- 16 REVERSE AUCTION. DALS is required to establish a pilot
- 17 project to determine the feasibility and cost-effectiveness
- 18 of conducting reverse auctions when allocating financial
- 19 assistance to persons seeking to establish practices to reduce
- 20 the transport of nutrients from nonpoint sources.
