      Section 1. Section 257.11, subsection 5, paragraph a,
 2 subparagraph (1), Code 2015, is amended to read as follows:
           In order to provide additional funding to increase

 4 student opportunities and redirect more resources to student
 5 programming for school districts that share operational
 6 functions, a district that shares with a political subdivision
 7 one or more operational functions of a curriculum director,
 8 principal, or school counselor, or one or more operational
 9 functions in the areas of superintendent management, business
10 management, human resources, transportation, or operation
11 and maintenance for at least twenty percent of the school
12 year shall be assigned a supplementary weighting for each
13 shared operational function. A school district that shares an
14 operational function in the area of superintendent management
15 shall be assigned a supplementary weighting of eight pupils for
16 the function. A school district that shares the operational
17 functions of a principal or an operational function in the area
18 of business management, human resources, transportation, or
19 operation and maintenance shall be assigned a supplementary
20 weighting of five pupils for the function. A school district
21 that shares the operational functions of a curriculum director
22 or a school counselor shall be assigned a supplementary
23 weighting of three pupils for the function.
                                                The additional
24 weighting shall be assigned for each discrete operational
25 function shared. However, a school district may receive the
26 additional weighting under this subsection for sharing the
27 services of an individual with a political subdivision even if
28 the type of operational function performed by the individual
29 for the school district and the type of operational function
30 performed by the individual for the political subdivision are
31 not the same operational function, so long as both operational
32 functions are eligible for weighting under this subsection.

- 6 Sec. 2. APPLICABILITY. This Act applies to school budget
- 7 years beginning on or after July 1, 2016.
- 8 EXPLANATION
- 9 The inclusion of this explanation does not constitute agreement with 10 the explanation's substance by the members of the general assembly.
- 11 Code section 257.11(5) provides supplementary weighting
- 12 for school districts and area education agencies that share
- 13 operational functions. A district that shares with a political
- 14 subdivision one or more operational functions of a curriculum
- 15 director or school counselor, or one or more operational
- 16 functions in the areas of superintendent management, business
- 17 management, human resources, transportation, or operation and
- 18 maintenance for at least 20 percent of the school year is
- 19 assigned a supplementary weighting for each shared operational
- 20 function. Supplementary weighting under this provision is
- 21 available for a maximum of five school budget years beginning
- 22 July 1, 2014, through the budget year beginning July 1, 2019.
- 23 This bill adds the position of principal to the category of
- 24 operational functions that receives supplementary weighting of
- 25 five pupils.
- 26 The bill applies to school budget years beginning on or after
- 27 July 1, 2016.
