A BILL FOR

1 An Act relating to a transfer of funding for a time certain
2 among the athletic programs at the institutions of higher
3 learning under the control of the state board of regents.
4 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

1 Section 1. NEW SECTION. 262.97 Athletic operating budgets
2 — revenue transfers.

3 Annually, on September 1 following the close of a fiscal
4 year, the state university of Iowa and Iowa state university
5 of science and technology athletic departments shall transfer
6 to the university of northern Iowa athletic department for the
7 following fiscal years the following amounts:

8 1. From the state university of Iowa as follows:

9 a. For the fiscal year beginning July 1, 2016, and ending
10 June 30, 2017, the sum of two million two hundred eighty
11 thousand dollars.

12 b. For the fiscal year beginning July 1, 2017, and ending
13 June 30, 2018, the sum of two million two hundred eighty
14 thousand dollars.

15 c. For the fiscal year beginning July 1, 2018, and ending
16 June 30, 2019, the sum of two million two hundred eighty
17 thousand dollars.

18 d. For the fiscal year beginning July 1, 2019, and ending
19 June 30, 2020, the sum of two million two hundred eighty
20 thousand dollars.

21 e. For the fiscal year beginning July 1, 2020, and ending
22 June 30, 2021, the sum of two million two hundred eighty
23 thousand dollars.

24 2. From Iowa state university of science and technology as
25 follows:

26 a. For the fiscal year beginning July 1, 2016, and ending
27 June 30, 2017, the sum of one million seven hundred twenty
28 thousand dollars.

29 b. For the fiscal year beginning July 1, 2017, and ending
30 June 30, 2018, the sum of one million seven hundred twenty
31 thousand dollars.

32 c. For the fiscal year beginning July 1, 2018, and ending
33 June 30, 2019, the sum of one million seven hundred twenty
34 thousand dollars.

35 d. For the fiscal year beginning July 1, 2019, and ending

1 June 30, 2020, the sum of one million seven hundred twenty
2 thousand dollars.

3 e. For the fiscal year beginning July 1, 2020, and ending
4 June 30, 2021, the sum of one million seven hundred twenty
5 thousand dollars.

EXPLANATION

7 The inclusion of this explanation does not constitute agreement with
8 the explanation's substance by the members of the general assembly.

9 This bill directs the state university of Iowa (UI) and Iowa
10 state university of science and technology (ISU) to transfer
11 from moneys from their university's athletic departments a
12 total of \$4 million for each of the next five years to the
13 university of northern Iowa (UNI) athletic department.

14 For each fiscal year of the fiscal period beginning July
15 1, 2016, and ending June 30, 2021, the UI athletic department
16 shall transfer \$2,280,000 to the UNI athletic department, and
17 the ISU athletic department shall transfer \$1,720,000 to the
18 UNI athletic department.
