**A BILL FOR**

DIVISION I  
DEPARTMENT OF AGRICULTURE AND LAND STEWARDSHIP  
GENERAL APPROPRIATION FOR FY 2015-2016

Section 1. GENERAL FUND — DEPARTMENT.

1. There is appropriated from the general fund of the state to the department of agriculture and land stewardship for the fiscal year beginning July 1, 2015, and ending June 30, 2016, the following amount, or so much thereof as is necessary, to be used for the purposes designated:

For purposes of supporting the department, including its divisions, for administration, regulation, and programs; for salaries, support, maintenance, and miscellaneous purposes; and for not more than the following full-time equivalent positions:  
..... \$ 17,655,492  
..... FTEs 372.00

2. Of the amount appropriated in subsection 1, the following amount is transferred to Iowa state university of science and technology, to be used for the university's midwest grape and wine industry institute:

..... \$ 288,000

3. The department shall submit a report each quarter of the fiscal year to the legislative services agency, the department of management, the members of the joint appropriations subcommittee on agriculture and natural resources, and the chairpersons and ranking members of the senate and house committees on appropriations. The report shall describe in detail the expenditure of moneys appropriated in this section to support the department's administration, regulation, and programs.

DESIGNATED APPROPRIATIONS  
MISCELLANEOUS FUNDS

Sec. 2. UNCLAIMED PARI-MUTUEL WAGERING WINNINGS — HORSE AND DOG RACING. There is appropriated from the moneys available under section 99D.13 to the department of agriculture and land stewardship for the fiscal year beginning July 1,

1 2015, and ending June 30, 2016, the following amount, or so  
2 much thereof as is necessary, to be used for the purposes  
3 designated:

4 For purposes of supporting the department's administration  
5 and enforcement of horse and dog racing law pursuant to section  
6 99D.22, including for salaries, support, maintenance, and  
7 miscellaneous purposes:

8 ..... \$ 305,516

9 Sec. 3. RENEWABLE FUEL INFRASTRUCTURE FUND — MOTOR FUEL  
10 INSPECTION.

11 1. There is appropriated from the renewable fuel  
12 infrastructure fund created in section 159A.16 to the  
13 department of agriculture and land stewardship for the fiscal  
14 year beginning July 1, 2015, and ending June 30, 2016, the  
15 following amount, or so much thereof as is necessary, to be  
16 used for the purposes designated:

17 For purposes of the inspection of motor fuel, including  
18 salaries, support, maintenance, and miscellaneous purposes:

19 ..... \$ 500,000

20 2. The department shall establish and administer programs  
21 for the auditing of motor fuel including biofuel processing  
22 and production plants, for screening and testing motor fuel,  
23 including renewable fuel, and for the inspection of motor fuel  
24 sold by dealers including retail dealers who sell and dispense  
25 motor fuel from motor fuel pumps.

26 SPECIAL APPROPRIATIONS

27 GENERAL FUND

28 Sec. 4. DAIRY REGULATION.

29 1. There is appropriated from the general fund of the state  
30 to the department of agriculture and land stewardship for the  
31 fiscal year beginning July 1, 2015, and ending June 30, 2016,  
32 the following amount, or so much thereof as is necessary, to be  
33 used for the purposes designated:

34 For purposes of performing functions pursuant to section  
35 192.109, including conducting a survey of grade "A" milk and

1 certifying the results to the secretary of agriculture:  
2 ..... \$ 189,196

3 2. Notwithstanding section 8.33, moneys appropriated in  
4 this section that remain unencumbered or unobligated at the  
5 close of the fiscal year shall not revert but shall remain  
6 available to be used for the purposes designated until the  
7 close of the succeeding fiscal year.

8 Sec. 5. LOCAL FOOD AND FARM PROGRAM.

9 1. There is appropriated from the general fund of the state  
10 to the department of agriculture and land stewardship for the  
11 fiscal year beginning July 1, 2015, and ending June 30, 2016,  
12 the following amount, or so much thereof as is necessary, to be  
13 used for the purposes designated:

14 For purposes of supporting the local food and farm program  
15 pursuant to chapter 267A:  
16 ..... \$ 75,000

17 2. The department shall enter into a cost-sharing agreement  
18 with Iowa state university of science and technology to support  
19 the local food and farm program coordinator position as part of  
20 the university's cooperative extension service in agriculture  
21 and home economics pursuant to chapter 267A.

22 3. Notwithstanding section 8.33, moneys appropriated in  
23 this section that remain unencumbered or unobligated at the  
24 close of the fiscal year shall not revert but shall remain  
25 available to be used for the purposes designated until the  
26 close of the succeeding fiscal year.

27 Sec. 6. AGRICULTURAL EDUCATION.

28 1. There is appropriated from the general fund of the state  
29 to the department of agriculture and land stewardship for the  
30 fiscal year beginning July 1, 2015, and ending June 30, 2016,  
31 the following amount, or so much thereof as is necessary, to be  
32 used for the purposes designated:

33 For purposes of allocating moneys to an Iowa association  
34 affiliated with a national organization which promotes  
35 agricultural education providing for future farmers:

1 ..... \$ 25,000

2 2. Notwithstanding section 8.33, moneys appropriated for  
3 the fiscal year beginning July 1, 2015, in this section that  
4 remain unencumbered or unobligated at the close of the fiscal  
5 year shall not revert but shall remain available to be used  
6 for the purposes designated until the close of the succeeding  
7 fiscal year.

8 Sec. 7. FARMERS WITH DISABILITIES PROGRAM.

9 1. There is appropriated from the general fund of the state  
10 to the department of agriculture and land stewardship for the  
11 fiscal year beginning July 1, 2015, and ending June 30, 2016,  
12 the following amount, or so much thereof as is necessary, to be  
13 used for the purposes designated:

14 For purposes of supporting a program for farmers with  
15 disabilities:

16 ..... \$ 130,000

17 2. The moneys appropriated in subsection 1 shall be used for  
18 the public purpose of providing a grant to a national nonprofit  
19 organization with over 80 years of experience in assisting  
20 children and adults with disabilities and special needs. The  
21 moneys shall be used to support a nationally recognized program  
22 that began in 1986 and has been replicated in at least 30 other  
23 states, but which is not available through any other entity  
24 in this state, and that provides assistance to farmers with  
25 disabilities in all 99 counties to allow the farmers to remain  
26 in their own homes and be gainfully engaged in farming through  
27 provision of agricultural worksite and home modification  
28 consultations, peer support services, services to families,  
29 information and referral, and equipment loan services.

30 3. Notwithstanding section 8.33, moneys appropriated in  
31 this section that remain unencumbered or unobligated at the  
32 close of the fiscal year shall not revert but shall remain  
33 available for expenditure for the purposes designated until the  
34 close of the succeeding fiscal year.

1 GENERAL FUND  
2 DEPARTMENT OF AGRICULTURE AND LAND STEWARDSHIP  
3 WATER QUALITY INITIATIVE  
4 APPROPRIATIONS FOR FY 2015-2016

5 Sec. 8. WATER QUALITY INITIATIVE — GENERAL.

6 1. There is appropriated from the general fund of the state  
7 to the department of agriculture and land stewardship for the  
8 fiscal year beginning July 1, 2015, and ending June 30, 2016,  
9 the following amount, or so much thereof as is necessary, to be  
10 used for the purposes designated:

11 For deposit in the water quality initiative fund created in  
12 section 466B.45, for purposes of supporting the water quality  
13 initiative administered by the soil conservation division as  
14 provided in section 466B.42, including salaries, support,  
15 maintenance, and miscellaneous purposes, and for not more than  
16 the following full-time equivalent positions:

17 .....	\$	4,400,000
18 .....	FTEs	2.00

19 2. a. The moneys appropriated in subsection 1 shall be  
20 used to support projects in subwatersheds as designated by the  
21 division that are part of high-priority watersheds identified  
22 by the water resources coordinating council established  
23 pursuant to section 466B.3.

24 b. The moneys appropriated in subsection 1 shall be used to  
25 support projects in watersheds generally, including regional  
26 watersheds, as designated by the division and high-priority  
27 watersheds identified by the water resources coordinating  
28 council established pursuant to section 466B.3.

29 3. In supporting projects in subwatersheds and watersheds  
30 as provided in subsection 2, all of the following shall apply:

31 a. The demonstration projects shall utilize water quality  
32 practices as described in the latest revision of the document  
33 entitled "Iowa Nutrient Reduction Strategy" initially presented  
34 in November 2012 by the department of agriculture and land  
35 stewardship, the department of natural resources, and Iowa

1 state university of science and technology.

2 b. The division shall implement demonstration projects as  
3 provided in paragraph "a" by providing for participation by  
4 persons who hold a legal interest in agricultural land used in  
5 farming. To every extent practical, the division shall provide  
6 for collaborative participation by such persons who hold a  
7 legal interest in agricultural land located within the same  
8 subwatershed.

9 c. The division shall implement a demonstration project on  
10 a cost-share basis as determined by the division. However, the  
11 state's share of the amount shall not exceed 50 percent of the  
12 estimated cost of establishing the practice as determined by  
13 the division or 50 percent of the actual cost of establishing  
14 the practice, whichever is less.

15 d. The demonstration projects shall be used to educate other  
16 persons about the feasibility and value of establishing similar  
17 water quality practices. The division shall promote field day  
18 events for purposes of allowing interested persons to establish  
19 water quality practices on their agricultural land.

20 e. The division shall conduct water quality evaluations  
21 within supported subwatersheds. Within a reasonable period  
22 after accumulating information from such evaluations, the  
23 division shall create an aggregated database of water quality  
24 practices. Any information identifying a person holding a  
25 legal interest in agricultural land or specific agricultural  
26 land shall be a confidential record under section 22.7.

27 4. The moneys appropriated in subsection 1 shall be used  
28 to support education and outreach in a manner that encourages  
29 persons who hold a legal interest in agricultural land used for  
30 farming to implement water quality practices, including the  
31 establishment of such practices in watersheds generally, and  
32 not limited to subwatersheds or high-priority watersheds.

33 5. The moneys appropriated in subsection 1 may be used  
34 to contract with persons to coordinate the implementation of  
35 efforts provided in this section.

1 6. The moneys appropriated in subsection 1 may be used by  
2 the department to support urban soil and water conservation  
3 efforts, which may include but are not limited to management  
4 practices related to bioretention, landscaping, the use of  
5 permeable or pervious pavement, and soil quality restoration.  
6 The moneys shall be allocated on a cost-share basis as provided  
7 in chapter 161A.

8 7. Notwithstanding any other provision of law to the  
9 contrary, the department may use moneys appropriated in  
10 subsection 1 to carry out the provisions of this section on a  
11 cost-share basis in combination with other moneys available to  
12 the department from a state or federal source.

13 8. Not more than 10 percent of the moneys appropriated in  
14 this section may be used to pay for the costs of administering  
15 and implementing the water quality initiative by the  
16 department's soil conservation division as provided in section  
17 466B.42 and this section.

18 DIVISION III

19 DEPARTMENT OF NATURAL RESOURCES

20 GENERAL APPROPRIATIONS FOR FY 2015-2016

21 Sec. 9. GENERAL FUND — DEPARTMENT.

22 1. There is appropriated from the general fund of the state  
23 to the department of natural resources for the fiscal year  
24 beginning July 1, 2015, and ending June 30, 2016, the following  
25 amount, or so much thereof as is necessary, to be used for the  
26 purposes designated:

27 For purposes of supporting the department, including its  
28 divisions, for administration, regulation, and programs; for  
29 salaries, support, maintenance, and miscellaneous purposes; and  
30 for not more than the following full-time equivalent positions:  
31 ..... \$ 12,862,307  
32 ..... FTEs 1,145.95

33 2. Of the number of full-time equivalent positions  
34 authorized to the department pursuant to subsection 1, 50.00  
35 full-time equivalent positions shall be allocated by the

1 department for seasonal employees for purposes of providing  
2 maintenance, upkeep, and sanitary services at state parks.  
3 This subsection shall not impact park ranger positions within  
4 the department.

5 3. The department shall submit a report each quarter of the  
6 fiscal year to the legislative services agency, the department  
7 of management, the members of the joint appropriations  
8 subcommittee on agriculture and natural resources, and the  
9 chairpersons and ranking members of the senate and house  
10 committees on appropriations. The report shall describe in  
11 detail the expenditure of moneys appropriated under this  
12 section to support the department's administration, regulation,  
13 and programs.

14 Sec. 10. STATE FISH AND GAME PROTECTION FUND — REGULATION  
15 AND ADVANCEMENT OF OUTDOOR ACTIVITIES.

16 1. There is appropriated from the state fish and game  
17 protection fund to the department of natural resources for the  
18 fiscal year beginning July 1, 2015, and ending June 30, 2016,  
19 the following amount, or so much thereof as is necessary, to be  
20 used for the purposes designated:

21 For purposes of supporting the regulation or advancement of  
22 hunting, fishing, or trapping, or the protection, propagation,  
23 restoration, management, or harvest of fish or wildlife,  
24 including for administration, regulation, law enforcement, and  
25 programs; and for salaries, support, maintenance, equipment,  
26 and miscellaneous purposes:

27 ..... \$ 41,223,225

28 2. Notwithstanding section 455A.10, the department may use  
29 the unappropriated balance remaining in the state fish and game  
30 protection fund to provide for the funding of health and life  
31 insurance premium payments from unused sick leave balances of  
32 conservation peace officers employed in a protection occupation  
33 who retire, pursuant to section 97B.49B.

34 3. Notwithstanding section 455A.10, the department of  
35 natural resources may use the unappropriated balance remaining



1 ending June 30, 2016, the following amount, or so much thereof  
2 as is necessary, to be used for the purpose designated:

3 For purposes of paying for administration expenses of the  
4 department's underground storage tanks section:

5 ..... \$ 200,000

6 SPECIAL APPROPRIATIONS

7 GENERAL FUND

8 Sec. 14. FLOODPLAIN MANAGEMENT AND DAM SAFETY.

9 1. There is appropriated from the general fund of the state  
10 to the department of natural resources for the fiscal year  
11 beginning July 1, 2015, and ending June 30, 2016, the following  
12 amount, or so much thereof as is necessary, to be used for the  
13 purpose designated:

14 For purposes of supporting floodplain management and dam  
15 safety:

16 ..... \$ 2,000,000

17 2. Of the amount appropriated in subsection 1, up to  
18 \$400,000 may be used by the department to acquire or install  
19 stream gages for purposes of tracking and predicting flood  
20 events and for compiling necessary data to improve flood  
21 frequency analysis.

22 3. Notwithstanding section 8.33, moneys appropriated in  
23 subsection 1 that remain unencumbered or unobligated at the  
24 close of the fiscal year shall not revert but shall remain  
25 available for expenditure for the purposes designated until the  
26 close of the succeeding fiscal year.

27 Sec. 15. FORESTRY HEALTH MANAGEMENT.

28 1. There is appropriated from the general fund of the state  
29 to the department of natural resources for the fiscal year  
30 beginning July 1, 2015, and ending June 30, 2016, the following  
31 amount, or so much thereof as is necessary, to be used for the  
32 purposes designated:

33 For purposes of providing for forestry health management  
34 programs:

35 ..... \$ 450,000

1 2. Notwithstanding section 8.33, moneys appropriated in  
2 this section that remain unencumbered or unobligated at the  
3 close of the fiscal year shall not revert but shall remain  
4 available to be used for the purposes designated until the  
5 close of the succeeding fiscal year.

6 DIVISION IV

7 IOWA STATE UNIVERSITY

8 SPECIAL GENERAL FUND AND GROUNDWATER PROTECTION FUND

9 APPROPRIATIONS FOR FY 2015-2016

10 VETERINARY DIAGNOSTIC LABORATORY

11 Sec. 16. VETERINARY DIAGNOSTIC LABORATORY.

12 1. There is appropriated from the general fund of the state  
13 to Iowa state university of science and technology for the  
14 fiscal year beginning July 1, 2015, and ending June 30, 2016,  
15 the following amount, or so much thereof as is necessary, to be  
16 used for the purposes designated:

17 For purposes of supporting the college of veterinary  
18 medicine for the operation of the veterinary diagnostic  
19 laboratory and for not more than the following full-time  
20 equivalent positions:

21 .....	\$	4,000,000
22 .....	FTEs	51.00

23 2. a. Iowa state university of science and technology  
24 shall not reduce the amount that it allocates to support the  
25 college of veterinary medicine from any other source due to the  
26 appropriation made in this section.

27 b. Paragraph "a" does not apply to a reduction made to  
28 support the college of veterinary medicine, if the same  
29 percentage of reduction imposed on the college of veterinary  
30 medicine is also imposed on all of Iowa state university of  
31 science and technology's budget units.

32 3. If by June 30, 2016, Iowa state university of science and  
33 technology fails to allocate the moneys appropriated in this  
34 section to the college of veterinary medicine in accordance  
35 with this section, the moneys appropriated in this section for

1 that fiscal year shall revert to the general fund of the state.

2 WATER QUALITY INITIATIVE

3 Sec. 17. IOWA NUTRIENT RESEARCH CENTER.

4 1. There is appropriated from the general fund of the state  
5 to Iowa state university of science and technology for the  
6 fiscal year beginning July 1, 2015, and ending June 30, 2016,  
7 the following amount, or so much thereof as is necessary, to be  
8 used for the purposes designated:

9 For purposes of supporting an Iowa nutrient research center  
10 as established in section 466B.47:

11 ..... \$ 1,325,000

12 2. Notwithstanding section 8.33, moneys appropriated in  
13 this section that remain unencumbered or unobligated at the  
14 close of the fiscal year shall not revert but shall remain  
15 available for expenditure for the purposes designated until the  
16 close of the succeeding fiscal year.

17 Sec. 18. DATA COLLECTION OF IN-FIELD AGRICULTURAL PRACTICES  
18 — THREE-YEAR PILOT PROJECT.

19 1. Notwithstanding section 455E.11, subsection 2,  
20 paragraph b, subparagraph (3), subparagraph division (b),  
21 of the unobligated and unencumbered moneys remaining in the  
22 agriculture management account of the groundwater protection  
23 fund that would otherwise be required to be transferred to  
24 the Iowa department of public health under that subparagraph  
25 division, there is appropriated to Iowa state university of  
26 science and technology for the fiscal year beginning July 1,  
27 2015, and ending June 30, 2016, the following amount, or so  
28 much thereof as is necessary, to be used for the purposes  
29 designated:

30 a. For use by the university's college of agriculture and  
31 life sciences for purposes of supporting a three-year data  
32 collection of in-field practices project:

33 ..... \$ 1,230,000

34 b. Notwithstanding section 8.33, moneys appropriated in  
35 paragraph "a" that remain unencumbered or unobligated at the

1 close of the fiscal year shall not revert but shall remain  
2 available for expenditure for the purposes designated until the  
3 close of the fiscal year beginning July 1, 2017.

4 2. The three-year project shall be used to do all of the  
5 following:

6 a. Enhance this state's ability to track its progress in  
7 reducing the transport of nutrients to water from nonpoint  
8 sources within watersheds in accordance with the latest  
9 revision of the document entitled "Iowa Nutrient Reduction  
10 Strategy" initially presented in November 2012 by the  
11 department of agriculture and land stewardship, the department  
12 of natural resources, and Iowa state university of science and  
13 technology.

14 b. Develop a database of in-field agricultural practices  
15 and analyze the impact of those practices in the aggregate.  
16 An agricultural practice includes but is not limited to soil  
17 and water conservation practices, structures, technologies,  
18 and agricultural inputs and outputs. The college may also  
19 provide for the measurement of other impacts associated with  
20 agricultural production. The finding of the pilot project  
21 shall be used to develop a system to be implemented within a  
22 broader range of watersheds that measures existing agricultural  
23 practices and the impact of different nutrient management  
24 decisions.

25 3. The college shall enter into a private-public  
26 partnership with one or more persons responsible for receiving,  
27 collecting, or holding data described in subsection 2. The  
28 college shall provide for the terms and conditions of any legal  
29 or financial arrangement that it enters into with such person.  
30 Any information received, collected, or held by the person  
31 shall be confidential in the same manner as provided in section  
32 466B.49, subsection 2. The college shall only enter into an  
33 arrangement with a person if the college is satisfied that the  
34 person will protect the confidentiality of the information.  
35 Any information including aggregate data transmitted to the

1 college by the person shall be available for public examination  
2 and copying under chapter 22, except for the same type of  
3 information described in section 466B.49, subsection 2, which  
4 shall remain confidential.

5 4. The college shall submit interim reports to the general  
6 assembly by March 1, 2016, and March 1, 2017, and a final  
7 report to the general assembly by March 1, 2018. The final  
8 report shall include its findings and recommendations.

9 DIVISION V

10 ENVIRONMENT FIRST FUND

11 GENERAL APPROPRIATIONS FOR FY 2015-2016

12 Sec. 19. DEPARTMENT OF AGRICULTURE AND LAND

13 STEWARDSHIP. There is appropriated from the environment first  
14 fund created in section 8.57A to the department of agriculture  
15 and land stewardship for the fiscal year beginning July 1,  
16 2015, and ending June 30, 2016, the following amounts, or so  
17 much thereof as is necessary, to be used for the purposes  
18 designated:

19 1. CONSERVATION RESERVE ENHANCEMENT PROGRAM (CREP)

20 a. For the conservation reserve enhancement program to  
21 restore and construct wetlands for the purposes of intercepting  
22 tile line runoff, reducing nutrient loss, improving water  
23 quality, and enhancing agricultural production practices:

24 ..... \$ 1,000,000

25 b. Not more than 10 percent of the moneys appropriated  
26 in paragraph "a" may be used for costs of administration and  
27 implementation of soil and water conservation practices.

28 c. Notwithstanding any other provision in law, the  
29 department may use moneys appropriated in this subsection,  
30 in combination with other appropriate environment first  
31 fund appropriations, for cost sharing to match United States  
32 department of agriculture, natural resources conservation  
33 service, wetlands reserve enhancement program (WREP) funding  
34 available to Iowa.

35 2. WATERSHED PROTECTION

1 a. For continuation of a program that provides  
2 multiobjective resource protections for flood control, water  
3 quality, erosion control, and natural resource conservation:  
4 ..... \$ 900,000

5 b. Not more than 10 percent of the moneys appropriated  
6 in paragraph "a" may be used for costs of administration and  
7 implementation of soil and water conservation practices.

8 3. FARM MANAGEMENT DEMONSTRATION PROGRAM

9 a. For continuation of a statewide voluntary farm  
10 management demonstration program to demonstrate the  
11 effectiveness and adaptability of emerging practices in  
12 agronomy that protect water resources and provide other  
13 environmental benefits:  
14 ..... \$ 625,000

15 b. Not more than 10 percent of the moneys appropriated  
16 in paragraph "a" may be used for costs of administration and  
17 implementation of soil and water conservation practices.

18 c. Of the amount appropriated in paragraph "a", \$400,000  
19 shall be allocated to an organization representing soybean  
20 growers to provide for an agriculture and environment  
21 performance program in order to carry out the purposes of this  
22 subsection as specified in paragraph "a".

23 4. SOIL AND WATER CONSERVATION — ADMINISTRATION

24 For use by the department for costs of administration and  
25 implementation of soil and water conservation practices:  
26 ..... \$ 2,550,000

27 5. CONSERVATION RESERVE PROGRAM (CRP)

28 a. To encourage and assist farmers in enrolling in and the  
29 implementation of the federal conservation reserve program and  
30 to work with them to enhance their revegetation efforts to  
31 improve water quality and habitat:  
32 ..... \$ 1,000,000

33 b. Not more than 10 percent of the moneys appropriated  
34 in paragraph "a" may be used for costs of administration and  
35 implementation of soil and water conservation practices.

1 6. SOIL AND WATER CONSERVATION

2 a. For use by the department in providing for soil and  
3 water conservation administration, the conservation of soil and  
4 water resources, or the support of soil and water conservation  
5 districts:

6 ..... \$ 6,750,000

7 b. Of the amount appropriated in paragraph "a" that the  
8 department allocates to a soil and water conservation district,  
9 the first \$15,000 may be expended by the district for the  
10 purpose of providing financial incentives under section 161A.73  
11 to establish management practices for the control of soil  
12 erosion on land that is row-cropped, including but not limited
