A BILL FOR

- 1 An Act relating to certain fees collected by the county
- 2 sheriff.
- 3 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

- Section 1. Section 331.655, subsection 1, paragraphs a, b, 2 c, e, f, g, h, k, 1, and n, Code 2015, are amended to read as 3 follows:
- 4 a. For serving a notice and returning it, for the first
- 5 person served, fifteen twenty-five dollars, and each additional
- 6 person, fifteen twenty-five dollars except the fee for serving
- 7 additional persons in the same household shall be ten fifteen
- 8 dollars for each additional service, or if the service of
- 9 notice cannot be made or several attempts are necessary, the
- 10 repayment of all necessary expenses actually incurred by the
- 11 sheriff while attempting in good faith to serve the notice.
- 12 b. For each warrant served, twenty-five dollars,
- 13 and the repayment of necessary expenses incurred in executing
- 14 the warrant, as sworn to by the sheriff, or if service of the
- 15 warrant cannot be made, the repayment of all necessary expenses
- 16 actually incurred by the sheriff while attempting in good faith
- 17 to serve the warrant.
- 18 c. For serving and returning a subpoena, for each person
- 19 served, twenty thirty dollars, and the necessary expenses
- 20 incurred while serving subpoenas in criminal cases or cases
- 21 relating to hospitalization of persons with mental illness.
- 22 e. For summoning a jury to assess the damages to the owners
- 23 of lands taken for works of internal improvement, one hundred
- 24 dollars, and attending them, one hundred dollars per day, and
- 25 necessary expenses incurred. This subsection does not allow
- 26 a sheriff to make separate charges for different assessments
- 27 which can be made by the same jury and completed in one day of
- 28 ten hours.
- 29 f. For serving an execution, attachment, order for the
- 30 delivery of personal property, injunction, or any order of
- 31 court, and returning it, fifteen twenty-five dollars.
- 32 g. For making and executing a certificate or deed for lands
- 33 sold on execution, or a bill of sale for personal property
- 34 sold, thirty forty dollars.
- 35 h. For the time necessarily employed in making an inventory

- 1 of personal property attached or levied upon, ten fifteen
 2 dollars per hour.
- 3 k. For attending setting a sale of property, fifty dollars.
- 4 1. For conveying one or more persons to a state, county, or
- 5 private institution by order of court or commission, necessary
- 6 expenses for the sheriff and the person conveyed and fifteen
- 7 twenty-five dollars per hour for the time necessarily employed
- 8 in going to and from the institution, the expenses and hourly
- 9 rate to be charged and accounted for as fees. If the sheriff
- 10 needs assistance in taking a person to an institution, the
- 11 assistance shall be furnished at the expense of the county.
- 12 n. For posting a notice or advertisement, five including
- 13 courtesy notices for writs of possession, ten dollars.
- 14 Sec. 2. Section 331.655, subsection 1, Code 2015, is amended
- 15 by adding the following new paragraph:
- 16 NEW PARAGRAPH. p. For serving a writ, twenty-five dollars
- 17 per hour, unless a lower fee for serving an order of the court
- 18 is specified in this subsection.
- 19 EXPLANATION
- The inclusion of this explanation does not constitute agreement with the explanation's substance by the members of the general assembly.
- 22 This bill relates to certain fees collected by the county 23 sheriff.
- 24 The bill raises fees for the serving and returning of
- 25 notice for each person from \$15 to \$25, and a fee for serving
- 26 additional persons in the same household is raised from \$10
- 27 to \$15. The bill raises the fee for warrants served from \$20
- 28 to \$25. The bill raises the fee for each person served a
- 29 subpoena from \$20 to \$30. The bill creates a separate fee for
- 30 summoning a jury (compensation commission) to assess damages
- 31 in a condemnation proceeding and sets the fee at \$100. Under
- 32 current law, the sheriff is also allowed to charge a fee of
- 33 \$100 per day for summoning and attending the jury (compensation
- 34 commission).
- 35 The bill raises the fee for serving an execution,

- 1 attachment, order for delivery of personal property,
- 2 injunction, or any other order of court from \$15 to \$25. The
- 3 bill also raises the fee for execution of a certificate or deed
- 4 for lands sold, or a bill of sale for personal property sold,
- 5 from \$30 to \$40. The bill raises the fee charged for the time
- 6 necessary to inventory personal property attached or levied
- 7 upon from \$10 to \$15 per hour. The bill provides that the
- 8 current \$50 fee regarding a sale of property is for setting,
- 9 rather than attending, the sale.
- 10 The bill raises the hourly fee charged for the conveyance
- 11 of certain persons by order of a court or commission to a
- 12 public or private institution from \$15 to \$25 per hour. This
- 13 hourly fee change also applies to fees charged for delivering
- 14 defendants under change of venue provisions or the transferring
- 15 of arrested persons pursuant to the provisions of Code section
- 16 815.8. The bill also raises the fee for posting a notice or
- 17 advertisement from \$5 to \$10, and specifies that this fee shall
- 18 also be collected for courtesy notices for writs of possession.
- 19 The bill creates a fee of \$25 per hour for serving a writ,
- 20 unless a lower fee for the sheriff's serving of an order of the
- 21 court is otherwise specified.
