

Senate Study Bill 3046 - Introduced

A BILL FOR

1 An Act relating to reading and literacy requirements for
2 practitioner preparation programs.
3 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

1 Section 1. Section 256.16, subsection 1, paragraph b, Code
2 2016, is amended to read as follows:

3 b. Include preparation in reading ~~programs, including~~
4 ~~reading recovery~~ theory, knowledge, strategies, and approaches;
5 and ~~integrate reading strategies for integrating literacy~~
6 instruction into content area ~~methods coursework~~ areas. Such
7 preparation shall address all students, including but not
8 limited to students with disabilities; students who are at
9 risk of academic failure; students who have been identified
10 as gifted and talented or limited English proficient; and
11 students with dyslexia, whether or not such students have
12 been identified as children requiring special education under
13 chapter 256B.

14 Sec. 2. Section 272.25, unnumbered paragraph 1, Code 2016,
15 is amended to read as follows:

16 ~~Not later than January 1, 1991, the~~ The state board of
17 education shall adopt rules ~~pursuant to~~ chapter 17A to
18 implement the following for approved practitioner preparation
19 programs:

20 Sec. 3. Section 272.25, subsection 3, Code 2016, is amended
21 to read as follows:

22 3. A requirement that the program include instruction
23 in skills and strategies to be used in classroom management
24 of individuals, and of small and large groups, under varying
25 conditions; skills for communicating and working constructively
26 with pupils, teachers, administrators, and parents; preparation
27 in reading theory, knowledge, strategies, and approaches,
28 and for integrating literacy instruction in content areas in
29 accordance with section 256.16; and skills for understanding
30 the role of the board of education and the functions of other
31 education agencies in the state. The requirement shall be
32 based upon recommendations of the department of education after
33 consultation with teacher education faculty members in colleges
34 and universities.

EXPLANATION

1 The inclusion of this explanation does not constitute agreement with
2 the explanation's substance by the members of the general assembly.

3 This bill modifies the reading and literacy requirements for
4 practitioner preparation programs approved by the state board
5 of education.

6 The bill replaces language relating to reading programs,
7 including reading recovery, with language requiring preparation
8 in reading theory, knowledge, strategies, and approaches;
9 and for integrating literacy instruction into content areas.
10 Such preparation must address all students, including but not
11 limited to students with disabilities, students at risk of
12 academic failure, gifted and talented students, limited English
13 proficient students, and students with dyslexia. The bill
14 provides for corresponding changes.
