A BILL FOR

- 1 An Act relating to high school equivalency programs and
- 2 assessments and including effective date provisions.
- 3 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

- 1 Section 1. Section 259A.1, Code 2017, is amended to read as 2 follows:
- 3 259A.1 Tests Assessment of competency.
- 4 The department of education shall cause to be made available
- 5 for qualified individuals a high school equivalency diploma.
- 6 The diploma shall be issued on the basis of satisfactory
- 7 demonstrated competence as shown by tests covering in all of
- 8 the following core areas: reading, language arts, literacy,
- 9 mathematics, science, and social studies.
- 10 Sec. 2. Section 259A.2, Code 2017, is amended to read as
- 11 follows:
- 12 259A.2 Age Application requirements.
- 13 l. Every applicant must shall have attained the age of
- 14 eighteen years, be a nonhigh have not graduated from high
- 15 school graduate, and not be currently enrolled in a secondary
- 16 school. However, an
- 2. An applicant is not eligible for the a high school
- 18 equivalency diploma until after the class in which the
- 19 applicant was enrolled has graduated from high school.
- 20 3. Application shall be made to a high school equivalency
- 21 program or testing center approved by the department of
- 22 education, accompanied by an application fee in an amount
- 23 prescribed by the department.
- 24 4. The test Test scores shall be forwarded by the scorer of
- 25 the test to the department of education.
- 26 5. Evidence that an applicant demonstrates competence as
- 27 required under section 259A.1 shall be made available to the
- 28 department of education by the high school equivalency program
- 29 for verification purposes.
- 30 Sec. 3. Section 259A.3, Code 2017, is amended to read as
- 31 follows:
- 32 259A.3 Notice and fee.
- 33 Any applicant who has achieved demonstrated competence in
- 34 the minimum passing core areas under standards as established
- 35 by the department, and approved adopted by the state board of

- 1 education pursuant to section 259A.5, shall be issued a high
- 2 school equivalency diploma by the department of education upon
- 3 payment of an additional amount determined in rules adopted by
- 4 the state board of education to cover the actual costs of the
- 5 production and distribution of the diploma. The state board of
- 6 education may also by rule establish a fee for the issuance or
- 7 verification of a transcript which shall be based on the actual
- 8 costs of the production or verification of a transcript.
- 9 Sec. 4. Section 259A.5, Code 2017, is amended to read as
- 10 follows:
- 11 **259A.5** Rules duties.
- 12 l. The director of the department of education shall adopt
- 13 tests prescribe assessments, definitions of terms, and forms
- 14 and resources as necessary for the administration of this
- 15 chapter.
- 16 2. The state board of education shall adopt rules
- 17 under chapter 17A to carry out this chapter, including but
- 18 not limited to rules establishing standards for content
- 19 and measures by which competence in core areas is to be
- 20 demonstrated and assessed. Such measures shall include but
- 21 not be limited to a test battery, credit-based measures, and
- 22 attainment of other academic credentials of equivalent or
- 23 greater rigor.
- 24 Sec. 5. EFFECTIVE UPON ENACTMENT. This Act, being deemed of
- 25 immediate importance, takes effect upon enactment.
- 26 EXPLANATION
- 27 The inclusion of this explanation does not constitute agreement with
- the explanation's substance by the members of the general assembly.
- 29 This bill modifies Code chapter 259A, which provides for
- 30 high school equivalency programs and assessments, and for the
- 31 issuance of high school equivalency diplomas by the department
- 32 of education.
- Under the bill, issuance of a high school equivalency
- 34 diploma is to be based on an applicant's demonstrated
- 35 competence in core areas. Currently, the diploma is issued

- 1 based on satisfactory competence, which an applicant meets
- 2 by achieving the minimum passing standards in the same areas
- 3 that under the bill are described as "core areas": reading,
- 4 language arts, literacy, mathematics, science, and social
- 5 studies.
- 6 Currently, an applicant must submit an application to a
- 7 testing center, but, under the bill, application may be made
- 8 either to a high school equivalency program or to a testing
- 9 center. The bill directs high school equivalency programs to
- 10 make available to the department evidence of an applicant's
- 11 demonstrated competence.
- 12 The bill requires the director of the department of
- 13 education to prescribe assessments and resources, and strikes
- 14 a requirement that the director adopt tests. Currently, the
- 15 state board of education has the authority to adopt rules to
- 16 carry out the Code chapter. The bill maintains this broad
- 17 authority, while specifying that the rules must include but
- 18 not be limited to rules establishing standards for content
- 19 and measures by which competence in core areas is to be
- 20 demonstrated and assessed. Such measures shall include but
- 21 not be limited to a test battery, credit-based measures, and
- 22 attainment of other academic credentials of equivalent or
- 23 greater rigor.
