## A BILL FOR

- 1 An Act relating to continuous quality improvement for the care
- 2 of individuals with stroke.
- 3 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

H.F. 548

- 1 Section 1. <u>NEW SECTION</u>. 135.191 Stroke care continuous 2 quality improvement.
- 3 1. The department and the university of Iowa college of 4 public health, department of epidemiology, shall coordinate 5 efforts to achieve continuous quality improvement in the care 6 provided for persons with stroke as follows:
- 7 a. Maintain a statewide stroke database that compiles 8 information and statistics on stroke care which align with 9 nationally recognized stroke consensus metrics.
- 10 b. Utilize a nationally recognized data set platform with 11 confidentiality standards consistent with federal and state law 12 and other health information and data collection, storage, and 13 sharing requirements of the department.
- 14 c. Coordinate with national voluntary health organizations 15 involved in stroke care quality improvement to avoid 16 duplication and redundancy.
- 17 d. Require nationally certified comprehensive stroke
  18 centers and nationally certified primary stroke centers, and
  19 encourage nationally certified acute stroke-ready hospitals and
  20 emergency medical services agencies, to report data consistent
  21 with nationally recognized guidelines on the treatment of
  22 individuals with confirmed cases of stroke within the state.
- 2. All data and information collected under this section 24 shall be made available to the Iowa stroke task force to 25 facilitate a collaborative, inclusive statewide stroke care 26 system and to identify evidence-based practices to guide 27 prevention, acute care, recovery, and rehabilitation efforts 28 in order to produce measurable improvements in outcomes for 29 persons with stroke.

## 30 EXPLANATION

- 33 This bill requires the department of public health (DPH) and 34 the university of Iowa college of public health, department 35 of epidemiology, to coordinate efforts to achieve continuous
