- 1 An Act relating to career and technical education programs and
- 2 partnerships and including effective date provisions.
- 3 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

- 1 Section 1. Section 85.20, subsection 3, Code 2017, is 2 amended to read as follows:
- 3. For a student participating in a work-based learning
- 4 opportunity as provided in section 85.61, against the student's
- 5 school district of residence, receiving school district if
- 6 the student is participating in open enrollment under section
- 7 282.18, accredited nonpublic school, or community college, and
- 8 the directors, officers, authorities, and employees of the
- 9 applicable school district corporation or school.
- 10 Sec. 2. Section 258.5, Code 2017, is amended to read as 11 follows:
- 12 258.5 Reimbursement from federal and state moneys.
- 13 1. At the end of the fiscal year, an An approved regional
- 14 career and technical education planning partnership is eligible
- 15 to receive, from federal and state funds, reimbursement for
- 16 expenditures made during the fiscal year for purposes allowed
- 17 under section 258.14, subsection 6. If federal and state
- 18 funds are not sufficient to make the reimbursement to the
- 19 extent provided in this section, the director shall prorate
- 20 the respective amounts available to the regional career
- 21 and technical education planning partnerships entitled to
- 22 reimbursement.
- 23 2. Federal funds received as a reimbursement for allowable
- 24 expenditures shall be received pursuant to the multiyear state
- 25 plan adopted pursuant to section 258.3A, subsection 1.
- 26 $\frac{2}{1}$ 3. The director may use federal funds to reimburse
- 27 approved practitioner preparation schools, departments, or
- 28 classes for the training of teachers of agriculture, food,
- 29 and natural resources; arts, communications, and information
- 30 systems; applied sciences, technology, engineering, and
- 31 manufacturing; health sciences; human services; and business,
- 32 finance, marketing, and management. The director may also
- 33 use such funds to reimburse approved practitioner preparation
- 34 schools, departments, or classes for the training of guidance
- 35 counselors.

- 1 Sec. 3. Section 258.14, subsection 6, Code 2017, is amended 2 to read as follows:
- A regional career and technical education partnership
- 4 may use funds received from state and federal sources on behalf
- 5 of school districts and community colleges participating in the
- 6 regional career and technical education planning partnership
- 7 to convene, lead, and staff the regional career and technical
- 8 education planning partnership,; to offer regional career and
- 9 technical education professional development opportunities; to
- 10 coordinate and maintain a career guidance system pursuant to
- 11 section 279.61, and to purchase career and technical education
- 12 equipment on behalf of school districts and community colleges
- 13 participating in the regional career and technical education
- 14 planning partnership; and to purchase standard classroom
- 15 consumable supplies other than consumable supplies that will be
- 16 made into products to be sold or used personally by students,
- 17 teachers, and other persons.
- 18 Sec. 4. EFFECTIVE UPON ENACTMENT. This Act, being deemed of
- 19 immediate importance, takes effect upon enactment.
- 20 EXPLANATION
- 21 The inclusion of this explanation does not constitute agreement with
- the explanation's substance by the members of the general assembly.
- 23 This bill relates to career and technical education
- 24 opportunities and partnerships.
- 25 The bill restores a reference to school corporations
- 26 mistakenly changed under 2016 Iowa Acts, chapter 1108, and
- 27 includes a reference to an accredited nonpublic school,
- 28 relating to student participation in work-based learning
- 29 opportunities.
- 30 The bill authorizes an approved regional career and
- 31 technical education planning partnership to receive state funds
- 32 for purposes allowed under Code section 258.14(6). The bill
- 33 amends Code section 258.14(6) to authorize a partnership to
- 34 purchase career and technical education equipment and standard
- 35 classroom consumable supplies other than consumable supplies
