A BILL FOR

1 An Act making appropriations to the department of cultural
2 affairs, the economic development authority, the Iowa
3 finance authority, the public employment relations board,
4 the department of workforce development, and the state board
5 of regents and certain regents institutions, and properly
6 related matters.

7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

DIVISION I
FY 2017-2018

Section 1. DEPARTMENT OF CULTURAL AFFAIRS.

1. There is appropriated from the general fund of the state to the department of cultural affairs for the fiscal year beginning July 1, 2017, and ending June 30, 2018, the following amounts, or so much thereof as is necessary, to be used for the purposes designated:

a. ADMINISTRATION

For salaries, support, maintenance, and miscellaneous purposes, and for not more than the following full-time equivalent positions for the department:

The department of cultural affairs shall coordinate activities with the tourism office of the economic development authority to promote attendance at the state historical building and at this state's historic sites.

Full-time equivalent positions authorized under this paragraph are funded, in full or in part, using moneys appropriated under this paragraph and paragraphs "c" through "g".

b. COMMUNITY CULTURAL GRANTS

For planning and programming for the community cultural grants program established under [section 303.3](#):

2 shall allocate \$300,000 for purposes of the film office.

8 For payment of rent for the state records center:

10 h. CULTURAL TRUST GRANTS

11 For grant programs administered by the Iowa arts council
12 including but not limited to those programs supporting the
13 long-term financial stability and sustainability of nonprofit
14 cultural organizations:

16 2. Notwithstanding section 8.33, moneys appropriated in
17 this section that remain unencumbered or unobligated at the
18 close of the fiscal year shall not revert but shall remain
19 available for expenditure for the purposes designated until the
20 close of the succeeding fiscal year.

21 Sec. 2. GOALS AND ACCOUNTABILITY — ECONOMIC DEVELOPMENT.

22 1. For the fiscal year beginning July 1, 2017, the goals
23 for the economic development authority shall be to expand and
24 stimulate the state economy, increase the wealth of Iowans, and
25 increase the population of the state.

26 2. To achieve the goals in subsection 1, the economic
27 development authority shall do all of the following for the
28 fiscal year beginning July 1, 2017:

29 a. Concentrate its efforts on programs and activities that
30 result in commercially viable products and services.

31 b. Adopt practices and services consistent with free
32 market, private sector philosophies.

33 c. Ensure economic growth and development throughout the
34 state.

35 d. Work with businesses and communities to continually

1 improve the economic development climate along with the
2 economic well-being and quality of life for Iowans.

3 e. Coordinate with other state agencies to ensure that they
4 are attentive to the needs of an entrepreneurial culture.

5 f. Establish a strong and aggressive marketing image to
6 showcase Iowa's workforce, existing industry, and potential.
7 A priority shall be placed on recruiting new businesses,
8 business expansion, and retaining existing Iowa businesses.
9 Emphasis shall be placed on entrepreneurial development through
10 helping entrepreneurs secure capital, and developing networks
11 and a business climate conducive to entrepreneurs and small
12 businesses.

13 g. Encourage the development of communities and quality of
14 life to foster economic growth.

15 h. Prepare communities for future growth and development
16 through development, expansion, and modernization of
17 infrastructure.

18 i. Develop public-private partnerships with Iowa businesses
19 in the tourism industry, Iowa tour groups, Iowa tourism
20 organizations, and political subdivisions in this state to
21 assist in the development of advertising efforts.

22 j. Develop, to the fullest extent possible, cooperative
23 efforts for advertising with contributions from other sources.

24 Sec. 3. ECONOMIC DEVELOPMENT AUTHORITY.

25 1. APPROPRIATION

26 a. There is appropriated from the general fund of the state
27 to the economic development authority for the fiscal year
28 beginning July 1, 2017, and ending June 30, 2018, the following
29 amount, or so much thereof as is necessary, to be used for the
30 purposes designated in this subsection, and for not more than
31 the following full-time equivalent positions:

32	\$ 13,400,000
33	FTEs 147.45

34 b. (1) For salaries, support, miscellaneous purposes,
35 programs, marketing, and the maintenance of an administration

1 division, a business development division, a community
2 development division, a small business development division,
3 and other divisions the authority may organize.

4 (2) The full-time equivalent positions authorized under
5 this section are funded, in whole or in part, by the moneys
6 appropriated under this subsection or by other moneys received
7 by the authority, including certain federal moneys.

8 (3) For business development operations and programs,
9 international trade, export assistance, workforce recruitment,
10 and the partner state program.

11 (4) For transfer to a fund created pursuant to section
12 15.313 for purposes of financing strategic infrastructure
13 projects.

14 (5) For community economic development programs, tourism
15 operations, community assistance, plans for Iowa green corps
16 and summer youth programs, the mainstreet and rural mainstreet
17 programs, the school-to-career program, the community
18 development block grant, and housing and shelter-related
19 programs.

20 (6) For achieving the goals and accountability, and
21 fulfilling the requirements and duties required under this Act.

22 c. Notwithstanding section 8.33, moneys appropriated in
23 this subsection that remain unencumbered or unobligated at the
24 close of the fiscal year shall not revert but shall remain
25 available for expenditure for the purposes designated in this
26 subsection until the close of the succeeding fiscal year.

27 2. FINANCIAL ASSISTANCE RESTRICTIONS

28 a. A business creating jobs through moneys appropriated in
29 subsection 1 shall be subject to contract provisions requiring
30 new and retained jobs to be filled by individuals who are
31 citizens of the United States who reside within the United
32 States or any person authorized to work in the United States
33 pursuant to federal law, including legal resident aliens in the
34 United States.

35 b. Any vendor who receives moneys appropriated in

1 subsection 1 shall adhere to such contract provisions and
2 provide periodic assurances as the state shall require that the
3 jobs are filled solely by citizens of the United States who
4 reside within the United States or any person authorized to
5 work in the United States pursuant to federal law, including
6 legal resident aliens in the United States.

7 c. A business that receives financial assistance from
8 the authority from moneys appropriated in subsection 1 shall
9 only employ individuals legally authorized to work in this
10 state. In addition to all other applicable penalties provided
11 by current law, all or a portion of the assistance received
12 by a business which is found to knowingly employ individuals
13 not legally authorized to work in this state is subject to
14 recapture by the authority.

15 3. USES OF APPROPRIATIONS

16 a. From the moneys appropriated in subsection 1, the
17 authority may provide financial assistance in the form of a
18 grant to a community economic development entity for conducting
19 a local workforce recruitment effort designed to recruit former
20 citizens of the state and former students at colleges and
21 universities in the state to meet the needs of local employers.

22 b. From the moneys appropriated in subsection 1, the
23 authority may provide financial assistance to early stage
24 industry companies being established by women entrepreneurs.

25 c. From the moneys appropriated in subsection 1, the
26 authority may provide financial assistance in the form of
27 grants, loans, or forgivable loans for advanced research and
28 commercialization projects involving value-added agriculture,
29 advanced technology, or biotechnology.

30 d. The authority shall not use any moneys appropriated in
31 subsection 1 for purposes of providing financial assistance for
32 the Iowa green streets pilot project or for any other program
33 or project that involves the installation of geothermal systems
34 for melting snow and ice from streets or sidewalks.

35 4. WORLD FOOD PRIZE

1 There is appropriated from the general fund of the state
2 to the economic development authority for the fiscal year
3 beginning July 1, 2017, and ending June 30, 2018, the following
4 amount for the world food prize and in lieu of the standing
5 appropriation in [section 15.368](#):

6 \$ 400,000

7 5. IOWA COMMISSION ON VOLUNTEER SERVICE

8 There is appropriated from the general fund of the state
9 to the economic development authority for the fiscal year
10 beginning July 1, 2017, and ending June 30, 2018, the following
11 amount for allocation to the Iowa commission on volunteer
12 service for purposes of the Iowa state commission grant
13 program, the Iowa's promise and Iowa mentoring partnership
14 programs, and for not more than the following full-time
15 equivalent positions:

16 \$ 168,201

17 FTEs 7.00

18 Of the moneys appropriated in this subsection, the
19 authority shall allocate \$75,000 for purposes of the Iowa state
20 commission grant program and \$93,201 for purposes of the Iowa's
21 promise and Iowa mentoring partnership programs.

22 Notwithstanding [section 8.33](#), moneys appropriated in this
23 subsection that remain unencumbered or unobligated at the close
24 of the fiscal year shall not revert but shall remain available
25 for expenditure for the purposes designated until the close of
26 the succeeding fiscal year.

27 6. COUNCILS OF GOVERNMENTS — ASSISTANCE

28 There is appropriated from the general fund of the state
29 to the economic development authority for the fiscal year
30 beginning July 1, 2017, and ending June 30, 2018, the following
31 amount to be used for the purposes of providing financial
32 assistance to Iowa's councils of governments:

33 \$ 175,000

34 7. SCIENCE, TECHNOLOGY, ENGINEERING, AND MATHEMATICS
35 INTERNSHIPS

1 a. There is appropriated from the Iowa skilled worker and
2 job creation fund created in section 8.75 to the Iowa economic
3 development authority for the fiscal year beginning July 1,
4 2017, and ending June 30, 2018, the following amount, or so
5 much thereof as is necessary, for the purposes designated:

6 For the funding of internships for students studying in the
7 fields of science, technology, engineering, and mathematics
8 with eligible Iowa employers as provided in section 15.411,
9 subsection 3, paragraph "c":

10 \$ 1,000,000

11 b. No more than 3 percent of the moneys appropriated in this
12 subsection may be used by the authority for costs associated
13 with administration of the internship program.

14 c. Notwithstanding section 8.33, moneys appropriated in
15 this subsection which remain unencumbered or unobligated at
16 the end of the fiscal year shall not revert but shall remain
17 available for expenditure for the purposes designated in
18 subsequent fiscal years.

19 Sec. 4. LIMITATIONS OF STANDING APPROPRIATIONS — FY
20 2017-2018. Notwithstanding the standing appropriations
21 in the following designated sections for the fiscal year
22 beginning July 1, 2017, and ending June 30, 2018, the amounts
23 appropriated from the general fund of the state pursuant to
24 these sections for the following purposes shall not exceed the
25 following amounts:

26 1. For operational support grants and community cultural
27 grants under section 99F.11, subsection 3, paragraph "d",
28 subparagraph (1):

29 \$ 416,702

30 2. For the purposes of regional tourism marketing under
31 section 99F.11, subsection 3, paragraph "d", subparagraph (2):

32 \$ 900,000

33 Sec. 5. INSURANCE ECONOMIC DEVELOPMENT. From the moneys
34 collected by the division of insurance in excess of the
35 anticipated gross revenues under section 505.7, subsection

1 3, during the fiscal year beginning July 1, 2017, \$100,000
2 shall be transferred to the economic development authority for
3 insurance economic development and international insurance
4 economic development.

5 Sec. 6. IOWA FINANCE AUTHORITY.

6 1. There is appropriated from the general fund of the state
7 to the Iowa finance authority for the fiscal year beginning
8 July 1, 2017, and ending June 30, 2018, the following amount,
9 or so much thereof as is necessary, to be used to provide
10 reimbursement for rent expenses to eligible persons under the
11 rent subsidy program:

12 \$ 658,000

13 2. Participation in the rent subsidy program shall be
14 limited to only those persons who meet the requirements for the
15 nursing facility level of care for home and community-based
16 services waiver services as in effect on July 1, 2017,
17 and to those individuals who are eligible for the federal
18 money follows the person grant program under the medical
19 assistance program. If the Iowa finance authority utilizes
20 a waiting list, the authority shall give priority to a
21 person participating in the state's money follows the person
22 partnership for community integration project who has been
23 assigned to work with a transition specialist. Of the moneys
24 appropriated in this section, not more than \$35,000 may be used
25 for administrative costs.

26 Sec. 7. IOWA FINANCE AUTHORITY AUDIT. The auditor of state
27 is requested to review the audit of the Iowa finance authority
28 performed by the auditor hired by the authority.

29 Sec. 8. PUBLIC EMPLOYMENT RELATIONS BOARD.

30 1. There is appropriated from the general fund of the state
31 to the public employment relations board for the fiscal year
32 beginning July 1, 2017, and ending June 30, 2018, the following
33 amount, or so much thereof as is necessary, for the purposes
34 designated:

35 For salaries, support, maintenance, and miscellaneous

1 purposes, and for not more than the following full-time
2 equivalent positions:

3	\$	1,342,452
4	FTEs	10.00

5 2. Of the moneys appropriated in this section, the board
6 shall allocate \$15,000 for maintaining an internet site that
7 allows searchable access to a database of collective bargaining
8 information.

9 Sec. 9. DEPARTMENT OF WORKFORCE DEVELOPMENT. There
10 is appropriated from the general fund of the state to the
11 department of workforce development for the fiscal year
12 beginning July 1, 2017, and ending June 30, 2018, the following
13 amounts, or so much thereof as is necessary, for the purposes
14 designated:

15 1. DIVISION OF LABOR SERVICES

16 a. For the division of labor services, including salaries,
17 support, maintenance, and miscellaneous purposes, and for not
18 more than the following full-time equivalent positions:

19	\$	3,491,252
20	FTEs	61.12

21 b. From the contractor registration fees, the division of
22 labor services shall reimburse the department of inspections
23 and appeals for all costs associated with hearings under
24 chapter 91C, relating to contractor registration.

25 2. DIVISION OF WORKERS' COMPENSATION

26 a. For the division of workers' compensation, including
27 salaries, support, maintenance, and miscellaneous purposes, and
28 for not more than the following full-time equivalent positions:

29	\$	3,259,044
30	FTEs	27.20

31 b. The division of workers' compensation shall charge a
32 \$100 filing fee for workers' compensation cases. The filing
33 fee shall be paid by the petitioner of a claim. However, the
34 fee can be taxed as a cost and paid by the losing party, except
35 in cases where it would impose an undue hardship or be unjust

1 under the circumstances. The moneys generated by the filing
2 fee allowed under this subsection are appropriated to the
3 department of workforce development to be used for purposes of
4 administering the division of workers' compensation.

5 3. WORKFORCE DEVELOPMENT OPERATIONS

6 a. For the operation of field offices, the workforce
7 development board, and for not more than the following
8 full-time equivalent positions:

9	\$	7,945,650
10	FTEs	187.75

11 b. Of the moneys appropriated in paragraph "a" of this
12 subsection, the department shall allocate \$150,000 to the state
13 library for the purpose of licensing an online resource which
14 prepares persons to succeed in the workplace through programs
15 which improve job skills and vocational test-taking abilities.

16 4. OFFENDER REENTRY PROGRAM

17 a. For the development and administration of an offender
18 reentry program to provide offenders with employment skills,
19 and for not more than the following full-time equivalent
20 positions:

21	\$	287,158
22	FTEs	4.00

23 b. The department of workforce development shall partner
24 with the department of corrections to provide staff within the
25 correctional facilities to improve offenders' abilities to find
26 and retain productive employment.

27 5. INTEGRATED INFORMATION FOR IOWA SYSTEM

28 For the payment of services provided by the department of
29 administrative services related to the integrated information
30 for Iowa system:

31	\$	228,822

32 6. NONREVERSION

33 Notwithstanding [section 8.33](#), moneys appropriated in this
34 section that remain unencumbered or unobligated at the close of
35 the fiscal year shall not revert but shall remain available for

1 expenditure for the purposes designated until the close of the
2 succeeding fiscal year.

3 Sec. 10. GENERAL FUND — EMPLOYEE MISCLASSIFICATION
4 PROGRAM. There is appropriated from the general fund of the
5 state to the department of workforce development for the fiscal
6 year beginning July 1, 2017, and ending June 30, 2018, the
7 following amount, or so much thereof as is necessary, to be
8 used for the purposes designated:

9 For enhancing efforts to investigate employers that
10 misclassify workers and for not more than the following
11 full-time equivalent positions:

12	\$	429,631
13	FTEs	5.00

14 Sec. 11. SPECIAL EMPLOYMENT SECURITY CONTINGENCY FUND.

15 1. There is appropriated from the special employment
16 security contingency fund to the department of workforce
17 development for the fiscal year beginning July 1, 2017, and
18 ending June 30, 2018, the following amount, or so much thereof
19 as is necessary, to be used for field offices:

20	\$	1,766,084

21 2. Any remaining additional penalty and interest revenue
22 collected by the department of workforce development is
23 appropriated to the department for the fiscal year beginning
24 July 1, 2017, and ending June 30, 2018, to accomplish the
25 mission of the department.

26 Sec. 12. UNEMPLOYMENT COMPENSATION RESERVE FUND —
27 FIELD OFFICES. Notwithstanding [section 96.9, subsection 8](#),
28 paragraph "e", there is appropriated from interest earned on
29 the unemployment compensation reserve fund to the department
30 of workforce development for the fiscal year beginning July 1,
31 2017, and ending June 30, 2018, the following amount, or so
32 much thereof as is necessary, for the purposes designated:

35 Sec. 13. VIRTUAL ACCESS WORKFORCE DEVELOPMENT OFFICES. The

1 department of workforce development shall require a unique
2 identification login for all users of workforce development
3 centers operated through electronic means.

4 Sec. 14. UNEMPLOYMENT COMPENSATION PROGRAM. Notwithstanding
5 section 96.9, subsection 4, paragraph "a", moneys credited to
6 the state by the secretary of the treasury of the United
7 States pursuant to section 903 of the Social Security
8 Act are appropriated to the department of workforce
9 development and shall be used by the department for the
10 administration of the unemployment compensation program only.
11 This appropriation shall not apply to any fiscal year
12 beginning after December 31, 2017.

13 Sec. 15. UNEMPLOYMENT INSURANCE SYSTEMS MODERNIZATION
14 — USE OF FUNDS AUTHORIZATION. Incentive payment moneys
15 transferred by the secretary of labor of the United States to
16 the state as a special transfer pursuant to section 2003 of
17 the Assistance for Unemployed Workers and Struggling Families
18 Act, enacted pursuant to Pub. L. No. 111-5, and credited to
19 the unemployment compensation fund established pursuant to
20 section 96.9, are appropriated to the department of workforce
21 development for the fiscal year beginning July 1, 2017, for the
22 purpose of unemployment insurance systems modernization and
23 for the acquisition of programming, software, and equipment
24 required to provide an administrative system for the Iowa
25 unemployment insurance program, in an amount not to exceed the
26 following amount:

28 Sec. 16. UNEMPLOYMENT COMPENSATION AND EMPLOYMENT SERVICES
29 PROGRAMS — USE OF FUNDS AUTHORIZATION. Incentive payment
30 moneys transferred by the secretary of labor of the United
31 States to the state as a special transfer pursuant to section
32 2003 of the Assistance for Unemployed Workers and Struggling
33 Families Act, enacted pursuant to Pub. L. No. 111-5, and
34 credited to the unemployment compensation fund established
35 pursuant to section 96.9, are appropriated to the department

1 of workforce development for the fiscal year beginning July 1,
2 2017, for the administration of the Iowa employment security
3 law and public employment offices, in an amount not to exceed
4 the following amount:

5 \$ 597,000

6 Sec. 17. IOWA SKILLED WORKER AND JOB CREATION FUND.

7 1. There is appropriated from the Iowa skilled worker and
8 job creation fund created in section 8.75 to the following
9 departments, agencies, and institutions for the fiscal year
10 beginning July 1, 2017, and ending June 30, 2018, the following
11 amounts, or so much thereof as is necessary, to be used for the
12 purposes designated:

13 a. ECONOMIC DEVELOPMENT AUTHORITY

14 (1) For the purposes of providing assistance under the high
15 quality jobs program as described in section 15.335B:

16 \$ 15,900,000

17 (2) From the moneys appropriated in this lettered paragraph
18 "a", the economic development authority may use not more than
19 \$1,000,000 for purposes of providing infrastructure grants to
20 mainstreet communities under the main street Iowa program.

21 (3) As a condition of receiving moneys appropriated in
22 this lettered paragraph "a", an entity shall testify upon the
23 request of the joint appropriations subcommittee on economic
24 development regarding the expenditure of such moneys.

25 b. STATE BOARD OF REGENTS AND REGENTS INSTITUTIONS

26 (1) STATE BOARD OF REGENTS. For capacity building
27 infrastructure in areas related to technology
28 commercialization, marketing and business development
29 efforts in areas related to technology commercialization,
30 entrepreneurship, and business growth, and infrastructure
31 projects and programs needed to assist in implementation of
32 activities under chapter 262B:

33 \$ 3,000,000

34 Of the moneys appropriated pursuant to this subparagraph
35 (1), 35 percent shall be allocated for Iowa state university of

1 science and technology, 35 percent shall be allocated for the
2 state university of Iowa, and 30 percent shall be allocated for
3 the university of northern Iowa.

4 (a) The institutions shall provide a one-to-one match
5 of additional moneys for the activities funded with moneys
6 appropriated under this subparagraph (1).

7 (b) The state board of regents shall annually submit a
8 report by January 15 to the governor, the general assembly,
9 and the legislative services agency regarding the activities,
10 projects, and programs funded with moneys appropriated under
11 this subparagraph (1). The report shall be provided in an
12 electronic format and shall include a list of metrics and
13 criteria mutually agreed to in advance by the board of regents
14 and the economic development authority. The metrics and
15 criteria shall allow the governor's office and the general
16 assembly to quantify and evaluate the progress of the board of
17 regents institutions with regard to their activities, projects,
18 and programs in the areas of technology commercialization,
19 entrepreneurship, regional development, and market research.

20 (2) IOWA STATE UNIVERSITY OF SCIENCE AND TECHNOLOGY. For
21 small business development centers, the science and technology
22 research park, and the center for industrial research and
23 service, and for not more than the following full-time
24 equivalent positions:

25	\$	2,424,302
26	FTEs	56.63

27 (a) Of the moneys appropriated in this subparagraph (2),
28 Iowa state university of science and technology shall allocate
29 at least \$735,728 for purposes of funding small business
30 development centers. Iowa state university of science and
31 technology may allocate the appropriated moneys to the various
32 small business development centers in any manner necessary to
33 achieve the purposes of this subparagraph.

34 (b) Iowa state university of science and technology shall
35 do all of the following:

1 (i) Direct expenditures for research toward projects that
2 will provide economic stimulus for Iowa.

3 (ii) Provide emphasis to providing services to Iowa-based
4 companies.

5 (c) It is the intent of the general assembly that the
6 industrial incentive program focus on Iowa industrial sectors
7 and seek contributions and in-kind donations from businesses,
8 industrial foundations, and trade associations, and that moneys
9 for the center for industrial research and service industrial
10 incentive program shall be allocated only for projects which
11 are matched by private sector moneys for directed contract
12 research or for nondirected research. The match required of
13 small businesses as defined in section 15.102, subsection 8,
14 for directed contract research or for nondirected research
15 shall be \$1 for each \$3 of state funds. The match required
16 for other businesses for directed contract research or
17 for nondirected research shall be \$1 for each \$1 of state
18 funds. The match required of industrial foundations or trade
19 associations shall be \$1 for each \$1 of state funds.

20 Iowa state university of science and technology shall
21 report annually to the joint appropriations subcommittee on
22 economic development and the legislative services agency the
23 total amount of private contributions, the proportion of
24 contributions from small businesses and other businesses, and
25 the proportion for directed contract research and nondirected
26 research of benefit to Iowa businesses and industrial sectors.

27 (3) STATE UNIVERSITY OF IOWA. For the state university
28 of Iowa research park and for the advanced drug development
29 program at the Oakdale research park, including salaries,
30 support, maintenance, equipment, and miscellaneous purposes,
31 and for not more than the following full-time equivalent

EXPLANATION

30 The inclusion of this explanation does not constitute agreement with
31 the explanation's substance by the members of the general assembly.

32 This bill makes appropriations and transfers for FY
33 2017-2018 and FY 2018-2019 from the general fund of the state
34 and other funds to the department of cultural affairs, the
35 economic development authority, the Iowa finance authority, the

1 public employment relations board, the department of workforce
2 development, the board of regents, the state university
3 of Iowa, the university of northern Iowa, and Iowa state
4 university of science and technology. The bill is organized
5 by divisions.

6 The bill appropriates moneys for FY 2017-2018 and FY
7 2018-2019 from the special employment security contingency fund
8 to the department of workforce development for field offices.

9 The bill appropriates interest earned on the unemployment
10 compensation reserve fund for FY 2017-2018 and FY 2018-2019 to
11 the department of workforce development for the operation of
12 field offices.

13 The bill appropriates moneys for FY 2017-2018 from the
14 unemployment compensation fund to the department of workforce
15 development for modernization of systems and for other
16 programs.

17 The bill appropriates moneys for FY 2017-2018 and FY
18 2018-2019 from the Iowa skilled worker and job creation fund to
19 the economic development authority and the board of regents and
20 certain regents institutions.

21 The bill limits standing appropriations, established in
22 Code, for the world food prize, certain operational support
23 grants, community cultural grants, and regional tourism
24 marketing for FY 2017-2018 and FY 2018-2019.

25 The bill also provides for the retention of certain costs
26 and fees by the public employment relations board.

27 The bill transfers the administration of the Iowa energy
28 center from the Iowa state university of science and technology
29 (Iowa state) to the economic development authority (EDA). The
30 bill repeals Code section 266.39C and establishes new Code
31 section 15.120, which places the center within the EDA. The
32 bill provides that the center has the following specified
33 purposes: to expand workforce and career opportunities for
34 workers in the energy sector; to support technology-based
35 development with public-private partnerships and innovative

1 manufacturers; to support rural and underserved areas and
2 vulnerable populations by providing resources for energy
3 efficiency and cyber security-related resources; to support
4 the expansion of natural gas infrastructure to rural and
5 underserved areas of the state; to promote the research,
6 development, and commercialization of biomass technology; to
7 encourage growth of the alternative fuel vehicle market and
8 infrastructure; and to support efforts to modernize the state's
9 electric grid infrastructure.

10 The bill establishes a governing board consisting of the
11 same number and background of members in the advisory council
12 established in current Code section 266.39C, but all to be
13 appointed by the governor in consultation with specified
14 persons. The board must oversee, approve, and provide
15 direction for the center's programs and shall ensure that all
16 ratepayer moneys remitted by the utilities board pursuant to
17 Code section 476.10A are used on programs designed to provide
18 benefits to gas and electric utility ratepayers. The board
19 must also oversee the center in the development of a budget
20 and other matters and approve the center's annual budget. The
21 bill excludes provisions relating to the appointment of a
22 director as contained in current Code section 266.39C. The
23 bill requires the center to employ necessary support staff
24 and prepare an annual report in coordination with the EDA and
25 submit the report to the general assembly and the legislative
26 services agency.

27 The bill makes conforming changes throughout the Code by
28 replacing references to Code section 266.39C with Code section
29 15.120, and provides transition provisions.

30 The division of the bill related to the Iowa energy center
31 takes effect October 1, 2017. The division provides for the
32 repeal of the Code section establishing the Iowa energy center,
33 effective July 1, 2022, and includes additional conforming
34 provisions.
