A BILL FOR

- 1 An Act concerning the use of mobile telephones while driving
- 2 and providing penalties.
- 3 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

- 1 Section 1. Section 321.1, Code 2017, is amended by adding
- 2 the following new subsection:
- 3 NEW SUBSECTION. 39. "Mobile telephone" means mobile
- 4 telephone as defined in 49 C.F.R. §383.5.
- 5 Sec. 2. Section 321.210, subsection 2, paragraph e, Code
- 6 2017, is amended to read as follows:
- 7 e. Violations of section sections 321.276 and 321.276A.
- Sec. 3. Section 321.276, subsection 1, paragraph a, Code
- 9 2017, is amended by striking the paragraph and inserting in
- 10 lieu thereof the following:
- 11 a. "Fixed unit global positioning system or navigation
- 12 system" means an electronic device that is mounted inside a
- 13 motor vehicle and is capable of providing navigation directions
- 14 to a driver based on data entered into the device.
- 15 Sec. 4. Section 321.276, subsection 2, paragraph a, Code
- 16 2017, is amended to read as follows:
- 17 a. A person does not violate this section by using a fixed
- 18 unit global positioning system or navigation system or when,
- 19 for the purpose of engaging in a call, the person selects
- 20 or enters a telephone number or name in a hand-held mobile
- 21 telephone or activates, deactivates, or initiates a function of
- 22 a hand-held mobile telephone to receive navigation directions,
- 23 provided that the person does not manually enter data into the
- 24 fixed unit global positioning system or navigation system while
- 25 operating the motor vehicle.
- 26 Sec. 5. NEW SECTION. 321.276A Use of mobile telephone while
- 27 driving.
- 28 1. A person shall not drive a motor vehicle while using a
- 29 mobile telephone unless the mobile telephone is specifically
- 30 designed and configured to allow hands-free listening and
- 31 talking and is used in that manner while driving.
- 32 2. This section does not apply to the following persons:
- 33 a. A member of a public safety agency, as defined in section
- 34 34.1, performing official duties.
- 35 b. A health care professional in the course of an emergency

- 1 situation.
- 2 c. A person receiving safety-related information including 3 emergency, traffic, or weather alerts.
- d. The driver of a motor vehicle when the motor vehicle is
- 5 at a complete stop off the traveled portion of the roadway.
- 6 3. Nothing in this section shall be construed to authorize a
- 7 peace officer to confiscate a mobile telephone from the driver
- 8 or occupant of a motor vehicle.
- 9 4. a. A person convicted of a violation of this section
- 10 is guilty of a simple misdemeanor punishable as a scheduled
- 11 violation under section 805.8A, subsection 14, paragraph "m".
- 12 b. A violation of this section shall not be considered a
- 13 moving violation for purposes of this chapter or rules adopted
- 14 pursuant to this chapter.
- 15 Sec. 6. Section 321.482A, unnumbered paragraph 1, Code
- 16 2017, is amended to read as follows:
- 17 Notwithstanding section 321.482, a person who is convicted
- 18 of operating a motor vehicle in violation of section 321.178,
- 19 subsection 2, paragraph "a", subparagraph (2), section
- 20 321.180B, subsection 6, section 321.194, subsection 2,
- 21 paragraph "b", subparagraph (2), section 321.256, 321.257,
- 22 section 321.275, subsection 4, section 321.276, 321.276A,
- 23 321.297, 321.298, 321.299, 321.302, 321.303, 321.304, 321.305,
- 24 321.306, 321.307, 321.308, section 321.309, subsection 2, or
- 25 section 321.311, 321.319, 321.320, 321.321, 321.322, 321.323,
- 26 321.324, 321.324A, 321.327, 321.329, 321.333, or 321.372,
- 27 subsection 3, causing serious injury to or the death of another
- 28 person may be subject to the following penalties in addition
- 29 to the penalty provided for a scheduled violation in section
- 30 805.8A or any other penalty provided by law:
- 31 Sec. 7. Section 321.555, subsection 2, Code 2017, is amended
- 32 to read as follows:
- 33 2. Six or more of any separate and distinct offenses within
- 34 a two-year period in the operation of a motor vehicle, which
- 35 are required to be reported to the department by section

- 1 321.491 or chapter 321C, except equipment violations, parking
- 2 violations as defined in section 321.210, violations of
- 3 registration laws, violations of sections 321.445 and 321.446,
- 4 violations of section sections 321.276 and 321.276A, operating
- 5 a vehicle with an expired license or permit, failure to appear,
- 6 weights and measures violations and speeding violations of less
- 7 than fifteen miles per hour over the legal speed limit.
- 8 Sec. 8. Section 805.8A, subsection 14, Code 2017, is amended
- 9 by adding the following new paragraph:
- 10 NEW PARAGRAPH. m. Mobile telephone violations. For
- 11 violations under section 321.276A, the scheduled fine is thirty
- 12 dollars.
- 13 EXPLANATION
- 14 The inclusion of this explanation does not constitute agreement with
- the explanation's substance by the members of the general assembly.
- 16 This bill prohibits a person from driving a motor vehicle
- 17 while using a mobile telephone unless the mobile telephone
- 18 is specifically designed and configured to allow hands-free
- 19 listening and talking and is used in that manner. The bill
- 20 does not apply to the driver of a motor vehicle when the motor
- 21 vehicle is at a complete stop off the traveled portion of the
- 22 roadway. In addition, the bill exempts the following persons
- 23 from the prohibition: a member of a public safety agency
- 24 performing official duties; a health care professional in
- 25 the course of an emergency situation; and a person receiving
- 26 safety-related information including emergency, traffic, or
- 27 weather alerts. These are the same exemptions that currently
- 28 apply under Iowa law prohibiting text-messaging while driving.
- 29 The bill defines "mobile telephone" to mean the same
- 30 as defined in federal motor carrier safety administration
- 31 regulations. Under that definition, "mobile telephone" means
- 32 a mobile communication device that falls under or uses any
- 33 commercial mobile radio service, as defined in regulations of
- 34 the federal communications commission. The federal definition
- 35 explicitly excludes two-way or citizens band radio services.

      The bill amends current provisions prohibiting
 2 text-messaging while driving to specify that a person does not
 3 violate the text-messaging provisions by using a fixed unit
 4 global positioning system or navigation system, provided the
 5 person does not enter data into the system while operating
 6 the motor vehicle. "Fixed unit global positioning system or
 7 navigation system" is defined as an electronic device mounted
 8 inside a motor vehicle and capable of providing navigation
 9 directions to a driver based on data entered into the device.
10 The bill also strikes a current exception to the prohibition
11 on text-messaging while driving which applies to a person
12 selecting or entering a telephone number or name in a hand-held
13 mobile telephone or activating, deactivating, or initiating a
14 function of a hand-held mobile telephone.

      The penalties established in the bill mirror the penalties
16 currently applicable for text-messaging while driving.
17 person who uses a mobile telephone while driving in violation
18 of the bill commits a simple misdemeanor punishable by
19 a scheduled fine of $30. The offense is not a moving
20 violation, and therefore cannot be considered for purposes of
21 administrative suspension of a driver's license or to establish
22 habitual offender status. However, if the violation causes a
23 serious injury, a court could impose an additional fine of $500
24 or suspend the person's driver's license for not more than 90
25 days, or both. If the violation causes a death, a court could
26 impose an additional fine of $1,000 or suspend the person's
27 driver's license for not more than 180 days, or both.
      The bill does not authorize a peace officer to confiscate a

29 mobile telephone from a driver or occupant of a motor vehicle.
30 However, a peace officer may stop or detain a driver solely for
31 using a hand-held mobile telephone while driving.
