## A BILL FOR

- 1 An Act relating to snowmobile user permits and registration
- 2 fees.
- 3 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

- 1 Section 1. Section 321G.2, subsection 1, paragraph h, Code
- 2 2017, is amended by striking the paragraph.
- 3 Sec. 2. Section 321G.3, Code 2017, is amended to read as 4 follows:
- 5 321G.3 Registration and user permit required penalties.
- 6 l. Each snowmobile used by a resident on public land, public
- 7 ice, or a designated snowmobile trail of this state shall be
- 8 currently registered in this state pursuant to section 321G.4.
- 9 A resident shall not operate, maintain, or give permission
- 10 for the operation or maintenance of a snowmobile on public
- 11 land, public ice, or a designated snowmobile trail unless the
- 12 snowmobile is registered in accordance with this chapter.
- 13 The owner of a snowmobile must also obtain a user permit in
- 14 accordance with section 321G.4A.
- 2. A violation of subsection 1 is punishable as a
- 16 scheduled violation under section 805.8B, subsection 2,
- 17 paragraph "a". When the scheduled fine is paid, the violator
- 18 shall submit proof to the department that a valid registration
- 19 and user permit have has been obtained by providing a copy
- 20 of the registration and user permit to the department within
- 21 thirty days of the date the fine is paid. A person who violates
- 22 this subsection is guilty of a simple misdemeanor.
- Sec. 3. Section 321G.4, subsection 2, Code 2017, is amended
- 24 to read as follows:
- 25 2. The owner of the snowmobile shall file an application for
- 26 registration with the department through the county recorder
- 27 of the county of residence in the manner established by the
- 28 commission. The application shall be completed by the owner
- 29 and shall be accompanied by a fee of fifteen thirty dollars and
- 30 a writing fee as provided in section 321G.27. A snowmobile
- 31 shall not be registered by the county recorder until the
- 32 county recorder is presented with receipts, bills of sale,
- 33 or other satisfactory evidence that the sales or use tax has
- 34 been paid for the purchase of the snowmobile or that the
- 35 owner is exempt from paying the tax. A snowmobile that has

- 1 an expired registration certificate from another state may be
- 2 registered in this state upon proper application, payment of
- 3 all applicable registration and writing fees, and payment of a
- 4 penalty of five dollars.
- 5 Sec. 4. Section 321G.4B, Code 2017, is amended to read as
- 6 follows:
- 7 321G.4B Nonresident requirements penalties.
- 8 1. A nonresident wishing to operate a snowmobile on public
- 9 land, public ice, or a designated snowmobile trail of this
- 10 state shall obtain a user permit in accordance with section
- 11 321G.4A. In addition to obtaining a user permit, a nonresident
- 12 shall display a current registration decal or other evidence
- 13 of registration or numbering required by the owner's state of
- 14 residence unless the owner resides in a state that does not
- 15 register or number snowmobiles.
- 2. A violation of subsection 1 is punishable as a scheduled
- 17 violation under section 805.8B, subsection 2, paragraph "a".
- 18 When the scheduled fine is paid, the violator shall submit
- 19 proof to the department that a user permit has been obtained
- 20 and provide evidence of registration or numbering as required
- 21 by the owner's state of residence, if applicable, to the
- 22 department within thirty days of the date the fine is paid.
- 23 A person who violates this section is guilty of a simple
- 24 misdemeanor.
- Sec. 5. Section 321G.5, Code 2017, is amended to read as
- 26 follows:
- 27 321G.5 Display of registration and user permit decals decal.
- The owner of a snowmobile shall display the registration
- 29 decal and user permit decal on the snowmobile in the manner
- 30 prescribed by the rules of the commission.
- 31 Sec. 6. Section 321G.6, subsections 1 and 4, Code 2017, are
- 32 amended to read as follows:
- 33 1. Every snowmobile registration certificate and
- 34 registration decal issued expires at midnight December 31
- 35 unless sooner terminated or discontinued in accordance with

- 1 this chapter or rules of the commission. After the first
- 2 day of September each year, an unregistered snowmobile
- 3 may be registered and a registration may be renewed in one
- 4 transaction. The fee is five dollars for the remainder of the
- 5 current year, in addition to the registration fee of fifteen
- 6 thirty dollars for the subsequent year beginning January 1, and
- 7 a writing fee as provided in section 321G.27.
- 8 4. A county recorder or a license agent designated by the
- 9 director pursuant to section 483A.11 may issue snowmobile
- 10 registration renewals electronically pursuant to rules adopted
- ll by the commission. The fee for a registration renewal issued
- 12 using an electronic system is fifteen thirty dollars plus an
- 13 administrative fee established by the commission and a writing
- 14 fee as provided in section 321G.27.
- Sec. 7. Section 321G.7, subsection 2, Code 2017, is amended
- 16 to read as follows:
- 17 2. The department shall remit the fees, including user
- 18 permit fees collected pursuant to section 3216.4A, to the
- 19 treasurer of state, who shall place the money in a special
- 20 snowmobile fund. The money is appropriated to the department
- 21 for the snowmobile programs of the state. The programs shall
- 22 include grants, subgrants, contracts, or cost-sharing of
- 23 snowmobile programs with political subdivisions or incorporated
- 24 private organizations or both in accordance with rules adopted
- 25 by the commission. Snowmobile fees may be used to support
- 26 snowmobile programs on a usage basis. At least fifty eighty
- 27 percent of the special fund shall be available for political
- 28 subdivisions or incorporated private organizations or both.
- 29 Moneys from the special fund not used by the political
- 30 subdivisions or incorporated private organizations or both
- 31 shall remain in the fund and may be used by the department for
- 32 the administration of the snowmobile programs purchase of trail
- 33 grooming equipment. Notwithstanding section 8.33, moneys in
- 34 the special fund shall not revert to the general fund of the
- 35 state at the end of a fiscal year. Notwithstanding section

- 1 12C.7, subsection 2, interest or earnings on moneys in the
- 2 special fund shall remain in the fund.
- 3 Sec. 8. Section 321G.8, Code 2017, is amended to read as
- 4 follows:
- 5 321G.8 Exempt vehicles.
- 6 Registration and user permits shall not be required for the
- 7 following described snowmobiles:
- 8 1. Snowmobiles owned by the United States, this state, or
- 9 another state, or by a governmental subdivision thereof, and
- 10 used for enforcement, search and rescue, or official research
- 11 and studies, but not for recreational or commercial purposes.
- 12 2. Snowmobiles used exclusively as farm implements.
- 3. Snowmobiles registered with an approved sponsored
- 14 snowmobile special event.
- 15 Sec. 9. Section 321G.27, subsection 1, paragraph b, Code
- 16 2017, is amended by striking the paragraph.
- 17 Sec. 10. Section 321G.27, subsection 2, Code 2017, is
- 18 amended to read as follows:
- 19 2. a. A license agent shall collect a writing fee of
- 20 one dollar for a snowmobile registration or for renewal of a
- 21 registration by the license agent.
- 22 b. A license agent shall retain a writing fee of one dollar
- 23 from the sale of each user permit issued by the license agent.
- 24 Sec. 11. Section 321G.34, subsection 5, Code 2017, is
- 25 amended to read as follows:
- 26 5. a. Upon the conviction of a person of any violation of
- 27 this chapter or a rule adopted under this chapter, the court,
- 28 as a part of the judgment, may suspend or revoke one or more
- 29 snowmobile registration or user permit privileges of the person
- 30 for any definite period.
- 31 b. The court shall revoke all of the person's snowmobile
- 32 registrations or user permits and suspend the privilege of
- 33 procuring a registration or user permit for a period of one
- 34 year for any person who has been convicted twice within one
- 35 year of trespassing while operating a snowmobile. A person

- 1 shall not be issued a registration or user permit during the
- 2 period of suspension or revocation.
- 3 Sec. 12. Section 331.602, subsection 16, Code 2017, is
- 4 amended to read as follows:
- 5 16. Issue snowmobile and all-terrain vehicle registrations
- 6 and user permits as provided in sections 321G.4, 321G.4A,
- 7 321G.6, 321G.21, 321I.4, 321I.5, 321I.7, and 321I.22.
- 8 Sec. 13. Section 331.605, subsection 1, paragraph d, Code
- 9 2017, is amended to read as follows:
- 10 d. For the issuance of snowmobile registrations and user
- 11 permits, the fees specified in sections section 321G.4 and
- 12 321G.4A.
- 13 Sec. 14. REPEAL. Section 321G.4A, Code 2017, is repealed.
- 14 EXPLANATION
- 15 The inclusion of this explanation does not constitute agreement with
- the explanation's substance by the members of the general assembly.
- 17 This bill relates to snowmobile user permits and
- 18 registration fees. The bill eliminates a requirement that
- 19 a snowmobile operator must obtain a user permit from the
- 20 department of natural resources to operate a snowmobile on
- 21 public land, public ice, or a designated snowmobile trail of
- 22 the state. Code section 321G.4A, concerning the issuance
- 23 of user permits and user permit fees, is repealed and
- 24 cross-references to the repealed Code section are stricken.
- 25 References to user permits are also stricken.
- 26 The bill raises the annual registration fee for a snowmobile
- 27 from \$15 to \$30. The bill also provides that 80 percent
- 28 instead of 50 percent of the fees in the special snowmobile
- 29 fund shall be available for the use of political subdivisions
- 30 or incorporated private organizations or both. The bill
- 31 provides that moneys not used by those entities remain in the
- 32 fund and may be used by the department of natural resources
- 33 for the purchase of trail grooming equipment, instead of for
- 34 administration of snowmobile programs.
- 35 The bill adds an exemption from registration requirements

- 1 for snowmobiles that are registered with an approved sponsored
- 2 snowmobile special event.
