- 15 Sec. 3. Section 68B.22, subsection 4, paragraph s, Code
- 16 2018, is amended to read as follows:
- 17 s. Gifts of food Food, beverage, and entertainment received
- 18 at a function where every member of the general assembly has

- 20 a regular session of the general assembly. A sponsor of a
- 21 function under this paragraph shall file a registration prior
- 22 to the function taking place identifying the sponsor and the

the explanation's substance by the members of the general assembly.

- 2 This bill relates to governmental ethics and the regulation 3 of lobbyists and gifts.
- 4 Currently, the definition of "lobbyist" includes eight
- 5 exceptions. One of the exceptions provides that a person is
- 6 not a lobbyist if the person is an individual who is a member,
- 7 director, trustee, officer, or committee member of a business,
- 8 trade, labor, farm, professional, religious, education, or
- 9 charitable association, foundation, or organization who either
- 10 is not paid compensation or is not specifically designated as
- 11 a lobbyist. The bill, in order for the exception to apply,
- 12 requires the person to both not be paid compensation and not be
- 13 specifically designated as a lobbyist.
- 14 The bill amends two exceptions to the gift law by eliminating
- 15 wording redundancies.
