## A BILL FOR

- 1 An Act authorizing the department of natural resources to
- 2 establish certain fees at state parks and recreation areas.
- 3 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

- 1 Section 1. <u>NEW SECTION</u>. **455A.14 Camping and rental** 2 facilities and other privileges fees.
- 1. Notwithstanding any provision of law to the contrary,
  4 the department is authorized to establish fees for camping
  5 and use of rental facilities and other special privileges at
  6 state parks and recreation areas under the jurisdiction of the
  7 department.
- 8 2. The fees established by the department pursuant to this 9 section shall be in such amounts as may be determined by the 10 department based on the cost of providing the privileges and 11 the reasonable value of such privileges. Such fees may be 12 increased, reduced, or waived by the department for special 13 promotional events or efforts or on the basis of special 14 seasonal or holiday rates, on a statewide basis or on the basis 15 of an individual state park or recreation area.
- 16 3. Fees established pursuant to this section shall be 17 considered a specification of prices to be charged for goods or 18 services as provided in section 17A.2, subsection 11, paragraph 19 "g".
- The department shall adopt rules pursuant to chapter 17A
   for the purpose of setting forth the methodology to be used in
   establishing fees pursuant to this section.

  23 5. The department shall prepare an annual report reviewing
  24 the fees established pursuant to this section. The report
  25 shall include information about fees and occupancy rates
  26 at each camping and rental facility in the state under the
  27 jurisdiction of the department, special promotional events or
  28 holiday rates for which fees were increased, reduced, or waived
  29 at those camping and rental facilities, and any recommendations
  30 for changes in fees or rules adopted pursuant to this section.
  31 The report shall be submitted to the park advisory oversight
  32 committee by December 31 of each year.
- 33 6. A park advisory oversight committee is established, 34 which shall consist of the chairpersons, vice chairpersons, and 35 ranking members of the senate standing committee on natural

- 2 natural resources. The committee shall meet annually to review
- 3 the report submitted by the department pursuant to subsection
- 4 5. The committee shall submit any recommendations, based
- 5 on that review, to the senate standing committee on natural
- 6 resources and environment and the house standing committee on
- 7 natural resources.
- 8 Sec. 2. REPEAL. Sections 455A.12 and 461A.47, Code 2018,
- 9 are repealed.
- 10 EXPLANATION
- 11 The inclusion of this explanation does not constitute agreement with
- the explanation's substance by the members of the general assembly.
- 13 This bill provides that, notwithstanding any provision of
- 14 law to the contrary, the department of natural resources is
- 15 authorized to establish fees for camping and use of rental
- 16 facilities and other special privileges at state parks and
- 17 recreation areas under the jurisdiction of the department.
- 18 Currently, the natural resource commission is authorized to
- 19 establish such fees under Code section 461A.47, which is
- 20 repealed by the bill.
- 21 The bill also provides that fees established by the
- 22 department pursuant to the bill's provisions shall be in such
- 23 amounts as may be determined by the department based on the
- 24 cost of providing the privileges and the reasonable value
- 25 of such privileges. Such fees may be increased, reduced,
- 26 or waived by the department for special promotional events
- 27 or efforts or on the basis of special seasonal or holiday
- 28 rates, on a statewide basis or on the basis of an individual
- 29 state park or recreation area. The bill provides that fees
- 30 established pursuant to the bill are considered a specification
- 31 of the prices to be charged for goods or services sold by
- 32 an agency and are not considered rules for purposes of Code
- 33 chapter 17A. The department is required to adopt rules that
- 34 set forth the methodology to be used in establishing the fees.
- 35 The bill requires the department to prepare an annual report

- 1 that reviews the fees, occupancy rates, and events and provides
- 2 recommendations for changes in fees for rules adopted pursuant
- 3 to the bill. The department shall submit the report to a newly
- 4 established park advisory oversight committee, which shall
- 5 consist of the chairpersons, vice chairpersons, and ranking
- 6 members of the senate standing committee on natural resources
- 7 and environment and the house standing committee on natural
- 8 resources. After reviewing the report, the advisory committee
- 9 shall make recommendations to the senate standing committee
- 10 on natural resources and environment and the house standing
- 11 committee on natural resources.
- 12 Code section 455A.12 relating to the sale of gift
- 13 certificates by the department for free camping and other
- 14 special privileges at state parks and recreation areas is
- 15 repealed.
