- 26 GENERAL. This bill relates to agriculture and natural

- 29 the department of agriculture and land stewardship (DALS),
- 30 the department of natural resources (DNR), and Iowa state
- 31 university (ISU).
- 32 The bill primarily appropriates moneys to DALS and DNR.
- 33 The appropriations are made to support those departments for
- 34 administration, regulation, and support of programs. The bill
- 35 requires the departments to submit quarterly reports to the
