A BILL FOR

- 1 An Act relating to the procedures for granting a waterworks or
- 2 sewer services franchise by a city and including effective
- 3 date provisions.
- 4 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

- 1 Section 1. Section 364.2, subsection 4, paragraphs a and b, 2 Code 2017, are amended to read as follows:
- 3 a. A city may grant to any person a franchise to erect,
- 4 maintain, and operate plants and systems for electric light
- 5 and power, heating, telegraph, cable television, district
- 6 telegraph and alarm, motor bus, trolley bus, street railway or
- 7 other public transit, waterworks, sewer services, or gasworks,
- 8 within the city for a term of not more than twenty-five years.
- 9 When considering whether to grant, amend, extend, or renew a
- 10 franchise, a city shall hold a public hearing on the question.
- 11 Notice of the time and place of the hearing shall be published
- 12 as provided in section 362.3. The franchise may be granted,
- 13 amended, extended, or renewed only by an ordinance, but no
- 14 exclusive franchise shall be granted, amended, extended, or
- 15 renewed.
- 16 b. Such an ordinance shall not become effective unless
- 17 approved at an election. The proposal may be submitted
- 18 by the council on its own motion to the voters at any city
- 19 election. Upon receipt of a valid petition as defined in
- 20 section 362.4 requesting that a proposal be submitted to the
- 21 voters, the council shall submit the proposal at the next
- 22 regular city election or at a special election called for
- 23 that purpose before the next regular city election. However,
- 24 the city council may dispense with such election as to the
- 25 grant, amendment, extension, or renewal of an electric light
- 26 and power, heating, waterworks, sewer services under section
- 27 357A.23, or gasworks franchise unless there is a valid petition
- 28 requesting submission of the proposal to the voters, or the
- 29 party seeking such franchise, grant, amendment, extension, or
- 30 renewal requests an election. If a majority of those voting
- 31 approves the proposal, the city may proceed as proposed. The
- 32 complete text of the ordinance shall be included on the ballot
- 33 if conventional paper ballots are used. If an optical scan
- 34 voting system is used, the proposal shall be stated on the
- 35 optical scan ballot, and the full text of the ordinance posted

- 1 for the voters pursuant to section 52.25. All absentee voters
- 2 shall receive the full text of the ordinance.
- 3 Sec. 2. EFFECTIVE UPON ENACTMENT. This Act, being deemed of
- 4 immediate importance, takes effect upon enactment.
- 5 EXPLANATION
- The inclusion of this explanation does not constitute agreement with the explanation's substance by the members of the general assembly.
- 8 Current Code section 364.2 authorizes cities to grant,
- 9 by ordinance, franchises for certain specified functions and
- 10 services undertaken within the city. Such franchises may be
- 11 granted for a term of not more than 25 years. This bill adds
- 12 sewer services to the list of functions and services for which
- 13 a city may grant a franchise.
- 14 An ordinance granting a franchise does not become effective
- 15 until approved at election. A city may, however, dispense with
- 16 such election as to the grant, amendment, extension, or renewal
- 17 of an electric light and power, heating, or gasworks franchise
- 18 unless there is a valid petition requesting submission of the
- 19 proposal to the voters, or the party seeking such franchise,
- 20 grant, amendment, extension, or renewal requests an election.
- 21 This bill adds a sewer services franchise granted under
- 22 Code section 357A.23 and a waterworks franchise to the list of
- 23 franchises for which the election is not required unless there
- 24 is a valid petition or request from the party seeking such
- 25 franchise, grant, amendment, extension, or renewal.
- 26 The bill takes effect upon enactment.
