A BILL FOR

- 1 An Act relating to the coordination of enforcement activities
- 2 between the department of transportation and the department
- 3 of public safety, including provisions relating to
- 4 department of transportation employees designated as peace
- officers, and including effective date provisions.
- 6 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

- 1 Section 1. Section 321.477, Code 2018, is amended to read 2 as follows:
- 3 321.477 Employees as peace officers maximum age.
- 4 1. The department may designate by resolution certain of its
- 5 employees upon each of whom there is conferred the authority
- 6 of a peace officer to enforce all laws of the state including
- 7 but not limited to the rules and regulations of the department.
- 8 Employees designated as peace officers pursuant to this
- 9 section shall have the same powers, duties, privileges, and
- 10 immunities conferred by law on peace officers for relating to
- 11 the enforcement of all laws of this state and the apprehension
- 12 of violators.
- 2. Employees designated as peace officers pursuant to this
- 14 section who are assigned to the supervision of the highways
- 15 of this state shall spend the preponderance of their time
- 16 conducting enforcement activities that assure the safe and
- 17 lawful movement and operation of commercial motor vehicles and
- 18 vehicles transporting loads, including but not limited to the
- 19 enforcement of motor vehicle laws relating to the operating
- 20 authority, registration, size, weight, and load of motor
- 21 vehicles and trailers, and registration of a motor carrier's
- 22 interstate transportation service with the department.
- 23 3. Employees designated as peace officers pursuant to
- 24 this section shall not exercise the general powers of a peace
- 25 officer within the limits of any city, except as follows:
- 26 a. When so ordered by the direction of the governor.
- 27 b. When request is made by the mayor of any city, with the
- 28 approval of the director.
- 29 c. When request is made by the sheriff or county attorney of
- 30 any county, with the approval of the director.
- 31 d. While in the pursuit of law violators or in investigating
- 32 law violations.
- 33 e. While making any inspection provided by this chapter, or
- 34 any additional inspection ordered by the director.
- 35 f. When engaged in the investigation and enforcement of laws

- 1 relating to narcotic, counterfeit, stimulant, and depressant 2 drugs.
- 4. The limitations specified in subsection 3 shall in no
- 4 way be construed as a limitation on the power of employees
- 5 designated as peace officers pursuant to this section when a
- 6 public offense is being committed in their presence.
- The department shall submit a report to the general
- 8 assembly on or before December 1 of each year that details the
- 9 nature and scope of enforcement activities conducted in the
- 10 previous fiscal year by employees designated as peace officers
- 11 pursuant to this section who are assigned to the supervision
- 12 of the highways of this state. The report shall include a
- 13 comparison of commercial and noncommercial motor vehicle
- 14 enforcement activities conducted by such employees.
- 15 The department and the department of public safety shall
- 16 coordinate to provide effective and efficient enforcement of
- 17 all laws of the state, including any related regulatory action.
- 18 6. 5. The maximum age for a person employed as a peace
- 19 officer pursuant to this section is sixty-five years of age.
- 20 Sec. 2. REPEAL. 2017 Iowa Acts, chapter 149, section 4, is
- 21 repealed.
- 22 Sec. 3. EFFECTIVE DATE. This Act, being deemed of immediate
- 23 importance, takes effect upon enactment.
- 24 EXPLANATION
- 25 The inclusion of this explanation does not constitute agreement with 26
- the explanation's substance by the members of the general assembly.
- 27 Under current law, the department of transportation (DOT)
- 28 is authorized to designate by resolution certain of its
- 29 employees upon each of whom there is conferred the authority
- 30 of a peace officer to enforce all laws of the state including
- 31 but not limited to the rules and regulations of the DOT.
- 32 Employees designated as peace officers in this manner have
- 33 the same powers conferred by law on peace officers for the
- 34 enforcement of all laws of this state and the apprehension
- 35 of violators. This bill amends current law to specify that

- 1 employees designated as peace officers in this manner have the
- 2 same powers, duties, privileges, and immunities conferred by
- 3 law on peace officers relating to the enforcement of all laws
- 4 of this state and the apprehension of violators.
- 5 Under current law, such employees are prohibited from
- 6 exercising the general powers of a peace officer within
- 7 the limits of any city, except under certain circumstances.
- 8 However, the limitation does not apply when a public offense is
- 9 being committed in the employee's presence. The bill strikes
- 10 these provisions.
- 11 The bill provides that the DOT and the department of public
- 12 safety are required to coordinate to provide effective and
- 13 efficient enforcement of all laws of the state, including any
- 14 related regulatory action.
- In 2017, the general assembly amended Code section 321.477
- 16 to specify the powers, duties, and limitations of such
- 17 employees. Under the terms of the legislation, the amended
- 18 language is set to be repealed effective July 1, 2018. Because
- 19 the bill amends language enacted in 2017, the bill repeals the
- 20 future repeal provision. The bill takes effect upon enactment.
