A BILL FOR

1 An Act providing for the issuance and display of one motor
2 vehicle registration plate, including by requiring a study
3 on other means available to identify motor vehicles from the
4 front, and including transition provisions.

5 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

1 Section 1. Section 8A.362, subsection 7, Code 2020, is
2 amended to read as follows:

3 7. The director shall require that a sign be placed on
4 each state-owned motor vehicle in a conspicuous place which
5 indicates its ownership by the state. This requirement
6 shall not apply to motor vehicles requested to be exempt by
7 the director or by the commissioner of public safety. All
8 state-owned motor vehicles shall display a registration
9 ~~plates~~ plate bearing the word "official" except motor vehicles
10 requested to be furnished with an ordinary ~~plates~~ plate by the
11 director or by the commissioner of public safety pursuant to
12 section 321.19. The director shall keep an accurate record of
13 the registration plates used on all state-owned motor vehicles.
14 **This subsection** shall not apply to an assigned vehicle rented
15 or leased pursuant to **section 8A.367**.

16 Sec. 2. Section 321.18, subsection 7, Code 2020, is amended
17 to read as follows:

18 7. Any school bus in this state used exclusively for
19 the transportation of pupils to and from school or a school
20 function or for the purposes provided in section 285.1,
21 subsection 1, and **section 285.10, subsection 9**, or used
22 exclusively for the transportation of children enrolled in a
23 federal head start program. Upon application the department
24 shall, without charge, issue a registration certificate and
25 registration ~~plates~~ plate. The ~~plates~~ plate shall be attached
26 to the ~~front and~~ rear of each bus exempt from registration
27 under **this subsection**.

28 Sec. 3. Section 321.19, subsection 1, paragraph c, Code
29 2020, is amended to read as follows:

30 *c.* However, the director of the department of administrative
31 services or the director of transportation may order the
32 issuance of a regular registration ~~plates~~ plate for any
33 exempted vehicle used by any of the following:

34 (1) Peace officers or federal law enforcement officers in
35 the enforcement of the law.

1 (2) Persons enforcing chapter 124 and other laws relating to
2 controlled substances.

3 (3) Persons in the department of justice, the alcoholic
4 beverages division of the department of commerce, disease
5 investigators of the Iowa department of public health, the
6 department of inspections and appeals, and the department of
7 revenue, who are regularly assigned to conduct investigations
8 which cannot reasonably be conducted with a vehicle displaying
9 an "official" state registration plates plate.

10 (4) Persons who are federal agents or officers regularly
11 assigned to conduct investigations which cannot reasonably be
12 conducted with a vehicle displaying an "official" registration
13 plates plate.

14 (5) Persons in the Iowa lottery authority whose regularly
15 assigned duties relating to security or the carrying of
16 lottery tickets cannot reasonably be conducted with a vehicle
17 displaying an "official" registration plates plate.

18 (6) Persons in the economic development authority
19 who are regularly assigned duties relating to existing
20 industry expansion or business attraction, and mental health
21 professionals or health care professionals who provide off-site
22 or in-home medical or mental health services to clients of
23 publicly funded programs.

24 Sec. 4. Section 321.20B, subsection 4, paragraph a,
25 subparagraph (3), unnumbered paragraph 1, Code 2020, is amended
26 to read as follows:

27 Issue a citation and remove the motor vehicle's license
28 plates plate and registration receipt.

29 Sec. 5. Section 321.20B, subsection 4, paragraph a,
30 subparagraph (3), subparagraph division (a), Code 2020, is
31 amended to read as follows:

32 (a) Upon removing the license plates plate and registration
33 receipt, the peace officer shall deliver the plates plate for
34 destruction, as appropriate, and forward the registration
35 receipt and evidence of the violation, as determined by the

1 department, to the county treasurer of the county in which the
2 motor vehicle is registered.

3 Sec. 6. Section 321.20B, subsection 4, paragraph a,
4 subparagraph (4), subparagraph division (a), Code 2020, is
5 amended to read as follows:

6 (a) Issue a citation, remove the motor vehicle's license
7 ~~plates~~ plate and registration receipt, and impound the motor
8 vehicle. The peace officer shall deliver the ~~plates~~ plate
9 for destruction, as appropriate, and forward the registration
10 receipt and evidence of the violation, as determined by the
11 department, to the county treasurer of the county in which the
12 motor vehicle is registered.

13 Sec. 7. Section 321.20B, subsection 4, paragraph b,
14 subparagraph (1), subparagraph divisions (a) and (b), Code
15 2020, are amended to read as follows:

16 (a) If the person was cited pursuant to paragraph "a",
17 subparagraph (3), the owner or driver shall provide a copy of
18 the receipt to the county treasurer of the county in which the
19 motor vehicle is registered and the owner shall be assessed a
20 fifteen dollar administrative fee by the county treasurer who
21 shall issue a new license ~~plates~~ plate and registration to the
22 person after payment of the fee.

23 (b) If the person was cited pursuant to paragraph "a",
24 subparagraph (4), the owner or driver, after the owner
25 provides proof of financial liability coverage to the clerk
26 of court, may claim the motor vehicle after such person pays
27 any applicable fine and the costs of towing and storage for
28 the motor vehicle, and the owner or driver provides a copy
29 of the receipt and the owner pays to the county treasurer of
30 the county in which the motor vehicle is registered a fifteen
31 dollar administrative fee, and the county treasurer shall issue
32 a new license ~~plates~~ plate and registration to the person.

33 Sec. 8. Section 321.20B, subsection 4, paragraph b,
34 subparagraph (2), subparagraph divisions (a) and (b), Code
35 2020, are amended to read as follows:

1 (a) Sign an admission of violation on the citation and
2 remit to the clerk of court a scheduled fine as provided in
3 section 805.8A, subsection 14, paragraph "f", for a violation of
4 subsection 1. Upon payment of the fine to the clerk of court of
5 the county where the citation was issued, payment of a fifteen
6 dollar administrative fee to the county treasurer of the
7 county in which the motor vehicle is registered, and providing
8 proof of payment of any applicable fine and proof of financial
9 liability coverages to the county treasurer of the county in
10 which the motor vehicle is registered, the treasurer shall
11 issue a new license plates plate and registration to the owner.

12 (b) Request an appearance before the court on the matter.
13 If the matter goes before the court, and the owner or driver
14 is found guilty of a violation of [subsection 1](#), the court
15 may impose a fine as provided in section 805.8A, subsection
16 14, paragraph "f", for a violation of [subsection 1](#), or the
17 court may order the person to perform unpaid community
18 service instead of the fine. Upon the payment of the fine
19 or the entry of the order for unpaid community service, the
20 person shall provide proof of payment or entry of such order
21 and the county treasurer of the county in which the motor
22 vehicle is registered shall issue a new license plates plate
23 and registration to the owner upon the owner providing proof
24 of financial liability coverage and paying a fifteen dollar
25 administrative fee to the county treasurer.

26 Sec. 9. Section 321.22, subsection 1, Code 2020, is amended
27 to read as follows:

28 1. An urban transit company or system having a franchise
29 to operate in any city and any regional transit system may
30 make application to the department, upon forms furnished by
31 the department, for a certificate containing a distinguishing
32 number and for one or more ~~pairs of~~ registration plates to be
33 attached to the ~~front and~~ rear of buses owned or operated by
34 the transit company or system.

35 Sec. 10. Section 321.23, subsection 3, Code 2020, is amended

1 to read as follows:

2 3. In the event an applicant for registration of a foreign
3 vehicle for which a certificate of title has been issued is
4 able to furnish evidence of being the registered owner of the
5 vehicle to the county treasurer of the owner's residence,
6 although unable to surrender such certificate of title,
7 the county treasurer may issue a registration receipt and
8 ~~plates~~ plate upon receipt of the required annual registration
9 fee and the fee for new registration but shall not issue a
10 certificate of title ~~thereto~~ for the vehicle. Upon surrender
11 of the certificate of title from the foreign state, the county
12 treasurer shall issue a certificate of title to the owner, of
13 the vehicle or other person entitled ~~thereto~~, ~~of such vehicle~~
14 to the certificate of title as provided in [this chapter](#). The
15 owner of a vehicle registered under [this subsection](#) shall not
16 be required to obtain a certificate of title in this state and
17 may transfer ownership of the vehicle to a motor vehicle dealer
18 licensed under [chapter 322](#) if, at the time of the transfer,
19 the certificate of title is held by a secured party and the
20 dealer has forwarded to the secured party the sum necessary to
21 discharge the security interest pursuant to section 321.48,
22 subsection 1.

23 Sec. 11. Section 321.25, subsection 1, Code 2020, is amended
24 to read as follows:

25 1. A vehicle may be operated upon the highways of this state
26 without a registration ~~plates~~ plate for a period of forty-five
27 days after the date of delivery of the vehicle to the purchaser
28 from a dealer if a card bearing the words "registration applied
29 for" is attached on the rear of the vehicle. The card shall
30 have plainly stamped or stenciled the registration number of
31 the dealer from whom the vehicle was purchased and the date
32 of delivery of the vehicle. In addition, a dealer licensed
33 to sell new motor vehicles may attach the card to a new motor
34 vehicle delivered by the dealer to the purchaser even if the
35 vehicle was purchased from an out-of-state dealer and the card

1 shall bear the registration number of the dealer that delivered
2 the vehicle. A dealer shall not issue a card to a person known
3 to the dealer to be in possession of a registration plates
4 plate which may be attached to the vehicle. A dealer shall
5 not issue a card unless an application for registration and
6 certificate of title has been made by the purchaser and a
7 receipt issued to the purchaser of the vehicle showing the fee
8 paid by the person making the application. Dealers' records
9 shall indicate the agency to which the fee is sent and the date
10 the fee is sent. The dealer shall forward the application by
11 the purchaser to the county treasurer or state office within
12 thirty calendar days from the date of delivery of the vehicle.
13 However, if the vehicle is subject to a security interest
14 and has been offered for sale pursuant to section 321.48,
15 subsection 1, the dealer shall forward the application by the
16 purchaser to the county treasurer or state office within thirty
17 calendar days from the date of the delivery of the vehicle to
18 the purchaser.

19 Sec. 12. Section 321.26, subsection 2, Code 2020, is amended
20 to read as follows:

21 2. The county treasurer may adjust the renewal or expiration
22 date of vehicles when deemed necessary to equalize the number
23 of vehicles registered in each twelve-month period or for the
24 administrative efficiency of the county treasurer's office.
25 The adjustment shall be accomplished by delivery of a written
26 notice to the vehicle owner of the adjustment and allowance of
27 a credit for the remaining months of the unused portion of the
28 annual registration fee, rounded to the nearest whole dollar,
29 which amount shall be deducted from the annual registration
30 fee due at the time of registration. Upon receipt of the
31 notification the owner shall, within thirty days, surrender the
32 registration card and registration ~~plates~~ plate to the county
33 treasurer of the county where the vehicle is registered, except
34 that the registration ~~plates~~ plate shall not be surrendered
35 if a validation stickers sticker or other ~~emblems~~ emblem

1 is used to designate the month and year of expiration of
2 registration. Upon payment of the annual registration fee,
3 less the credit allowed for the remaining months of the
4 unused portion of the annual registration fee, the county
5 treasurer shall issue a new registration card and registration
6 ~~plates~~ plate, validation ~~stickers~~ sticker, or ~~emblems~~ emblem
7 which ~~indicate~~ indicates the month and year of expiration of
8 registration.

9 Sec. 13. Section 321.34, subsections 1, 2, and 3, Code 2020,
10 are amended to read as follows:

11 1. *Plates* Plate issued. The county treasurer upon receiving
12 application, accompanied by proper fee, for registration of a
13 vehicle shall issue to the owner one registration plate ~~for~~
14 ~~a motorcycle, motorized bicycle, autocycle, truck tractor,~~
15 ~~trailer, or semitrailer and two registration plates for every~~
16 ~~other motor vehicle~~. The registration ~~plates~~ plate, including
17 any special registration ~~plates~~ plate, shall be assigned
18 to the owner of a vehicle. When the owner of a registered
19 vehicle transfers or assigns ownership of the vehicle to
20 another person, the owner shall remove the registration ~~plates~~
21 plate from the vehicle. The owner shall forward the ~~plates~~
22 plate to the county treasurer where the vehicle is registered
23 or the owner may have the ~~plates~~ plate assigned to another
24 vehicle within thirty days after transfer, upon payment of the
25 fees required by law. The owner shall immediately affix the
26 registration ~~plates~~ plate retained by the owner to another
27 vehicle owned or acquired by the owner, providing the owner
28 complies with [section 321.46](#). The department shall adopt rules
29 providing for the assignment of a registration ~~plates~~ plate to
30 the transferee of a vehicle for which a credit is allowed under
31 section 321.46, subsection 6.

32 2. *Validation stickers*.

33 a. In lieu of issuing a new registration ~~plates~~ plate
34 each registration year for a vehicle renewing registration,
35 the department may reassign the registration ~~plates~~ plate

1 previously issued to the vehicle and may adopt and prescribe
2 an annual validation sticker indicating payment of annual
3 registration fees. The department shall issue one validation
4 sticker for each ~~set of registration plates~~ plate. The
5 sticker shall specify the month and year of expiration of the
6 registration ~~plates~~ plate. The sticker shall be displayed
7 ~~only on the rear registration plate, except that the sticker~~
8 ~~shall be displayed on the front registration plate of a truck~~
9 ~~tractor.~~

10 *b.* The state department of transportation shall adopt rules
11 to provide for the placement of the motor vehicle registration
12 validation sticker.

13 3. *Radio operators plates.* The owner of an automobile,
14 motorcycle, trailer, or motor truck who holds an amateur radio
15 license issued by the federal communications commission may,
16 upon written application to the county treasurer accompanied
17 by a fee of five dollars, order a special registration plates
18 plate bearing the call letters authorized the radio station
19 covered by the person's amateur radio license. When received
20 by the county treasurer, such special registration ~~plates~~
21 plate shall be issued to the applicant in exchange for the
22 registration ~~plates~~ plate previously issued to the person. Not
23 more than one ~~set of special registration plates~~ plate may be
24 issued to an applicant. Said fee shall be in addition to and
25 not in lieu of the fee for a regular registration plates plate.
26 ~~Special~~ A special registration ~~plates~~ plate must be surrendered
27 upon expiration of the owner's amateur radio license and the
28 owner shall thereupon be entitled to the owner's regular
29 registration ~~plates~~ plate. The county treasurer shall validate
30 special plates in the same manner as regular registration
31 plates, upon payment of five dollars in addition to the regular
32 annual registration fee.

33 Sec. 14. Section 321.34, subsection 5, paragraph a, Code
34 2020, is amended to read as follows:

35 *a.* Upon application and the payment of a fee of twenty-five

1 dollars, the director may issue to the owner of a motor
2 vehicle registered in this state or a trailer or travel trailer
3 registered in this state, a personalized registration plates
4 plate marked with up to seven initials, letters, or combination
5 of numerals and letters requested by the owner. However,
6 personalized registration plates for autocycles, motorcycles,
7 and motorized bicycles shall be marked with no more than six
8 initials, letters, or combinations of numerals and letters.
9 Upon receipt of the personalized registration plates plate,
10 the applicant shall surrender the regular registration plates
11 plate to the county treasurer. The fee for issuance of the
12 personalized registration plates plate shall be in addition to
13 the regular annual registration fee.

14 Sec. 15. Section 321.34, subsection 6, Code 2020, is amended
15 to read as follows:

16 6. *Sample vehicle registration plates.* ~~Vehicle~~ A vehicle
17 registration plates plate displaying the general design of
18 a regular registration plates plate, with the word "sample"
19 displayed on the plate, may be furnished to any person upon
20 payment of a fee of three dollars, except that such plates may
21 be furnished to governmental agencies without cost. ~~Sample~~ A
22 sample registration plates plate shall not be attached to a
23 vehicle moved on the highways of this state.

24 Sec. 16. Section 321.34, subsection 7, paragraphs a and e,
25 Code 2020, are amended to read as follows:

26 a. Upon application and payment of the proper fees, the
27 director may issue to the owner of a motor vehicle subject
28 to registration under [section 321.109, subsection 1](#), motor
29 truck, motor home, multipurpose vehicle, trailer over two
30 thousand pounds, or travel trailer registered in this state, a
31 collegiate registration plates plate created pursuant to this
32 subsection. Upon receipt of the collegiate registration plates
33 plate, the applicant shall surrender the regular registration
34 plates plate to the county treasurer.

35 e. A collegiate registration plate shall not be issued if

1 its combination of alphanumeric characters are identical to
2 those contained on a current personalized registration plate
3 issued under [subsection 5](#). However, the owner of a motor
4 vehicle who has a personalized registration plate issued for
5 the motor vehicle may, after proper application and payment
6 of fees, be issued a collegiate registration plate containing
7 the same alphanumeric characters as those on the personalized
8 plate. Upon receipt of the collegiate registration ~~plates~~
9 plate, the owner shall surrender the personalized registration
10 ~~plates~~ plate to the county treasurer.

11 Sec. 17. Section 321.34, subsection 7A, paragraphs b and c,
12 Code 2020, are amended to read as follows:

13 *b.* Upon application and payment of the proper fees, the
14 director may issue to the owner of a motor vehicle subject
15 to registration under [section 321.109, subsection 1](#), motor
16 truck, motor home, multipurpose vehicle, trailer over two
17 thousand pounds, or travel trailer registered in this state,
18 a collegiate registration ~~plates~~ plate created pursuant to
19 this subsection. The fee for the issuance of a collegiate
20 registration ~~plates~~ plate is twenty-five dollars, which fee
21 is in addition to the regular annual registration fee for the
22 vehicle. An applicant may obtain a personalized collegiate
23 registration plate upon payment of the additional fee for a
24 personalized plate as provided in [subsection 5](#) in addition to
25 the collegiate plate fee and the regular registration fee. The
26 county treasurer shall validate collegiate registration plates
27 issued under [this subsection](#) in the same manner as regular
28 registration plates, upon payment of five dollars in addition
29 to the regular annual registration fee. Upon receipt of the
30 collegiate registration ~~plates~~ plate, the applicant shall
31 surrender the regular registration ~~plates~~ plate to the county
32 treasurer.

33 *c.* A personalized collegiate registration plate shall
34 not be issued if its combination of alphanumeric characters
35 are identical to those contained on a current personalized

1 registration plate issued under [subsection 5](#). However, the
 2 owner of a motor vehicle who has a personalized registration
 3 plate issued for the motor vehicle may, after proper
 4 application and payment of fees, be issued a collegiate
 5 registration plate containing the same alphanumeric characters
 6 as those on the personalized plate. Upon receipt of the
 7 collegiate registration ~~plates~~ plate, the owner shall surrender
 8 the personalized registration ~~plates~~ plate to the county
 9 treasurer.

10 Sec. 18. Section 321.34, subsections 8, 8A, and 9, Code
 11 2020, are amended to read as follows:

12 8. *Medal of honor plates.*

13 a. The owner of a motor vehicle subject to registration
 14 under [section 321.109, subsection 1](#), autocycle, motorcycle,
 15 trailer, or motor truck who has been awarded the medal of
 16 honor may, upon written application to the department, order a
 17 special registration ~~plates~~ plate which shall be red, white,
 18 and blue in color and shall bear an emblem of the medal of
 19 honor and an identifying number. Each applicant applying for
 20 a special registration ~~plates~~ plate under [this subsection](#) may
 21 order only one ~~set of~~ registration ~~plates~~ plate under this
 22 subsection. The application is subject to approval by the
 23 department and the special registration ~~plates~~ plate shall
 24 be issued at no charge to the applicant in exchange for the
 25 registration ~~plates~~ plate previously issued to the person.
 26 A person who is issued a special ~~plates~~ plate under this
 27 subsection is exempt from payment of any annual registration
 28 fee for the motor vehicle bearing the special ~~plates~~ plate.
 29 The department shall validate the special plates in the same
 30 manner as regular registration plates are validated under this
 31 section. The department shall not issue special registration
 32 plates until service organizations in the state have furnished
 33 the department either the special dies or the cost of the
 34 special dies necessary for the manufacture of the special
 35 registration plate.

1 **b.** The surviving spouse of a person who was issued a special
 2 ~~plates~~ plate under this subsection may continue to use the
 3 special ~~plates~~ plate subject to registration of the special
 4 ~~plates~~ plate in the surviving spouse's name. If the surviving
 5 spouse remarries, the surviving spouse shall return the special
 6 ~~plates~~ plate to the department and the department shall issue a
 7 regular registration ~~plates~~ plate to the surviving spouse.

8 **8A. Ex-prisoner of war special plates.**

9 **a.** The owner of a motor vehicle subject to registration
 10 under section 321.109, subsection 1, autocycle, motorcycle,
 11 trailer, or motor truck who was a prisoner of war during a
 12 time of military conflict may, upon written application to
 13 the department, order only one ~~set of~~ special registration
 14 ~~plates~~ plate with an ex-prisoner of war processed emblem. The
 15 emblem shall be designed by the department in cooperation
 16 with the adjutant general and shall signify that the owner
 17 was a prisoner of war as described in this subsection. The
 18 application is subject to approval by the department, in
 19 consultation with the adjutant general. The special ~~plates~~
 20 plate shall be issued at no charge and ~~are~~ is subject to
 21 an annual registration fee of fifteen dollars. The county
 22 treasurer shall validate the special plates in the same
 23 manner as regular registration plates are validated under this
 24 section.

25 **b.** The surviving spouse of a person who was issued a special
 26 ~~plates~~ plate under this subsection may continue to use or apply
 27 for and use the special ~~plates~~ plate subject to registration
 28 of the special ~~plates~~ plate in the surviving spouse's name and
 29 upon payment of the annual registration fee. If the surviving
 30 spouse remarries, the surviving spouse shall return the special
 31 ~~plates~~ plate to the department and the department shall issue a
 32 regular registration ~~plates~~ plate to the surviving spouse.

33 **9. Leased vehicles. Registration plates** A registration
 34 plate under this section, including a disabled veteran ~~plates~~
 35 plate specified in section 321.105, may be issued to the lessee

1 of a motor vehicle if the lessee provides evidence of a lease
2 for a period of more than sixty days and if the lessee complies
3 with the requirements, under [this section](#), for issuance of the
4 specific registration ~~plates~~ plate.

5 Sec. 19. Section 321.34, subsection 10, paragraphs a, b, and
6 d, Code 2020, are amended to read as follows:

7 a. An owner referred to in [subsection 12](#) who is a current
8 or retired member of a paid or volunteer fire department may,
9 upon written application to the department, order a special
10 registration ~~plates~~ plate, designed by the department in
11 cooperation with representatives designated by the Iowa fire
12 fighters' associations, which signify that the applicant
13 is a current or retired member of a paid or volunteer fire
14 department.

15 b. The application shall be approved by the department in
16 consultation with representatives designated by the Iowa fire
17 fighters' associations, and the special registration ~~plates~~
18 plate shall be issued to the applicant in exchange for the
19 registration ~~plates~~ plate previously issued to the person. An
20 applicant who is the owner of a business-trade truck or special
21 truck shall not be issued a special fire fighter registration
22 ~~plates~~ plate for more than one vehicle. The fee for the
23 special ~~plates~~ plate is twenty-five dollars which shall be
24 paid in addition to the regular annual registration fee. The
25 department shall validate the special plates in the same manner
26 as regular registration plates are validated under [this section](#)
27 at the regular annual registration fee.

28 d. For purposes of [this subsection](#), a person is considered
29 to be retired if the person is recognized by the chief of the
30 fire department where the individual served, and on record,
31 as officially retired from the fire department. ~~Special A~~
32 special registration ~~plates~~ plate with a fire fighter emblem
33 shall be surrendered, as provided in [subsection 12](#), in exchange
34 for a regular registration ~~plates~~ plate upon termination of
35 the motor vehicle owner's membership in the paid or volunteer

1 fire department, unless the person is a retired member in good
2 standing.

3 Sec. 20. Section 321.34, subsection 10A, paragraph a, Code
4 2020, is amended to read as follows:

5 a. The owner of a motor vehicle referred to in subsection
6 12 who is a current member of a paid or volunteer emergency
7 medical services agency may, upon written application to
8 the department, order a special registration plates plate,
9 designed by the department in cooperation with representatives
10 designated by the Iowa emergency medical services association,
11 which ~~plates signify~~ signifies that the applicant is a current
12 member of a paid or volunteer emergency medical services
13 agency. The application shall be approved by the department,
14 in consultation with representatives designated by the Iowa
15 emergency medical services association, and the special
16 registration ~~plates~~ plate shall be issued to the applicant
17 in exchange for the registration ~~plates~~ plate previously
18 issued to the person. The fee for the special ~~plates~~ plate is
