A BILL FOR

- 1 An Act relating to the prohibition of social media censorship
- and suppression of religious and political speech.
- 3 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

H.F. 317

- 1 Section 1. NEW SECTION. 686.1 Definitions.
- 2 As used in this chapter, unless the context otherwise
- 3 requires:
- 4 1. "Algorithm" means a set of instructions designed to
- 5 perform a specific task.
- 6 2. "Hate speech" means content that a person arbitrarily
- 7 finds offensive based on the person's personal moral code.
- 8 3. "Obscene" means content that to the average person, when
- 9 applying contemporary community standards, taken as a whole
- 10 appeals to prurient interests, and lacks serious literary,
- 11 artistic, political, or scientific value.
- 12 4. "Political speech" means speech relating to the state,
- 13 government, body politic, public administration, or government
- 14 policymaking, including speech relating to social issues.
- 15 "Political speech" does not include speech concerning the
- 16 administration of or the law relating to the civil aspects of
- 17 government.
- 18 5. "Social media internet site" means an internet site or
- 19 application that enables users to communicate with each other
- 20 by posting information, comments, messages, or images and meets
- 21 all of the following criteria:
- 22 a. Is open to the public.
- 23 b. Has more than seventy-five million users.
- 24 c. Has not been specifically affiliated with any one
- 25 religion or political party from its inception.
- 26 Sec. 2. NEW SECTION. 686.2 Civil action.
- 27 A social media internet site user may bring a civil action
- 28 against the owner or operator of a social media internet site
- 29 with users in this state if the social media internet site
- 30 purposely does any of the following:
- 31 l. Censors a social media internet site user's religious or
- 32 political speech.
- Uses an algorithm to suppress a social media internet
- 34 site user's religious or political speech.
- 35 Sec. 3. NEW SECTION. 686.3 Damages.

H.F. 317

- 1 A social media internet site user may be awarded damages
- 2 under section 686.2, including civil damages of seventy-five
- 3 thousand dollars for each purposeful censoring or suppression
- 4 of the social media user's speech, actual damages, forms of
- 5 equitable relief, and attorney fees.
- 6 Sec. 4. NEW SECTION. 686.4 Hate speech not a defense.
- 7 It is not a defense to a civil action under section 686.2
- 8 that the social media internet site user's speech was hate
- 9 speech.
- 10 Sec. 5. NEW SECTION. 686.5 Defenses.
- 11 A social media internet site shall not be found liable under
- 12 section 686.2 if the censored speech calls for immediate acts
- 13 of violence, is obscene or pornographic in nature, was censored
- 14 as a result of operational error, was censored as a result of
- 15 a court order, came from an inauthentic source or involved
- 16 false impersonation, enticed criminal conduct, involved minors
- 17 bullying minors, or if the speech was censored by another
- 18 social media internet site user.
- 19 Sec. 6. NEW SECTION. 686.6 Standing eighteen years of
- 20 age or older.
- Only social media internet site users eighteen years of age
- 22 or older have standing to enforce this chapter.
- 23 Sec. 7. NEW SECTION. 686.7 Attorney general may enforce.
- 24 The attorney general may bring a civil action under section
- 25 686.2 on behalf of a social media internet user who resides
- 26 in this state whose religious or political speech has been
- 27 censored by a social media internet site.
- 28 Sec. 8. NEW SECTION. 686.8 Venue.
- 29 The venue for any civil action brought under section 686.2
- 30 shall be in this state.
- 31 EXPLANATION
- 32 The inclusion of this explanation does not constitute agreement with
- 33 the explanation's substance by the members of the general assembly.
- 34 This bill relates to the prohibition of social media
- 35 censorship and suppression of religious and political speech.

H.F. 317

1 The bill creates a new Code chapter. The bill provides that 2 a social media internet site user may bring a civil action 3 against the owner or operator of a social media internet site 4 with users in this state if the social media internet site 5 purposely censors a social media internet site user's religious 6 or political speech or uses an algorithm to suppress the social 7 media internet site user's religious or political speech. 8 bill provides for damages up to \$75,000 for each purposeful 9 act of censorship or suppression, as well as actual damages, 10 equitable relief, and attorney fees. The bill sets forth what 11 a social media internet site may use as a defense and what 12 a social media internet site may not use as a defense for 13 censorship or suppression. The bill provides that the Code 14 chapter may be enforced by a social media internet site user 15 who is 18 years old or older or by the attorney general. 16 bill provides that venue is in the state of Iowa.
