      Section 1. Section 481A.67, Code 2019, is amended to read
 2 as follows:
      481A.67 Seasons and limits - turtle harvesting restrictions.

          It is unlawful for a person, except as otherwise
 5 expressly provided, to take, capture, or kill fish, frogs,
 6 or turtles except during the open season established by the
 7 commission. It is unlawful during open season to take in any
 8 one day an amount in excess of the daily catch limit designated
 9 for each variety or each locality, or have in possession any
10 variety of fish, frog, or turtle in excess of the possession
11 limit, or have in possession any frog, fish, or turtle at any
12 time under the minimum length or weight. The open season,
13 possession limit, daily catch limit, and the minimum length
14 or weight for each variety of fish, frog, or turtle shall be
15 established by rule of the department or commission under the
16 authority of sections 456A.24, 481A.38, 481A.39, and 482.1.

      2. Notwithstanding any provision of law to the contrary,
18 the natural resource commission shall adopt rules pursuant to
19 chapter 17A establishing seasons and daily catch limits for the
20 noncommercial harvest of turtles in any waters of the state
21 pursuant to section 483A.28. Seasons established pursuant to
22 this subsection shall not apply to the noncommercial harvest of
23 snapping turtles.

      3. Notwithstanding any provision of law to the contrary,
25 the natural resource commission shall adopt rules pursuant to
26 chapter 17A establishing seasons and daily catch limits for the
27 commercial harvest of turtles in any waters of the state.
      2. There shall be a continuous open season for turtle

          3. Beginning no later than January 1, 2017, and ending

32 review of the status of the turtle population in the state by

1 on whether restrictions on noncommercial and commercial turtle
2 harvesting in the state should be revised no later than June
3 30, 2021. This subsection is repealed effective July 1, 2021.

6 the explanation's substance by the members of the general assembly.
7 Current law allows the natural resource commission to adopt
8 rules to establish turtle harvesting seasons. This bill
9 creates a continuous open season for turtle harvesting.
