**A BILL FOR**

1 An Act relating to and making appropriations to state  
2 departments and agencies from the rebuild Iowa  
3 infrastructure fund and the technology reinvestment fund,  
4 providing for related matters, and including effective date  
5 provisions.

6 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

DIVISION I

REBUILD IOWA INFRASTRUCTURE FUND

Section 1. REBUILD IOWA INFRASTRUCTURE FUND —

4 APPROPRIATIONS. There is appropriated from the rebuild Iowa  
5 infrastructure fund to the following departments and agencies  
6 for the following fiscal years, the following amounts, or so  
7 much thereof as is necessary, to be used for the purposes  
8 designated:

9 1. DEPARTMENT OF ADMINISTRATIVE SERVICES

10 FY 2019-2020:

11 For deposit in the routine maintenance fund created in  
12 section 8A.330:

14 2. DEPARTMENT OF AGRICULTURE AND LAND STEWARDSHIP

15 a. (1) For deposit in the water quality initiative fund  
16 created in [section 466B.45](#) for purposes of supporting the  
17 water quality initiative administered by the division of soil  
18 conservation and water quality as provided in [section 466B.42](#),  
19 including salaries, support, maintenance, and miscellaneous  
20 purposes, notwithstanding [section 8.57, subsection 5](#), paragraph  
21 "c":

24 (2) (a) The moneys appropriated in this lettered  
25 paragraph shall be used to support demonstration projects in  
26 subwatersheds as designated by the department that are part  
27 of high-priority watersheds identified by the water resources  
28 coordinating council.

29 (b) The moneys appropriated in this lettered paragraph  
30 shall be used to support demonstration projects in watersheds  
31 generally, including regional watersheds, as designated by the  
32 division and high-priority watersheds identified by the water  
33 resources coordinating council.

34 (3) In supporting projects in watersheds and subwatersheds  
35 as provided in subparagraph (2), subparagraph divisions (a) and

1 (b), all of the following shall apply:

2 (a) The demonstration projects shall utilize water quality  
3 practices as described in the latest revision of the document  
4 entitled "Iowa Nutrient Reduction Strategy" initially presented  
5 in November 2012 by the department of agriculture and land  
6 stewardship, the department of natural resources, and Iowa  
7 state university of science and technology.

8 (b) The division shall implement demonstration projects  
9 as provided in subparagraph division (a) by providing  
10 for participation by persons who hold a legal interest in  
11 agricultural land used in farming. To every extent practical,  
12 the division shall provide for collaborative participation by  
13 such persons who hold a legal interest in agricultural land  
14 located within the same subwatershed.

15 (c) The division shall implement demonstration projects on  
16 a cost-share basis as determined by the division. Except for  
17 edge-of-field practices, the state's share of the amount shall  
18 not exceed 50 percent of the estimated cost of establishing the  
19 practice as determined by the division or 50 percent of the  
20 actual cost of establishing the practice, whichever is less.

21 (d) The demonstration projects shall be used to educate  
22 other persons about the feasibility and value of establishing  
23 similar water quality practices. The division shall promote  
24 field day events for purposes of allowing interested persons to  
25 establish water quality practices on their agricultural land.

26 (e) The division shall conduct water quality evaluations  
27 within supported subwatersheds. Within a reasonable period  
28 after accumulating information from such evaluations, the  
29 division shall create an aggregated database of water quality  
30 practices. Any information identifying a person holding a  
31 legal interest in agricultural land or specific agricultural  
32 land shall be a confidential record.

33 (4) The moneys appropriated in this lettered paragraph  
34 shall be used to support education and outreach in a manner  
35 that encourages persons who hold a legal interest in

1 agricultural land used for farming to implement water quality  
2 practices, including the establishment of such practices in  
3 watersheds generally, and not limited to subwatersheds or  
4 high-priority watersheds.

5 (5) The moneys appropriated in this lettered paragraph  
6 may be used to contract with persons to coordinate the  
7 implementation of efforts provided in this paragraph.

8 (6) The moneys appropriated in this lettered paragraph  
9 may be used by the department to support urban soil and water  
10 conservation efforts, which may include but are not limited  
11 to management practices related to bioretention, landscaping,  
12 the use of permeable or pervious pavement, and soil quality  
13 restoration. The moneys shall be allocated on a cost-share  
14 basis as provided in [chapter 161A](#).

15 (7) Notwithstanding any other provision of law to the  
16 contrary, the department may use moneys appropriated in  
17 this lettered paragraph to carry out the provisions of this  
18 paragraph on a cost-share basis in combination with other  
19 moneys available to the department from a state or federal  
20 source.

21 (8) Not more than 10 percent of the moneys appropriated in  
22 this lettered paragraph may be used for costs of administration  
23 and implementation of the water quality initiative administered  
24 by the soil conservation division.

25 b. For deposit in the agricultural drainage well water  
26 quality assistance fund created in [section 460.303](#) for  
27 purposes of supporting the agricultural drainage well water  
28 quality assistance program as provided in [section 460.304](#),  
29 notwithstanding [section 8.57, subsection 5](#), paragraph "c":

26 and the department of management on or before January 15 of  
27 each year.

4 MISCELLANEOUS PROVISIONS

7 (2) Until July 1, 1986, the county shall remain responsible  
8 for the compensation of and operating costs for court  
9 employees not presently designated for state financing and  
10 for miscellaneous costs of the judicial branch related to  
11 furnishings, supplies, and equipment purchased, leased, or  
12 maintained for the use of judicial officers, referees, and  
13 their staff. Effective July 1, 1986, the state shall assume  
14 the responsibility for the compensation of and operating costs  
15 for court employees presently designated for state financing  
16 and for miscellaneous costs of the judicial branch related to  
17 furnishings, supplies, and equipment purchased, leased, or  
18 maintained for the use of judicial officers, referees, and  
19 their staff. However, the county shall at all times remain  
20 responsible for the provision of suitable courtrooms, offices,  
21 and other physical facilities pursuant to section 602.1303,  
22 subsection 1, including paint, wall covering, and fixtures in  
23 the facilities. In addition, effective July 1, 2020, if a  
24 county expends moneys for the renovation or construction of  
25 suitable courtrooms, offices, and other physical facilities  
26 pursuant to section 602.1303, that requires the purchase of  
27 furnishings, supplies, and equipment for the use of judicial  
28 officers, referees, and their staff as a result of that  
29 renovation or construction, the cost of the purchase shall not  
30 be the sole responsibility of the state.

31 Sec. 12. STATE HISTORICAL BUILDING TASK FORCE.

32 1. A state historical building task force is established  
33 within the state fair authority. The state fair authority  
34 shall provide administrative support for the task force.

35 2. The task force shall consist of the following members:



- 1 a. One member appointed by the Iowa state fair board.
- 2 b. One member appointed by the Iowa state fair foundation  
3 established in section 173.22.
- 4 c. One member appointed by the director of the department of  
5 administrative services.
- 6 d. One member who is designated by the general assembly as  
7 the facilities manager for facilities under the control of the

- 9 e. One member appointed by the director of the department of

- 11 f. One member appointed by the governor.
- 12 g. Four members of the general assembly serving as ex  
13 officio, nonvoting members, with one representative to be  
14 appointed by the speaker of the house of representatives, one  
15 representative to be appointed by the minority leader of the  
16 house of representatives, one senator to be appointed by the  
17 majority leader of the senate, and one senator to be appointed  
18 by the minority leader of the senate.

32 Sec. 13. NEW SECTION. 15.261 Vacant state buildings  
33 demolition fund.

34 1. A vacant state buildings demolition fund is created in  
35 the state treasury under the control of the authority. The

1 fund shall consist of all moneys appropriated to the fund.

2 2. Moneys in the vacant state buildings demolition fund are  
3 appropriated to the authority for purposes of funding a grant  
4 program for the demolition of vacant buildings owned by the  
5 state which are no longer used for a state purpose.

14 1. A vacant state buildings rehabilitation fund is created  
15 in the state treasury under the control of the authority. The  
16 fund shall consist of all moneys appropriated to the fund.

17 2. Moneys in the vacant state buildings rehabilitation fund  
18 are appropriated to the authority for purposes of funding a  
19 loan program for the rehabilitation or redevelopment of vacant  
20 buildings owned by the state which are no longer used for a  
21 state purpose.

22 3. Notwithstanding section 12C.7, subsection 2, interest  
23 or earnings on moneys deposited in the vacant state buildings  
24 rehabilitation fund shall be credited to the vacant state

29 The inclusion of this explanation does not constitute agreement with  
30 the explanation's substance by the members of the general assembly.

31 This bill relates to and makes appropriations to state  
32 departments and agencies from the rebuild Iowa infrastructure  
33 fund and the technology reinvestment fund, and provides for  
34 related matters. The bill is organized by divisions.

35 DIVISION I — REBUILD IOWA INFRASTRUCTURE FUND. This

1 division appropriates project funding for FY 2019-2020 from  
2 the rebuild Iowa infrastructure fund for projects for the  
3 departments of administrative services, agriculture and land  
4 stewardship, corrections, cultural affairs, human services,  
5 natural resources, public defense, public safety, and  
6 transportation, and for the office of the chief information  
7 officer, the board of regents, the treasurer of state,  
8 Iowa veterans home, and the judicial branch. The division  
9 appropriates project funding for FY 2019-2020 and FY 2020-2021  
10 from the rebuild Iowa infrastructure fund for projects for the  
11 state fair authority and appropriates project funding from the  
12 rebuild Iowa infrastructure fund for multiple fiscal years to  
13 the economic development authority.

14 DIVISION II — TECHNOLOGY REINVESTMENT FUND. This division  
15 appropriates project funding for FY 2019-2020 from the  
16 technology reinvestment fund for the departments of education,  
17 homeland security and emergency management, human rights, human  
18 services, management, public health, public safety and veterans  
19 affairs, and for the office of the chief information officer,  
20 the Iowa law enforcement academy, and state public defender.

21 DIVISION III — CHANGES TO PRIOR APPROPRIATIONS. This  
22 division makes a change to the reversion provision for moneys  
23 appropriated to the department of natural resources from the  
24 rebuild Iowa infrastructure fund in FY 2014-2015. The division  
25 also makes a change to the reversion provision for moneys  
26 appropriated from the rebuild Iowa infrastructure fund to  
27 the department of administrative services for the costs of  
28 major maintenance of monuments in FY 2016-2017. The division  
29 makes changes to moneys appropriated to the department of  
30 administrative services for major maintenance projects from  
31 the rebuild Iowa infrastructure fund in FY 2018-2019 and FY  
32 2019-2020 by eliminating the priority to projects for repair of  
33 the roof of the state historical building. The division of the  
34 bill takes effect upon enactment.

35 DIVISION IV — DEPARTMENT OF ADMINISTRATIVE SERVICES.

1 Code section 8A.321 is amended to require the director of  
2 the department of administrative services to prepare an  
3 annual report of vacant state buildings and to submit the  
4 report to the legislative services agency and the department  
5 of management on or before January 15 of each year. Code  
6 section 8A.330, concerning the routine maintenance fund under  
7 the control of the department of administrative services, is  
8 amended to provide that moneys in the fund may be appropriated  
9 for routine maintenance projects for state buildings and  
10 facilities and not just physical properties under the control  
11 of the department.

12 DIVISION V — MISCELLANEOUS PROVISIONS. Code section  
13 602.11101, concerning responsibility for county courthouses  
14 and attendant costs, is amended to provide that, effective  
15 July 1, 2020, if a county expends moneys for the renovation  
16 or construction of suitable courtrooms, offices, and other  
17 physical facilities that requires the purchase of furnishings,  
18 supplies, and equipment as a result of that renovation or  
19 construction, the state shall not be solely responsible for the  
20 cost of the purchase.

21 The bill also establishes a state historical building task  
22 force within the state fair authority. The bill provides for  
23 membership on the task force and directs the task force to  
24 consider the feasibility, costs, and possible options relative  
25 to construction of a new state historical building museum on  
26 the state fairgrounds, to include options for relocating the  
27 collections stored in the current state historical building,  
28 and to create increased access to the collections to Iowans.  
29 The bill requires the task force to submit an interim report  
30 to the general assembly by December 20, 2019, and to submit a  
31 final report, including its findings and recommendations, to  
32 the general assembly by January 1, 2021.

33 DIVISION VI — VACANT STATE BUILDINGS — FUNDS. The bill  
34 creates a vacant state buildings demolition fund in the  
35 state treasury under the control of the economic development

1 authority. Moneys in the vacant state buildings demolition  
2 fund shall be appropriated to the authority and used for  
3 purposes of funding a grant program for the demolition of  
4 buildings owned by the state which are vacant and no longer  
5 used for a state purpose.

6 The bill also creates a vacant state buildings  
7 rehabilitation fund in the state treasury under the control of  
8 the economic development authority. Moneys in the vacant state  
9 buildings rehabilitation fund shall be appropriated to the  
10 authority and used for purposes of funding a loan program for  
11 the rehabilitation or redevelopment of buildings owned by the  
12 state which are vacant and no longer used for a state purpose.
