A BILL FOR

- 1 An Act relating to the criminal offense of lascivious conduct
- with a minor, and providing penalties.
- 3 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

- 1 Section 1. Section 709.14, Code 2019, is amended by striking
- 2 the section and inserting in lieu thereof the following:
- 3 709.14 Lascivious conduct with a minor.
- 4 l. a. It is unlawful for a person eighteen years of age
- 5 or older who is in a position of authority over a minor to
- 6 force, persuade, or coerce a minor, with or without consent,
- 7 to disrobe or partially disrobe for the purpose of arousing or
- 8 satisfying the sexual desires of either of them.
- 9 b. A violation of this subsection is a serious misdemeanor.
- 2. For purposes of subsections 3 and 4, "minor" means a
- 11 person fourteen or fifteen years of age.
- 12 3. a. It is unlawful for a person eighteen years of age
- 13 or older who is in a position of authority over a minor to
- 14 perform any of the following acts with a minor, with or without
- 15 consent, for the purpose of arousing or satisfying the sexual
- 16 desires of either of them:
- 17 (1) Fondle or touch the inner thigh, groin, buttock, anus,
- 18 or breast of the minor.
- 19 (2) Touch the clothing covering the immediate area of the
- 20 inner thigh, groin, buttock, anus, or breast of the minor.
- 21 (3) Solicit or permit the minor to fondle or touch the inner
- 22 thigh, groin, buttock, anus, or breast of the person.
- 23 (4) Solicit the minor to engage in any act prohibited under
- 24 subsection 4, paragraph "a", subparagraph (1), (2), or (3).
- 25 b. A violation of this subsection is a serious misdemeanor.
- 26 4. a. It is unlawful for a person eighteen years of age
- 27 or older who is in a position of authority over a minor to
- 28 perform any of the following acts with a minor, with or without
- 29 consent, for the purpose of arousing or satisfying the sexual
- 30 desires of either of them:
- 31 (1) Fondle or touch the pubes or genitals of the minor.
- 32 (2) Permit or cause the minor to fondle or touch the
- 33 person's genitals or pubes.
- 34 (3) Cause the touching of the person's genitals to any part
- 35 of the body of the minor.

- 1 (4) Solicit the minor to engage in a sex act or solicit a 2 person to arrange a sex act with the minor.
- 3 (5) Inflict pain or discomfort upon the minor or permit the 4 minor to inflict pain or discomfort on the person.
- 5 b. A violation of this subsection is an aggravated 6 misdemeanor.

7 EXPLANATION

- 8 The inclusion of this explanation does not constitute agreement with 9 the explanation's substance by the members of the general assembly.
- 10 This bill relates to the criminal offense of lascivious 11 conduct with a minor or child.
- 12 The bill defines "minor" to mean a person fourteen or fifteen 13 years of age.
- 14 Under the bill, a person commits lascivious conduct with a
- 15 minor when a person over 18 years of age who is in a position of
- 16 authority over a minor performs any of the following acts with
- 17 a minor, with or without consent, for the purpose of arousing
- 18 or satisfying the sexual desires of either of them: fondle
- 19 or touch the inner thigh, groin, buttock, anus, or breast of
- 20 the minor; touch the clothing covering the immediate area of
- 21 the inner thigh, groin, buttock, anus, or breast of the minor;
- 22 solicit or permit the minor to fondle or touch the inner thigh,
- 23 groin, buttock, anus, or breast of the person; or solicit the
- 24 minor to engage in certain acts prohibited by the bill in Code
- 25 section 709.14(3)(a)(1),(2), or (3). A person who violates
- 26 this provision commits a serious misdemeanor.
- 27 A person commits lascivious conduct with a minor when a
- 28 person over 18 years of age who is in a position of authority
- 29 over a minor performs any of the following acts with a minor,
- 30 with or without consent, for the purpose of arousing or
- 31 satisfying the sexual desires of either of them: fondle or
- 32 touch the pubes or genitals of the minor; permit or cause
- 33 the minor to fondle or touch the person's genitals or pubes;
- 34 cause the touching of the person's genitals to any part of the
- 35 body of the minor; solicit the minor to engage in a sex act

- 1 or solicit a person to arrange a sex act with the minor; or
- 2 inflict pain or discomfort upon the minor or permit the minor
- 3 to inflict pain or discomfort on the person. A person who
- 4 violates this provision commits an aggravated misdemeanor.
- 5 The bill does not change the current offense of lascivious
- 6 conduct with a minor which makes it unlawful for a person
- 7 over 18 years of age who is in a position of authority over
- 8 any minor, regardless of age, to force, persuade, or coerce a
- 9 minor, with or without consent, to disrobe or partially disrobe
- 10 for the purpose of arousing or satisfying the sexual desires of
- 11 either of them. The current offense is punishable as a serious
- 12 misdemeanor.
- 13 A person who violates the bill must register as a sex
- 14 offender pursuant to Code chapter 692A.
