A BILL FOR

- 1 An Act relating to the jurisdiction and management of pioneer
- 2 cemeteries.
- 3 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

- 1 Section 1. Section 331.325, subsections 1 and 3, Code 2019, 2 are amended to read as follows:
- 3 1. As used in this section, "pioneer cemetery" means a
- 4 cemetery where there have been twelve or fewer burials in the
- 5 preceding fifty years except as provided in subsection 3.
- 6 3. a. In lieu of management of the cemeteries, the
- 7 board of supervisors may create, by ordinance, a cemetery
- 8 commission to assume jurisdiction and management of the pioneer
- 9 cemeteries in the county. The ordinance shall delineate the
- 10 number of commissioners, the appointing authority, the term of
- 11 office, officers, employees, organizational matters, rules of
- 12 procedure, compensation and expenses, and other matters deemed
- 13 pertinent by the board. The board may delegate any power and
- 14 duties relating to cemeteries which that may otherwise be
- 15 exercised by township trustees pursuant to sections 359.28
- 16 through 359.40 to the cemetery commission except the commission
- 17 shall not certify a tax levy pursuant to section 359.30 or
- 18 359.33 and except that the expenses of the cemetery commission
- 19 shall be paid from the county general fund.
- 20 b. The cemetery commission, once created, may continue to
- 21 assume jurisdiction and management of a cemetery that would
- 22 no longer qualify as a pioneer cemetery due to recent burials
- 23 if the cemetery qualified as a pioneer cemetery upon or after
- 24 creation of the cemetery commission. The choice to continue
- 25 retaining jurisdiction and control of a cemetery that no longer
- 26 qualifies as a pioneer cemetery shall be in the sole discretion
- 27 of the cemetery commission.
- 28 c. The board and the cemetery commission, if created
- 29 pursuant to paragraph \tilde{a} , may, by a majority vote of both the
- 30 board and the commission, respectively, amend the definition of
- 31 "pioneer cemetery" in the county to mean a cemetery where there
- 32 have been twenty-four or fewer burials in the preceding fifty
- 33 years.
- 34 Sec. 2. Section 523I.102, subsection 39, Code 2019, is
- 35 amended to read as follows:

1 39. "Pioneer cemetery" means a cemetery where there were 2 twelve or fewer burials in the preceding fifty years except as 3 provided in section 331.325.

4 EXPLANATION

- 5 The inclusion of this explanation does not constitute agreement with 6 the explanation's substance by the members of the general assembly.
- 7 Under current law, a pioneer cemetery is a cemetery where
- 8 there have been 12 or fewer burials in the preceding 50 years.
- 9 A county board of supervisors has the authority to create, by
- 10 ordinance, a cemetery commission that shall assume jurisdiction
- 11 and control of the pioneer cemeteries in the county.
- 12 This bill allows a cemetery commission to retain
- 13 jurisdiction and control of a cemetery that was a pioneer
- 14 cemetery upon or after creation of the cemetery commission,
- 15 but is no longer considered a pioneer cemetery due to recent
- 16 burials. The decision to continue retaining jurisdiction and
- 17 control belongs solely to the cemetery commission. The bill
- 18 also allows a board and a cemetery commission, if created,
- 19 by a majority vote of both the board and the commission,
- 20 respectively, to amend the definition of "pioneer cemetery" in
- 21 the county to mean a cemetery where there have been 24 or fewer
- 22 burials in the preceding 50 years.
