## A BILL FOR

- 1 An Act relating to the criminal offenses of theft in the third
- 2 degree and robbery in the first degree and making penalties
- 3 applicable.
- 4 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

- 1 Section 1. Section 714.2, subsection 3, Code 2020, is 2 amended to read as follows:
- 3 3. The theft of property exceeding seven hundred fifty
- 4 dollars but not exceeding one thousand five hundred dollars in
- 5 value, or the theft of any property not exceeding five seven
- 6 hundred fifty dollars in value by one who has before been twice
- 7 convicted of theft, is theft in the third degree. Theft in the
- 8 third degree is an aggravated misdemeanor.
- 9 Sec. 2. Section 902.12, subsection 3, Code 2020, is amended 10 to read as follows:
- 11 3. A person serving a sentence for a conviction for
- 12 robbery in the first degree in violation of section 711.2
- 13 for a conviction that occurs on or after July 1, 2018 2019,
- 14 shall be denied parole or work release until the person has
- 15 served between one-half and seven-tenths of the maximum term
- 16 of the person's sentence as determined under section 901.11,
- 17 subsection 3.
- 18 EXPLANATION
- The inclusion of this explanation does not constitute agreement with the explanation's substance by the members of the general assembly.
- 21 Under current law, the theft of property that is more than
- 22 \$750 but not more than \$1,500, or the theft of any property
- 23 not more than \$500 by a person who has previously been twice
- 24 convicted of theft, is theft in the third degree, an aggravated
- 25 misdemeanor. This bill increases the dollar amount limit for
- 26 the theft of any property by a person who has previously been
- 27 twice convicted of theft from \$500 to \$750.
- Theft in the third degree is an aggravated misdemeanor
- 29 punishable by confinement for no more than two years and a fine
- 30 of at least \$625 but not more than \$6,250.
- 31 Under current law, a person serving a sentence for a
- 32 conviction of robbery in the first degree shall be denied
- 33 parole or work release until the person has served between
- 34 one-half and seven-tenths of the maximum term of the person's
- 35 sentence, if the person was convicted on or after July 1, 2018.
