## A BILL FOR

- 1 An Act relating to health insurance by certain peace officers
- of the department of public safety.
- 3 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

- 1 Section 1. <u>NEW SECTION</u>. **80.7 Peace officers** health 2 insurance.
- Notwithstanding any provision to the contrary, peace
- 4 officers employed within the department that are not covered
- 5 under a collective bargaining agreement shall have the option
- 6 to participate in the group health insurance plan that is
- 7 negotiated under chapter 20 between the state and the state
- 8 police officers council labor union for peace officers.
- 9 2. The department shall calculate the savings to the
- 10 department for peace officers exercising the option to
- 11 participate in the group health insurance plan pursuant to
- 12 subsection 1. The department shall transfer to the special
- 13 investigations fund created in section 80.48 from moneys
- 14 appropriated to the department an amount equal to the savings
- 15 calculated by the department.
- 16 Sec. 2. NEW SECTION. 80.48 Special investigations fund.
- 17 l. A special investigations fund is established in the state
- 18 treasury under the control of the department. The fund shall
- 19 consist of moneys transferred to the fund pursuant to section
- 20 80.7.
- 2. Moneys in the fund are appropriated to the department for
- 22 purposes of paying for departmental personnel to investigate
- 23 unsolved homicides and sexual assaults.
- 3. Notwithstanding section 8.33, moneys in the fund
- 25 that remain unencumbered or unobligated at the close of a
- 26 fiscal year shall not revert but shall remain available for
- 27 expenditure for the purposes designated. Notwithstanding
- 28 section 12C.7, subsection 2, interest or earnings on moneys in
- 29 the fund shall be credited to the fund.
- 30 EXPLANATION
- 31 The inclusion of this explanation does not constitute agreement with
- 32 the explanation's substance by the members of the general assembly.
- 33 This bill allows peace officers employed within the
- 34 department of public safety that are not covered under
- 35 a collective bargaining agreement to have the option to

- 1 participate in the group health insurance plan that is
- 2 negotiated between the state and the state police officers
- 3 council labor union for peace officers. The bill provides that
- 4 the department shall calculate the savings to the department
- 5 for peace officers exercising the option provided by the bill
- 6 and directs the department to transfer moneys to a new special
- 7 investigations fund created by the bill in an amount equal to
- 8 the savings. The bill creates a new special investigations
- 9 fund and provides that moneys in the fund are appropriated
- 10 to the department for purposes of paying for departmental
- 11 personnel to investigate unsolved homicides and sexual
- 12 assaults.
