A BILL FOR

- 1 An Act requiring certain disclosures related to veterans'
- benefit services, and making penalties applicable.
- 3 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

- 1 Section 1. Section 546B.2, Code 2019, is amended to read as 2 follows:
- 3 546B.2 Advertising or promotion disclosures.
- A person who advertises or promotes any event,
- 5 presentation, seminar, workshop, or other public gathering
- 6 regarding veterans' benefits or entitlements shall include a
- 7 disclosure as provided in this section subsection 2 and must
- 8 disseminate the disclosure, both orally and in writing, at the
- 9 beginning of the event, presentation, seminar, workshop, or
- 10 other public gathering. The written disclosure must be in the
- 11 same type size and font as the term "veteran" or any variation
- 12 of that term as used in the advertisement or promotional
- 13 materials for the event, presentation, seminar, workshop, or
- 14 public gathering.
- 2. The disclosure required by this section subsection 1
- 16 shall be in the following form:
- 17 This event is not sponsored by, or affiliated with, the
- 18 United States Department of Veterans Affairs, the Iowa
- 19 Department of Veterans Affairs, or any other congressionally
- 20 chartered or recognized organization of honorably discharged
- 21 members of the Armed Forces of the United States or any
- 22 of their auxiliaries. Products or services that may be
- 23 discussed at this event are not necessarily endorsed by those
- 24 organizations. You may qualify for benefits other than or in
- 25 addition to the benefits discussed at this event.
- 26 3. The requirement to provide a disclosure as provided in
- 27 this section subsection 1 shall not apply under any of the
- 28 following circumstances:
- 29 a. The United States department of veterans affairs,
- 30 the Iowa department of veterans affairs, or any other
- 31 congressionally chartered or recognized organization of
- 32 honorably discharged members of the armed forces of the
- 33 United States or any of their auxiliaries have granted written
- 34 permission to the person for the use of its name, symbol,
- 35 or insignia to advertise or promote any event, presentation,

- 1 seminar, workshop, or other public gathering regarding
- 2 veterans' benefits or entitlements.
- 3 b. The event, presentation, seminar, workshop, or public
- 4 gathering is part of an accredited continuing legal education
- 5 course.
- 6 4. A person advertising or promoting services to represent
- 7 or assist veterans in any veterans' benefit matter, including
- 8 any services related to a veteran's application for veteran's
- 9 disability benefits, shall include a disclosure, as provided in
- 10 subsection 5, in all advertisements and promotional materials,
- 11 including online advertisements, in the same type size and font
- 12 as the term "veteran" or any variation of that term is used in
- 13 the advertisement or promotion.
- 14 5. The disclosure required by subsection 4 shall be in the
- 15 following form:
- No compensation may be received by any person advising or
- 17 assisting another person with a veterans' benefit matter except
- 18 as allowed under Title 38 of the United States Code. Veterans'
- 19 benefit services are offered at no cost by federally chartered
- 20 veteran service organizations and Iowa county veteran service
- 21 officers. The services being offered are not provided by
- 22 or affiliated with the United States department of veterans
- 23 affairs, the Iowa department of veterans affairs, or any other
- 24 government agency or recognized veterans services organization.
- 25 You may qualify for benefits other than or in addition to
- 26 benefits obtained by the services offered.
- 27 EXPLANATION
- 28 The inclusion of this explanation does not constitute agreement with
- the explanation's substance by the members of the general assembly.
- 30 This bill requires certain disclosures related to veterans'
- 31 benefit services.
- 32 The bill provides that a person advertising services to
- 33 represent or assist veterans in any veterans' benefit matter
- 34 must include a disclosure in all advertisements and promotional
- 35 materials. The required disclosure states that no compensation

- 1 may be received by any person advising or assisting another
- 2 person with a veterans' benefit matter except as allowed by
- 3 federal law; that veterans' benefit services are offered at no
- 4 cost by federally chartered veteran service organizations and
- 5 the Iowa county veteran service officers; that the services
- 6 being offered are not provided by or affiliated with the United
- 7 States department of veterans affairs, the Iowa department of
- 8 veterans affairs, or any other government agency or recognized
- 9 veterans services organization; and that the veteran may
- 10 qualify for benefits other than or in addition to benefits
- 11 obtained by the services to be provided.
- 12 A person who fails to include the required disclosure when
- 13 advertising services to represent or assist veterans in any
- 14 veterans' benefit matter violates the consumer fraud provisions
- 15 of Code section 714.16(2)(a) relating to unfair, fraudulent, or
- 16 deceptive practices and any civil penalty recovered shall be
- 17 deposited in the veterans trust fund created in Code section
- 18 35A.13. Current law provides that a person who receives
- 19 compensation for advising or assisting another person with a
- 20 veterans' benefit matter, except as permitted under Title 38
- 21 of the United States Code, also commits a violation of Code
- 22 section 714.16(2)(a).
- 23 Pursuant to Code section 714.16, the attorney general may
- 24 investigate, issue subpoenas, and commence civil proceedings
- 25 seeking restraining orders or injunctions prohibiting persons
- 26 from engaging in unlawful practices or seeking termination
- 27 of the business affairs of a person engaging in unlawful
- 28 practices. In addition, a civil penalty of up to \$40,000 per
- 29 violation may be imposed by a court against a person found to
- 30 have committed an unlawful practice.
