HOUSE FILE 2061 BY WILLS

A BILL FOR

- 1 An Act concerning persons appointed to a convention called
- 2 by the United States Congress to propose amendments to
- 3 the United States Constitution, providing a penalty, and
- 4 including effective date provisions.
- 5 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

- 1 Section 1. NEW SECTION. 38.1 Definitions.
- 2 For purposes of this chapter, unless the context otherwise 3 requires:
- 4 l. "Article V convention" means a convention called by the
- 5 United States Congress pursuant to Article V of the United
- 6 States Constitution upon application of the legislatures of at
- 7 least two-thirds of the states to propose amendments to the
- 8 United States Constitution.
- 9 2. "Commissioner" means a person selected to represent the 10 state at an Article V convention.
- 11 3. "Unauthorized amendment" means a proposed amendment
- 12 to be considered at an Article V convention that is outside
- 13 the subject matter of the state's joint resolution applying
- 14 to Congress to call the Article V convention or that is in
- 15 contravention of any instructions provided to commissioners by
- 16 the state.
- 17 4. "Unauthorized rule" means a proposed rule for governing
- 18 the Article V convention that is in conflict with a rule
- 19 that each state be granted one vote and that a majority vote
- 20 is required to propose an amendment to the United States
- 21 Constitution.
- 22 Sec. 2. NEW SECTION. 38.2 Commissioner prohibitions —
- 23 removal penalty.
- 1. A commissioner shall not have the authority at an Article
- 25 V convention to vote to allow consideration of or vote to
- 26 approve an unauthorized amendment or an unauthorized rule.
- 27 2. Every commissioner shall be required to take the
- 28 following oath:
- 29 I do solemnly swear (or affirm) that to the best of
- 30 my abilities, I will, as a commissioner to an Article V
- 31 convention, uphold the Constitution and laws of the United
- 32 States of America and the State of Iowa. I will not vote to
- 33 allow consideration of or to approve any unauthorized amendment
- 34 or unauthorized rule. I acknowledge that violation of this
- 35 oath may result in my recall and replacement as a commissioner

- 1 and is a simple misdemeanor.
- A commissioner violating the provisions of subsection
- 3 1 or of the oath as provided in subsection 2 shall be subject
- 4 to removal and replacement as a commissioner by the state and
- 5 shall be guilty of a simple misdemeanor.
- 6 Sec. 3. EFFECTIVE DATE. This Act, being deemed of immediate
- 7 importance, takes effect upon enactment.
- 8 EXPLANATION
- 9 The inclusion of this explanation does not constitute agreement with 10 the explanation's substance by the members of the general assembly.
- 11 This bill relates to persons selected by the general
- 12 assembly to represent the state at a convention called by the
- 13 United States Congress to propose amendments to the United
- 14 States Constitution.
- 15 The bill defines an Article V convention as a convention
- 16 called by the United States Congress as provided by Article
- 17 V of the United States Constitution upon application of the
- 18 legislatures of at least two-thirds of the states to propose
- 19 amendments to the United States Constitution. "Commissioner"
- 20 is defined to mean a person selected to represent the state at
- 21 an Article V convention. The bill also defines an unauthorized
- 22 amendment as a proposed amendment at an Article V convention
- 23 that is outside the subject matter of the state's joint
- 24 resolution calling for the convention or is in contravention
- 25 of any instructions provided to commissioners by the state.
- 26 Finally, the bill defines an unauthorized rule as a proposed
- 27 rule for governing the Article V convention that is in conflict
- 28 with a rule that each state be granted one vote and that a
- 29 majority vote is required to propose an amendment to the United
- 30 States Constitution.
- 31 The bill provides that a commissioner shall not propose or
- 32 vote to approve an unauthorized amendment or an unauthorized
- 33 rule at an Article V convention. The bill also requires a
- 34 commissioner to take an oath recognizing these prohibitions.
- 35 The bill provides that a commissioner violating the provisions

- 1 of the bill shall be subject to removal and replacement as
- 2 a commissioner by the state and shall be guilty of a simple
- 3 misdemeanor. A simple misdemeanor is punishable by confinement
- 4 for no more than 30 days and a fine of at least \$105 but not
- 5 more than \$855.
- 6 The bill takes effect upon enactment.
