- 2 concerning internet fantasy sports contests and sports
- 3 wagering to the county endowment fund.
- 4 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

- 1 Section 1. Section 99E.6, subsection 2, Code 2022, is
- 2 amended to read as follows:
- 3 2. The taxes imposed by this section for internet fantasy
- 4 sports contests authorized under this chapter shall be paid by
- 5 the internet fantasy sports contest service provider to the
- 6 treasurer of state as determined by the commission and shall be
- 7 distributed as follows:
- 8 a. An amount of taxes distributed pursuant to this section
- 9 equal to one percent of internet fantasy sports contest
- 10 adjusted revenues shall be deposited in the county endowment
- 11 fund created in section 15E.311.
- 12 b. The remaining amount of internet fantasy sports contest
- 13 taxes distributed pursuant to this section shall be credited as
- 14 provided in section 8.57, subsection 6.
- 15 Sec. 2. Section 99F.11, subsection 5, paragraph b, Code
- 16 2022, is amended to read as follows:
- 17 b. The taxes imposed by this subsection for sports wagering
- 18 authorized under this chapter shall be paid by the licensed
- 19 operator to the treasurer of state as determined by the
- 20 commission and shall be distributed as follows:
- 21 (1) An amount of taxes distributed pursuant to this
- 22 subsection equal to one percent of sports wagering net receipts
- 23 shall be deposited in the county endowment fund created in
- 24 section 15E.311.
- 25 (2) The remaining amount of sports wagering taxes
- 26 distributed pursuant to this subsection shall be credited as
- 27 provided in section 8.57, subsection 6.
- 28 EXPLANATION
- The inclusion of this explanation does not constitute agreement with
- 30 the explanation's substance by the members of the general assembly.
- 31 This bill provides that, of taxes collected, 1 percent
- 32 of internet fantasy sports contest adjusted revenues and 1
- 33 percent of sports wagering net receipts shall be deposited
- 34 in the county endowment fund created in Code section 15E.311
- 35 prior to the remaining taxes received for internet fantasy

- 1 sports contests and sports wagering being credited to the
- 2 sports wagering receipts fund created in Code section 8.57.
- 3 Currently, all tax revenue for internet fantasy sports contests
- 4 and sports wagering is credited to the sports wagering receipts
- 5 fund.
