COLLEGE STUDENT AID COMMISSION -28 APPROPRIATION. There is appropriated from the general 29 fund of the state to the college student aid commission for the 30 fiscal year beginning July 1, 2022, and ending June 30, 2023, 31 the following amount, or so much thereof as is necessary, to be 32 used for the purposes designated: 33 For the coordination of activities with the Iowa college

11	the general fund of the state and other funds to the college

13	department of education, and the state board of regents and its
14	institutions. The bill is organized by divisions.
15	DIVISION I — FY 2022-2023. The bill appropriates moneys to
16	the department for the blind for its administration.
17	The bill includes appropriations to the college student aid
	commission for general administrative purposes, administration
	of the future ready Iowa skilled workforce last-dollar
	scholarship program, the health care professional recruitment
	program, the national guard service scholarship program, the
	all Iowa opportunity scholarship program, the teach Iowa
	scholar program, the rural Iowa primary care loan repayment

	veterinarian loan repayment program, the future ready Iowa

- 27 the state university of Iowa; Iowa state university of science
- 28 and technology; the university of northern Iowa; and for the
- 29 Iowa school for the deaf and the Iowa braille and sight saving

- 31 DIVISION II WORKFORCE TRAINING PROGRAMS APPROPRIATIONS
- 32 FY 2022-2023. The bill appropriates moneys from the Iowa
- 33 skilled worker and job creation fund to the college student aid
- 34 commission and the department of education.
- 35 DIVISION III IOWA WORKFORCE GRANT AND INCENTIVE PROGRAM.

1 The bill establishes the Iowa workforce grant and incentive 2 program within the college student aid commission. 3 provides that the Iowa workforce grant and incentive program 4 will provide grants to certain eligible students who are 5 pursuing an eligible program for high-demand jobs. 6 provides that the amount of the grant is based on the number of 7 semester hours in which the student is enrolled. The bill requires the Iowa workforce development board to 9 update its list of high-demand jobs at least once every five 10 years. The bill also provides that this list shall be used for 11 purposes of the Iowa workforce grant and incentive program. DIVISION IV - CLASSROOM MANAGEMENT AND TRANSPORTATION 12 13 REIMBURSEMENT. The bill appropriates moneys to the department 14 of education for developing guidelines related to behavior in 15 the classroom, the therapeutic classroom incentive fund, and 16 the payment of claims for reimbursement submitted under Code 17 section 256A.25A(1)(a) (therapeutic classroom transportation 18 claims). 19 DIVISION V — APPROPRIATION — STANDING LIMITED. 20 increases the standing limited appropriation to the college 21 student aid commission for tuition grants to qualified students 22 who are enrolled in accredited private institutions from 23 \$48,896,050 to \$50,118,451. In addition, the bill increases 24 the standing limited appropriation to the college student aid 25 commission for tuition grants to qualified students who are 26 enrolled in eligible institutions from \$456,220 to \$500,000. 27 DIVISION VI - STATE PROGRAM ALLOCATION. Current Code 28 section 284.13 establishes how moneys appropriated for purposes 29 of the student achievement and teacher quality program are to 30 be allocated. The bill extends the allocations established 31 pursuant to Code section 284.13 to the fiscal year beginning 32 July 1, 2022. The bill provides that for the fiscal year 33 beginning July 1, 2023, and for each subsequent fiscal year, of 34 the moneys appropriated for purposes of the student achievement 35 and teacher quality program, the final priority for the

- 4 DIVISION VII COLLEGE STUDENT AID COMMISSION IOWA
- 5 COLLEGE ACCESS NETWORK. The bill appropriates \$150,000 from

- 8 the Iowa college access network to assist students enrolled
- 9 in grades 9 through 12 in completing the free application for
- 10 federal student aid. Any moneys that remain unencumbered or
- ll unobligated at the close of the fiscal year shall not revert

- 13 the succeeding fiscal year.
