A BILL FOR

- 1 An Act relating to the practice of barbering and cosmetology
- arts and sciences, including fees, and providing transition
- 3 provisions.
- 4 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

- 1 Section 1. Section 10A.104, subsection 14, Code 2022, is
- 2 amended by striking the subsection.
- 3 Sec. 2. Section 147.13, subsection 11, Code 2022, is amended
- 4 to read as follows:
- 5 11. For cosmetology arts and sciences, the board of
- 6 barbering and cosmetology arts and sciences.
- 7 Sec. 3. Section 147.13, subsection 12, Code 2022, is amended
- 8 by striking the subsection.
- 9 Sec. 4. Section 147.14, subsection 1, paragraphs a and n,
- 10 Code 2022, are amended by striking the paragraphs.
- 11 Sec. 5. Section 147.14, subsection 1, Code 2022, is amended
- 12 by adding the following new paragraph:
- 13 NEW PARAGRAPH. x. For barbering and cosmetology arts and
- 14 sciences, three members who are licensed cosmetologists; one
- 15 member who is a licensed instructor of cosmetology arts and

- 4 NEW SUBSECTION. 001. "Barbering" means the practices listed
- 5 in this subsection performed with or without compensation.
- 6 "Barbering" includes but is not limited to the following
- 7 practices performed upon the upper part of the human body of
- 8 any person for cosmetic purposes and not for the treatment of
- 9 disease or physical or mental ailments:
- 10 a. Shaving or trimming the beard or cutting the hair.
- 11 b. Giving facial and scalp massages or treatments with oils,
- 12 creams, lotions, or other preparations either by hand, or by
- 13 electrical or mechanical appliances.
- 14 c. Singeing, shampooing, hair body processing, curling,
- 15 blow waving, hair relaxing, bleaching or coloring the hair, or
- 16 applying hair tonics.
- 17 d. Applying cosmetic preparations, antiseptics, powders,
- 18 oils, clays, waxes, or lotions to the scalp, face, or neck.
- 19 e. Styling, cutting, or shampooing hairpieces or wigs when
- 20 done in conjunction with haircutting or hairstyling.
- 21 NEW SUBSECTION. 10A. "Establishment" means a fixed place
- 22 or a place that is readily movable where one or more persons
- 23 engage in the practice of barbering or cosmetology arts and
- 24 sciences, including but not limited to a retail establishment.

- 31 1. a. The merger of the boards of barbering and cosmetology

- 35 or the board of cosmetology arts and sciences shall continue to

- 8 sciences or board of barbering that is in force and effect
- 9 immediately prior to the effective date of this Act shall

- 25 5. Any cause of action, statute of limitation, or
- 26 administrative action relating to or initiated by the board of
- 27 cosmetology arts and sciences or board of barbering shall not
- 28 be affected as a result of this Act and shall apply to the board
- 29 of barbering and cosmetology arts and sciences.
- 30 6. All client and organizational files in the possession
- 31 of the board of cosmetology arts and sciences or board of
- 32 barbering shall become the property of the board of barbering
- 33 and cosmetology arts and sciences.
- 34 7. Any personnel in the state merit system of employment
- 35 who are mandatorily transferred due to the effect of this Act

- 1 shall be so transferred without any loss in salary, benefits,
 2 or accrued years of service.
- 8. A person licensed as a barber as of July 1, 2022, shall

- 12 EXPLANATION
- The inclusion of this explanation does not constitute agreement with the explanation's substance by the members of the general assembly.
- 15 This bill relates to the practices of barbering and
- 16 cosmetology. The bill merges the boards of cosmetology
- 17 arts and sciences and barbering into the board of barbering
- 18 and cosmetology arts and sciences, repeals Code chapter 158
- 19 governing barbering, and makes conforming Code changes. The
- 20 bill gives the board of barbering and cosmetology arts and
- 21 sciences all of the powers and responsibilities of the prior
- 22 boards. The bill provides that current members of the boards
- 23 of barbering and cosmetology arts and sciences shall become
- 24 members of the merged board until their terms otherwise expire
- 25 or they are otherwise replaced. The bill also provides that
- 26 the current rules of both boards shall remain in effect until
- 27 the board of barbering and cosmetology arts and sciences
- 28 amends, rescinds, or supplements the rules, or the rules expire
- 29 by their own terms. The bill grants the board of barbering,
- 30 the board of cosmetology arts and sciences, and the board
- 31 of barbering and cosmetology arts and sciences emergency
- 32 rulemaking authority to implement the provisions of the bill.
- 33 The bill also provides other transition provisions.
- The bill changes the definition of "cosmetology" by removing
- 35 arranging, braiding, and dressing of hair. The bill adds

- 1 definitions of "barber" and "barbering" consistent with the
- 2 definitions found in Code chapter 158 (barbering). The bill
- 3 repeals the definition of the term "salon" and defines the term
- 4 "establishment" as a fixed place or a place that is readily
- 5 movable where one or more persons engage in the practice of
- 6 barbering or cosmetology arts and sciences.
- 7 The bill directs the board of barbering and cosmetology
- 8 arts and sciences to adopt rules for the licensure of persons
- 9 who perform the practice of barbering, which shall include a
- 10 course of study of at least 2,100 hours of instruction. The
- 11 bill allows licensed barbers to perform shaving or trimming for
- 12 hair removal by the use of a straight edge razor and directs
- 13 the board to adopt rules for the provision of such services by
- 14 a cosmetologist with appropriate training.
- 15 The bill allows a school of barbering and cosmetology
- 16 arts and sciences to be used for purposes other than student
- 17 instruction so long as the other activities do not disrupt
- 18 classes.
- 19 The bill removes manicuring and pedicuring from the required
- 20 course of study for licensure as a cosmetologist.
- 21 The bill requires an establishment to be inspected at
- 22 least once every five years and at the time of opening of the
- 23 establishment and allows an establishment to be inspected upon
- 24 receipt of a complaint by the department of public health.
- 25 The bill moves responsibility for conducting inspections from
- 26 the department of inspections and appeals to the department
- 27 of public health and directs the board to adopt rules for the
- 28 administration of inspections, which shall include fees to
- 29 cover the costs of inspections.
- 30 The bill allows a licensee to practice barbering or
- 31 cosmetology arts and sciences at a location that is not a
- 32 licensed establishment or a school of barbering and cosmetology
- 33 arts and sciences if the board issues an event services permit
- 34 to the licensee pursuant to rules of the board. The bill
- 35 also allows a licensee to practice in the home of a customer

1 pursuant to rules of the board.
