A BILL FOR

- 1 An Act relating to self-service storage insurance, and
- 2 including applicability provisions.
- 3 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

- 1 Section 1. NEW SECTION. 522F.1 Definitions.
- 2 As used in this chapter, unless the context otherwise
- 3 requires:
- 4 1. "Commissioner" means the commissioner of insurance.
- 5 2. "Endorsee" means an employee or an authorized
- 6 representative of an owner authorized to sell or offer
- 7 self-service storage insurance at one or more of the owner's
- 8 locations.
- 9 3. "Financial institution" means any bank, savings and loan
- 10 association, credit union, or other entity subject to Title
- 11 XIII, subtitle 2.
- 12 4. "Insurance producer" means the same as defined in section
- 13 522B.1.
- 14 5. "Insurer" means the same as defined in section 522B.1.
- 15 6. "License" means the same as defined in section 522B.1.
- 16 7. "Limited lines producer" means the same as defined in
- 17 section 522B.1.
- 18 8. "Location" means any physical location in this state, or
- 19 any internet site, call center site, or other location at which
- 20 an owner engages in transactions related to a self-service
- 21 storage facility located in this state.
- 9. "Occupant" means a person, or the person's successors or
- 23 assigns, entitled to the use of space at a self-service storage
- 24 facility under a rental agreement.
- 25 10. "Owner" means a resident or a nonresident person that is
- 26 the owner, operator, property management company, lessor, or
- 27 sublessor of a self-service storage facility. "Owner" does not
- 28 mean an occupant.
- 29 11. "Person" means the same as defined in section 522B.1.
- 30 12. "Personal property" means movable property not affixed
- 31 to land, including goods, wares, merchandise, household items,
- 32 and furnishings.
- 33 13. "Rental agreement" means any written agreement that
- 34 establishes or modifies the terms or conditions concerning an
- 35 occupant's use of space at a self-service storage facility.

- 1 14. "Self-service storage facility" or "facility" means
- 2 any real property used for the purpose of renting or leasing
- 3 individual storage space to occupants who have access to the
- 4 space for the purpose of storing personal property, but does
- 5 not include a garage used primarily for storage of motor
- 6 vehicles, or a repository at a financial institution used by
- 7 the financial institution's customers for storage of money or
- 8 valuables. If an owner issues a warehouse receipt, bill of
- 9 lading, or other document of title for an occupant's personal
- 10 property stored at the facility, the owner and the occupant are
- 11 subject to chapter 554, article 7, and this chapter shall not
- 12 apply.
- 13 15. "Self-service storage insurance" means insurance
- 14 providing coverage for the loss of, or damage to, personal
- 15 property that is contained in a storage space at a facility, or
- 16 is in transit to or from the storage space, during the term of a
- 17 rental agreement covering an occupant's use of storage space at
- 18 the facility.
- 19 16. "Sell" means the same as defined in section 522B.1.
- 20 17. "Solicit" means the same as defined in section 522B.1.
- 21 18. "Supervising entity" means a person licensed as an
- 22 insurance producer under chapter 522B who is appointed by an
- 23 insurer to supervise the administration of self-service storage
- 24 insurance at an owner's locations.
- 25 Sec. 2. NEW SECTION. 522F.2 License required.
- 26 l. Except as provided in subsection 2, an owner or endorsee
- 27 shall not sell or solicit self-service storage insurance
- 28 unless the owner is licensed pursuant to chapter 522B as a
- 29 self-service storage insurance limited lines producer and the
- 30 sale or solicitation of self-service storage insurance is in
- 31 conjunction with and incidental to the rental of self-service
- 32 storage to an occupant.
- 33 2. A license shall not be required for an owner, or an
- 34 endorsee on behalf of an insurer, to display and provide
- 35 promotional information regarding self-service storage

- 1 insurance to occupants and prospective occupants.
- 3. Any owner or endorsee that has solicited or sold
- 3 self-service storage insurance before July 1, 2021, shall
- 4 obtain a self-service storage insurance limited lines producer
- 5 license on or before October 1, 2021, or shall be prohibited
- 6 from continuing to solicit or sell self-service storage
- 7 insurance until licensed. Any owner or endorsee that begins
- 8 to solicit or sell self-service storage insurance on or after
- 9 July 1, 2021, shall obtain a self-service storage limited lines
- 10 insurance producer license prior to soliciting or selling
- 11 self-service storage insurance.
- 12 Sec. 3. <u>NEW SECTION</u>. **522F.3** Application for license —
- 13 requirements.
- 14 l. The commissioner shall issue a self-service storage
- 15 insurance limited lines producer license to an owner pursuant
- 16 to section 522B.6 or 522B.7 if the owner satisfies the
- 17 applicable requirements of section 522B.5 and as part of the
- 18 application for the license the owner provides all of the
- 19 following information:
- 20 a. The physical address of the home office of the owner's
- 21 facility and the physical address and internet sites of all
- 22 locations.
- 23 b. If less than fifty percent of the facility's revenue
- 24 is derived from the sale of self-service storage insurance,
- 25 the owner shall provide the name, residential address, and
- 26 any other information required by the commissioner for one
- 27 employee or one authorized representative of the owner, or for
- 28 one employee or one authorized representative of a supervising
- 29 entity, designated as the person responsible for the owner's
- 30 compliance with the requirements of this chapter.
- 31 c. If fifty percent or more of the facility's revenue is
- 32 derived from the sale of self-service storage insurance, the
- 33 owner shall provide the residential address and any other
- 34 information required by the commissioner for all officers,
- 35 directors, and shareholders of record that have ten percent or

- 1 more beneficial ownership of the facility.
- 2. An owner applying for a self-service storage limited
- 3 lines producer license shall be exempt from the examination
- 4 requirements pursuant to section 522B.4 and section 522B.5,
- 5 subsection 1, paragraph "d".
- 6 3. An owner applying to renew a self-service storage limited
- 7 lines producer license shall be exempt from the continuing
- 8 education requirements pursuant to section 522B.6, subsection
- 9 3.
- 10 Sec. 4. NEW SECTION. 522F.4 Endorsees conditions and
- 11 limitations.
- 12 1. An owner licensed pursuant to section 522F.3 may
- 13 authorize endorsees to solicit, offer, or sell self-service
- 14 storage insurance to occupants and prospective occupants at any
- 15 location.
- 16 2. An endorsee shall not be required to be licensed as an
- 17 insurance producer if all of the following requirements are
- 18 met:
- 19 a. The endorsee is eighteen years of age or older.
- 20 b. The insurer issuing the self-service storage insurance
- 21 either directly supervises, or appoints a supervising entity
- 22 to supervise, the administration of the self-service storage
- 23 insurance, including the development and implementation of a
- 24 training program for endorsees pursuant to subsection 3.
- 25 c. The owner has filed an affidavit with the commissioner,
- 26 in the form and manner required by the commissioner by rule,
- 27 acknowledging that the owner is legally responsible for the
- 28 actions of all endorsees relating to an endorsee's solicitation
- 29 or sale of self-service storage insurance in conjunction with
- 30 and incidental to the rental of storage space to an occupant at
- 31 any location.
- 32 3. An owner, or the supervising entity, shall provide
- 33 a training program for all endorsees who solicit or sell
- 34 self-service storage insurance. The training program shall
- 35 meet all of the following requirements:

- 1 a. The training shall be delivered to each endorsee
- 2 who sells or offers self-service storage insurance at any
- 3 location. The owner, or the supervising entity, shall maintain
- 4 documentation evidencing that each endorsee has completed the
- 5 training. The documentation and all training materials shall
- 6 be made available to the commissioner within five business days
- 7 of the commissioner's request to review the documentation or
- 8 the training materials.
- 9 b. If the training is conducted in an electronic form, the
- 10 supervising entity shall implement a supplemental education
- 11 program regarding self-service storage insurance that is
- 12 conducted and overseen by an employee of the supervising entity
- 13 who is licensed as an insurance producer pursuant to chapter
- 14 522B.
- 15 c. The training program shall include basic information
- 16 about self-service storage insurance and shall address all of
- 17 the following:
- 18 (1) No endorsee shall advertise or otherwise represent the
- 19 endorsee as a licensed insurance producer unless the endorsee
- 20 holds a license.
- 21 (2) No endorsee shall solicit or sell self-service storage
- 22 insurance except in conjunction with and incidental to the
- 23 rental of storage space to an occupant at a location.
- 24 4. An endorsee shall not be paid directly by an insurer,
- 25 and an owner shall not pay an endorsee commission or compensate
- 26 an endorsee based primarily on the number of occupants the
- 27 endorsee enrolls for self-service storage insurance. An
- 28 owner may, however, include an endorsee's performance related
- 29 to soliciting or selling self-service storage insurance to
- 30 occupants and prospective occupants in an overall performance
- 31 incentive compensation program the owner offers for all
- 32 endorsees.
- 33 Sec. 5. NEW SECTION. 522F.5 Registry of locations.
- 34 The owner, or the supervising entity, shall maintain a
- 35 registry of all of the owner's locations and of all endorsees

- 1 at each location that are authorized to sell or solicit
- 2 self-service storage insurance. The owner, or the supervising
- 3 entity, shall make the registry available to the commissioner
- 4 within five business days of the commissioner's request for the
- 5 registry.
- 6 Sec. 6. NEW SECTION. 522F.6 Required documents and
- 7 disclosures.
- 8 l. At any location where self-service storage insurance
- 9 is offered to occupants or prospective occupants, written or
- 10 electronic documents shall be available to the occupants or
- 11 prospective occupants and must include all of the following:
- 12 a. The material terms of the self-service storage
- 13 insurance coverage, or a summary of the material terms of the
- 14 self-service storage insurance coverage, including all of the
- 15 following:
- 16 (1) The identity of the insurer.
- 17 (2) The identity of the supervising entity, if applicable.
- 18 (3) All benefits provided by the coverage.
- 19 (4) The key terms and conditions of the coverage, including
- 20 all exclusions.
- 21 (5) The amount of all deductibles and the process for paying
- 22 a deductible.
- 23 b. A summary of the claims process.
- 24 c. A disclosure specifying that self-service storage
- 25 insurance may be a duplication of coverage already provided by
- 26 an occupant's or prospective occupant's homeowner's insurance
- 27 policy, renter's insurance policy, or other source of insurance
- 28 coverage.
- 29 d. A disclosure specifying that self-service storage
- 30 insurance sold by the owner or an endorsee is not required as a
- 31 condition of obtaining a rental agreement.
- 32 e. Any other disclosures specified by rule as adopted by the
- 33 commissioner.
- 2. The written or electronic documents provided pursuant to
- 35 subsection 1 shall not be subject to filing with, or be subject

- 1 to the approval of, the commissioner.
- 2 Sec. 7. NEW SECTION. 522F.7 Authority conveyed by license.
- All charges for self-service storage insurance on a
- 4 master, corporate, group, or individual policy basis may be
- 5 billed and collected by an owner or an endorsee, and the owner
- 6 may receive compensation for performing billing and collection
- 7 services if all of the following conditions are met:
- 8 a. If any charges for self-service storage insurance are
- 9 not included in the costs associated with an occupant's rental
- 10 of self-service storage space, the owner shall itemize the
- 11 charges for the self-service storage insurance separately on
- 12 the occupant's bill.
- 13 b. If any charges for self-service storage insurance are
- 14 included in the costs associated with an occupant's rental
- 15 of self-service storage space, the owner shall clearly and
- 16 conspicuously disclose that information to the occupant in
- 17 writing.
- 18 2. All premiums received by an owner or endorsee from an
- 19 occupant for self-service storage insurance shall be considered
- 20 funds held by the owner in a fiduciary capacity for the benefit
- 21 of the insurer that issues the self-service storage insurance.
- 22 An owner that bills and collects such moneys shall not be
- 23 required to maintain the moneys in a segregated account if any
- 24 of the following apply:
- 25 a. The owner is authorized by the insurer to hold the funds
- 26 in an alternate manner.
- 27 b. The owner remits the funds to the supervising entity as
- 28 required by the supervising entity.
- 29 Sec. 8. NEW SECTION. 522F.8 License suspension, revocation,
- 30 denial, nonrenewal.
- 31 The commissioner may suspend, revoke, or refuse to issue or
- 32 renew an owner's limited lines self-service storage insurance
- 33 producer license pursuant to section 522B.11.
- 34 Sec. 9. NEW SECTION. 522F.9 Rules.
- 35 The commissioner shall adopt rules pursuant to chapter 17A

- 1 as necessary to implement and administer this chapter.
- 2 Sec. 10. NEW SECTION. 522F.10 Enforcement.
- 3 The commissioner may take any action within the
- 4 commissioner's authority to enforce compliance with this
- 5 chapter.
- 6 Sec. 11. APPLICABILITY. This Act applies to self-service
- 7 storage insurance that is delivered, issued for delivery,
- 8 continued, or renewed in this state on or after July 1, 2021.
- 9 EXPLANATION
- The inclusion of this explanation does not constitute agreement with the explanation's substance by the members of the general assembly.
- 12 This bill relates to self-service storage insurance. The
- 13 bill prohibits an owner or endorsee from soliciting or selling
- 14 self-service storage insurance (insurance) unless the owner
- 15 is licensed as a self-service storage insurance limited lines
- 16 producer (limited lines producer) and the solicitation or sale
- 17 of the insurance is in conjunction with or incidental to an
- 18 occupant's rental of storage space at a self-service storage
- 19 facility (facility). "Self-service storage insurance" is
- 20 defined in the bill as insurance providing coverage for the
- 21 loss of, or damage to, personal property that is contained in
- 22 a storage space at a facility, or is in transit to or from the
- 23 storage space, during the term of a rental agreement covering
- 24 an occupant's use of storage space at the facility. A license
- 25 is not required for an owner to display promotional information
- 26 regarding insurance to occupants and prospective occupants.
- 27 "Owner", "endorsee", "self-service storage facility",
- 28 "occupant", "personal property", and "rental agreement" are
- 29 also defined in the bill.
- 30 An owner or endorsee that has solicited or sold insurance
- 31 before July 1, 2021, must obtain a limited lines producer
- 32 license on or before October 1, 2021, to continue to solicit or
- 33 sell insurance. Any owner or endorsee that begins to solicit
- 34 or sell insurance on or after July 1, 2021, must obtain a
- 35 limited lines producer license prior to soliciting or selling

- 1 insurance. The application and licensing requirements for
- 2 an owner to obtain a limited lines producer license, and the
- 3 conditions and limitations imposed on endorsees, are contained
- 4 in the bill.
- 5 At any location where insurance is offered to occupants or
- 6 prospective occupants, written or electronic documents must
- 7 be available to the occupants or prospective occupants and
- 8 must include the material terms of the insurance coverage as
- 9 outlined in the bill. The documents are not subject to filing
- 10 with, or requiring the approval of, the commissioner. The bill
- 11 defines "location" as any physical location in this state, or
- 12 any internet site, call center site, or other location at which
- 13 an owner engages in transactions related to a facility located
- 14 in this state.
- 15 An endorsee cannot be paid directly by an insurer and
- 16 an owner cannot pay an endorsee commission, or compensate
- 17 an endorsee based primarily on the number of occupants the
- 18 endorsee enrolls for insurance. An owner may, however, include
- 19 an endorsee's performance related to soliciting or selling
- 20 insurance to occupants in an overall performance incentive
- 21 compensation program the owner offers all endorsees.
- 22 The bill allows all charges for insurance on a master,
- 23 corporate, group, or individual basis to be billed and
- 24 collected by the owner or an endorsee. The owner may receive
- 25 compensation for performing billing and collection services if
- 26 the owner itemizes the charges for the insurance separately on
- 27 an occupant's bill if any charges for the insurance are not
- 28 included in the costs associated with the occupant's rental of
- 29 storage space; or the owner clearly and conspicuously discloses
- 30 to the occupant that the charges for insurance are included
- 31 with the storage space rental.
- 32 All premiums received by an owner from an occupant for
- 33 insurance must be considered funds held by the owner in a
- 34 fiduciary capacity for the benefit of the insurer that issues
- 35 the insurance. An owner that bills and collects such funds

- 1 is not required to maintain the funds in a segregated account
- 2 if the owner is authorized by the insurer to hold the funds
- 3 in an alternate manner, or the owner remits the funds to a
- 4 supervising entity as required by the supervising entity, if
- 5 applicable. "Supervising entity" is defined in the bill as a
- 6 person licensed as an insurance producer who is appointed by an
- 7 insurer to supervise the administration of self-service storage
- 8 insurance at an owner's locations.
- 9 The bill gave the commissioner the authority to suspend,
- 10 revoke, or refuse to issue or renew an owner's limited
- 11 lines producer license. The commissioner must adopt rules
- 12 as necessary to implement and administer the provisions of
- 13 the bill, and may take any action within the commissioner's
- 14 authority to enforce compliance with the bill.
- 15 The bill is applicable to self-service storage insurance
- 16 that is delivered, issued for delivery, continued, or renewed
- 17 in this state on or after July 1, 2021.
