

House Study Bill 17 - Introduced

A BILL FOR

1 An Act relating to the sex offender registry including
2 duration of registration requirements and sexually motivated
3 extortion.
4 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

1 Section 1. Section 692A.102, subsection 1, paragraph c,
2 Code 2021, is amended by adding the following new subparagraph:
3 NEW SUBPARAGRAPH. (033) Extortion in violation of section
4 711.4, if a determination is made that the offense was sexually
5 motivated pursuant to section 692A.126.

6 Sec. 2. Section 692A.106, Code 2021, is amended by adding
7 the following new subsection:

8 NEW SUBSECTION. 8. A sex offender who is required to
9 register in another jurisdiction under the other jurisdiction's
10 sex offender registry but who resides, is employed, or attends
11 school in this state shall be required to register for a period
12 of time equal to the period of time required under the other
13 jurisdiction's requirements or under Iowa law, whichever is
14 longer.

15 Sec. 3. Section 692A.126, subsection 1, Code 2021, is
16 amended by adding the following new paragraph:

17 NEW PARAGRAPH. w. Extortion in violation of section 711.4.

18 Sec. 4. Section 711.4, Code 2021, is amended by adding the
19 following new subsection:

20 NEW SUBSECTION. 4. A person convicted of extortion under
21 this section shall be required to register as a sex offender
22 pursuant to the provisions of chapter 692A, if a determination
23 is made that the offense was sexually motivated pursuant to
24 section 692A.126.

25 **EXPLANATION**

26 The inclusion of this explanation does not constitute agreement with
27 the explanation's substance by the members of the general assembly.

28 This bill relates to the sex offender registry including
29 duration of registration requirements and sexually motivated
30 extortion.

31 The bill provides that a sex offender who is required to
32 register in another jurisdiction under the other jurisdiction's
33 sex offender registry but who resides, is employed, or attends
34 school in Iowa shall be required to register for a period of
35 time equal to the period of time required under the other

1 jurisdiction's requirements or under Iowa law, whichever is
2 longer.

3 The bill provides that a person convicted of extortion shall
4 be required to register as a sex offender pursuant to the
5 provisions of Code chapter 692A if a determination is made that
6 the offense was sexually motivated pursuant to Code section
7 692A.126. If such a determination is made, the offender is
8 classified as a tier III offender and the offender is required
9 to register for a period of 10 years pursuant to Code section
10 692A.106.
