A BILL FOR

- 1 An Act authorizing length of service award programs for
- 2 volunteer fire fighters, volunteer emergency medical care
- 3 providers, and reserve peace officers.
- 4 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

- 1 Section 1. <u>NEW SECTION</u>. 100B.51 Length of service award 2 programs authorization.
- 3 The governing body of a municipality, as defined in section
- 4 100B.21, is authorized to establish a length of service award
- 5 program for volunteer fire fighters as defined in section
- 6 85.61, emergency medical care providers as defined in section
- 7 147A.1 who are volunteers, and reserve peace officers as
- 8 defined in section 80D.1A. The program shall provide length
- 9 of service awards, as described in section 457(e)(11) of the
- 10 Internal Revenue Code, to volunteer fire fighters, volunteer
- 11 emergency medical care providers, and reserve peace officers
- 12 serving a municipality that elects to establish a program. The
- 13 program shall be designed to treat awards from the program as
- 14 a tax-deferred benefit under the Internal Revenue Code. The
- 15 governing body of the municipality shall, in consultation with
- 16 the chief or other person in command of the fire department
- 17 and police department serving the municipality, as applicable,
- 18 adopt guidelines providing for eligibility requirements for
- 19 participation by volunteer fire fighters, volunteer emergency
- 20 medical care providers, and reserve peace officers, minimum
- 21 vesting requirements, distribution requirements, and such other
- 22 guidelines as deemed necessary to operate the program.
- 23 Sec. 2. NEW SECTION. 100B.52 Length of service award
- 24 program grant fund appropriation.
- 25 1. A length of service award program grant fund is created
- 26 in the state treasury under the control of the state fire
- 27 service and emergency response council. The fund shall consist
- 28 of all moneys appropriated to the fund.
- 29 2. Moneys in the length of service award program grant
- 30 fund are appropriated to the state fire service and emergency
- 31 response council for the purpose of providing grants to
- 32 municipalities that have established a length of service
- 33 award program as described in section 100B.51 to provide
- 34 contributions to the program on behalf of participants in the
- 35 program. The state fire service and emergency response council

- 1 shall develop and submit to the state fire marshal for adoption
- 2 rules establishing a grant application process. The state
- 3 fire service and emergency response council shall consult with
- 4 the Iowa firefighters association and issue grants based on
- 5 the recommendations from the Iowa firefighters association.
- 6 The grant process shall provide for up to a dollar-for-dollar
- 7 funding match from a municipality that has established a length
- 8 of service award program.
- 9 3. Notwithstanding section 12C.7, subsection 2, interest or
- 10 earnings on moneys deposited in the fund shall be credited to
- 11 the fund. Notwithstanding section 8.33, moneys credited to the
- 12 fund shall not revert at the close of a fiscal year.
- 13 EXPLANATION
- 14 The inclusion of this explanation does not constitute agreement with
- 15 the explanation's substance by the members of the general assembly.
- 16 This bill authorizes a municipality, defined as a city,
- 17 county, township, benefited fire district, or agency authorized
- 18 by law to provide emergency response services, to establish
- 19 a length of service award program as described in section
- 20 457(e)(ll) of the Internal Revenue Code for volunteer fire
- 21 fighters, volunteer emergency medical care providers, and
- 22 reserve peace officers. The bill provides that the governing
- 23 body of a municipality that establishes a program shall, in
- 24 consultation with the chief or other person in command of the
- 25 fire department and police department serving the municipality,
- 26 as applicable, adopt guidelines providing for eligibility
- 27 requirements for participation by volunteer fire fighters,
- 28 volunteer emergency medical care providers, and reserve
- 29 peace officers, minimum vesting requirements, distribution
- 30 requirements, and such other guidelines as deemed necessary to
- 31 operate the program.
- 32 The bill also establishes a length of service award program
- 33 grant fund under the control of the state fire service and
- 34 emergency response council (council). Moneys in the fund
- 35 are appropriated to the council for grants to municipalities

- 1 that have established a length of service award program to
- 2 provide contributions to the program on behalf of participants.
- 3 The bill requires the council to develop and submit to
- 4 the state fire marshal for adoption rules establishing a
- 5 grant application process that shall provide for up to a
- 6 dollar-for-dollar funding match from a municipality that has
- 7 established a length of service award program. The bill
- 8 requires the council to consult with the Iowa firefighters
- 9 association and issue grants based on the association's
- 10 recommendations.
