A BILL FOR

1 An Act providing for congressional and legislative districts
2 and including effective date provisions.

3 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

1 Section 1. Section 40.1, Code 2021, is amended by striking
2 the section and inserting in lieu thereof the following:

3 **40.1 Congressional districts.**

4 The state of Iowa is hereby organized and divided into four
5 congressional districts, which shall be composed, respectively,
6 of the following counties:

7 1. The first district shall consist of the counties of
8 Cedar, Clinton, Des Moines, Henry, Iowa, Jackson, Jasper,
9 Jefferson, Johnson, Jones, Keokuk, Lee, Louisa, Mahaska,
10 Marion, Muscatine, Scott, Van Buren, Warren, and Washington.

11 2. The second district shall consist of the counties of
12 Allamakee, Benton, Black Hawk, Bremer, Buchanan, Butler, Cerro
13 Gordo, Chickasaw, Clayton, Delaware, Dubuque, Fayette, Floyd,
14 Grundy, Hardin, Howard, Linn, Mitchell, Poweshiek, Tama,
15 Winneshiek, and Worth.

16 3. The third district shall consist of the counties of
17 Adair, Adams, Appanoose, Cass, Clarke, Dallas, Davis, Decatur,
18 Greene, Guthrie, Lucas, Madison, Monroe, Montgomery, Page,
19 Polk, Ringgold, Taylor, Union, Wapello, and Wayne.

20 4. The fourth district shall consist of the counties of
21 Audubon, Boone, Buena Vista, Calhoun, Carroll, Cherokee, Clay,
22 Crawford, Dickinson, Emmet, Franklin, Fremont, Hamilton,
23 Hancock, Harrison, Humboldt, Ida, Kossuth, Lyon, Marshall,
24 Mills, Monona, O'Brien, Osceola, Palo Alto, Plymouth,
25 Pocahontas, Pottawattamie, Sac, Shelby, Sioux, Story, Webster,
26 Winnebago, Woodbury, and Wright.

27 Sec. 2. Section 41.1, Code 2021, is amended by striking the
28 section and inserting in lieu thereof the following:

29 **41.1 Representative districts.**

30 The state of Iowa is hereby divided into one hundred
31 representative districts as follows:

32 1. The first representative district in Woodbury county
33 shall consist of that portion of Sioux City bounded by a
34 line commencing at the point the boundary of the state of
35 Iowa intersects the north boundary of Woodbury county, and

1 proceeding east along the boundary of Woodbury county to
2 Talbot road, and proceeding southerly along Talbot road to
3 Plum Creek road, and proceeding easterly along Plum Creek
4 road to Broken Kettle road, and proceeding southerly along
5 Broken Kettle road to West Clifton avenue, and proceeding
6 easterly along West Clifton avenue to Stone Park boulevard,

8 boulevard, and proceeding northerly along Hamilton boulevard

11 easterly along Thirty-fourth street and its extension to
12 Jones street, and proceeding southerly along Jones street to
13 Twenty-ninth street, and proceeding easterly along Twenty-ninth
14 street to Court street, and proceeding southerly along Court
15 street to Twenty-eighth street, and proceeding easterly along
16 Twenty-eighth street to Court street, and proceeding southerly
17 along Court street to Twenty-fourth street, and proceeding
18 easterly along Twenty-fourth street to Floyd boulevard, and
19 proceeding southerly along Floyd boulevard to Nineteenth
20 street, and proceeding easterly along Nineteenth street to
21 Union Pacific Railroad, and proceeding southerly along Union
22 Pacific Railroad to the extension of Thirteenth street, and
23 proceeding westerly along the extension of Thirteenth street to
24 Floyd boulevard, and proceeding northerly along Floyd boulevard
25 to Fourteenth street, and proceeding westerly along Fourteenth
26 street to Court street, and proceeding southerly along Court
27 street to Twelfth street, and proceeding westerly along
28 Twelfth street to Jackson street, and proceeding northerly
29 along Jackson street to Thirteenth street, and proceeding
30 westerly along Thirteenth street to Nebraska street, and
31 proceeding southerly along Nebraska street to Twelfth street,
32 and proceeding westerly along Twelfth street to Grandview
33 boulevard, and proceeding southerly along Grandview boulevard
34 to Eleventh street, and proceeding westerly along Eleventh
35 street to Summit street, and proceeding southerly along Summit

1 street to Bluff street, and proceeding southerly along Bluff
2 street to Wesley parkway, and proceeding southerly along Wesley
3 parkway to the boundary of the state of Iowa, and proceeding
4 first westerly, then in a clockwise manner along the boundary
5 of the state of Iowa to the point of origin.

6 2. The second representative district in Woodbury county
7 shall consist of:

8 a. The city of Lawton.

9 b. Banner and Concord townships.

10 c. That portion of the city of Sioux City bounded by a
11 line commencing at the point the northern boundary of Woodbury
12 county intersects Talbot road, and proceeding easterly along
13 the boundary of Woodbury county until it intersects the eastern
14 boundary of the corporate limits of the city of Sioux City, and
15 proceeding southerly along the corporate limits of the city
16 of Sioux City to Stone avenue, and proceeding westerly along
17 Stone avenue to Morningside avenue, and proceeding southerly
18 along Morningside avenue to Peters avenue, and proceeding
19 westerly along Peters avenue to South Paxton street, and
20 proceeding northerly along South Paxton street to Stone avenue,
21 and proceeding westerly along Stone avenue to South Cecelia
22 street, and proceeding northerly along South Cecelia street to
23 Jay avenue, and proceeding easterly along Jay avenue to South
24 Cecelia street, and proceeding northerly along South Cecelia
25 street to Leech avenue, and proceeding westerly along Leech
26 avenue to Alice street South, and proceeding northerly along
27 Alice street South to Correctionville road, and proceeding
28 westerly along Correctionville road to South Westcott street,
29 and proceeding southerly along South Westcott street to
30 East Gordon drive, and proceeding westerly along East Gordon
31 drive to Gordon drive, and proceeding westerly along Gordon
32 drive to South Court street, and proceeding southerly along
33 South Court street to the boundary of the state of Iowa, and
34 proceeding westerly along the boundary of the state of Iowa
35 to Wesley parkway, and proceeding northerly along Wesley

1 parkway to Bluff street, and proceeding northerly along
2 Bluff street to Summit street, and proceeding northerly along
3 Summit street to Eleventh street, and proceeding easterly
4 along Eleventh street to Grandview boulevard, and proceeding
5 northerly along Grandview boulevard to Twelfth street, and
6 proceeding easterly along Twelfth street to Nebraska street,
7 and proceeding northerly along Nebraska street to Thirteenth
8 street, and proceeding easterly along Thirteenth street to
9 Jackson street, and proceeding southerly along Jackson street
10 to Twelfth street, and proceeding easterly along Twelfth street
11 to Court street, and proceeding northerly along Court street
12 to Fourteenth street, and proceeding easterly along Fourteenth
13 street to Floyd boulevard, and proceeding southerly along
14 Floyd boulevard to the extension of Thirteenth street, and
15 proceeding easterly along the extension of Thirteenth street to
16 Union Pacific Railroad, and proceeding northerly along Union
17 Pacific Railroad to Nineteenth street, and proceeding westerly
18 along Nineteenth street to Floyd boulevard, and proceeding
19 northerly along Floyd boulevard to Twenty-fourth street, and
20 proceeding westerly along Twenty-fourth street to Court street,
21 and proceeding northerly along Court street to Twenty-eighth
22 street, and proceeding westerly along Twenty-eighth street to
23 Court street, and proceeding northerly along Court street to
24 Twenty-ninth street, and proceeding westerly along Twenty-ninth
25 street to Jones street, and proceeding northerly along Jones
26 street to Thirty-fourth street, and proceeding westerly along
27 Thirty-fourth street and its extension to Perry creek, and
28 proceeding westerly along Perry creek to Hamilton boulevard,
29 and proceeding southerly along Hamilton boulevard to Stone Park
30 boulevard, and proceeding westerly along Stone Park boulevard
31 to West Clifton avenue, and proceeding westerly along West
32 Clifton avenue to Broken Kettle road, and proceeding northerly
33 along Broken Kettle road to Plum Creek road, and proceeding
34 westerly along Plum Creek road to Talbot road, and proceeding
35 northerly along Talbot road to the point of origin.

1 3. The third representative district shall consist of:

2 a. In Plymouth county, America, Elgin, Fredonia, Grant,
3 Johnson, Portland, Preston, Sioux, Washington, and Westfield
4 townships, and that portion of Meadow township lying outside
5 the corporate limits of the city of Remsen.

6 b. In Sioux county, Buncombe, Center, Eagle, East Orange,
7 Floyd, Garfield, Holland, Logan, Nassau, Reading, Sherman, and
8 Washington townships, and that portion of West Branch township
9 lying outside the corporate limits of the city of Sioux Center.

10 4. The fourth representative district shall consist of:

11 a. Lyon county.

12 b. In Sioux county:

13 (1) The city of Sioux Center.

14 (2) Capel, Grant, Lincoln, Lynn, Plato, Rock, Settlers,
15 Sheridan, Sioux, and Welcome townships.

16 5. The fifth representative district shall consist of:

17 a. O'Brien county.

18 b. Osceola county.

19 c. In Buena Vista county, Elk, Maple Valley, Nokomis, and
20 Scott townships.

21 d. In Cherokee county, Afton, Cedar, Cherokee, Diamond,
22 Liberty, Pilot, Pitcher, Silver, and Spring townships.

23 6. The sixth representative district shall consist of:

24 a. In Buena Vista county:

25 (1) The cities of Sioux Rapids and Storm Lake.

26 (2) Barnes, Brooke, Coon, Fairfield, Grant, Hayes, Lee,
27 Lincoln, Newell, Poland, Providence, and Washington townships.

28 b. In Clay county:

29 (1) The city of Spencer.

30 (2) Clay, Douglas, Garfield, Gillett Grove, Herdland,
31 Lincoln, Logan, Peterson, and Riverton townships, and that
32 portion of Lone Tree township lying outside the corporate
33 limits of the city of Everly.

34 7. The seventh representative district shall consist of:

35 a. Calhoun county.

- 2 *c.* Sac county.
- 3 *d.* In Webster county, Clay, Dayton, Deer Creek, Fulton,

 - 20 10. The tenth representative district shall consist of:

 - 25 (2) Freeman, Lake, Meadow, Sioux, Summit, and Waterford
 - 26 townships.
 - 27 *d.* In Kossuth county, Cresco, Garfield, Lotts Creek,
 - 28 Riverdale, Union, and Whittemore townships, and that portion of
 - 29 Fenton township lying outside the corporate limits of the city
 - 30 of Lone Rock.
 - 31 11. The eleventh representative district shall consist of:
 - 32 *a.* Audubon county.
 - 33 *b.* Carroll county.
 - 34 *c.* In Pottawattamie county, Knox and Pleasant townships.
 - 35 *d.* In Shelby county, Center, Clay, Douglas, Fairview,

1 Jackson, Monroe, Polk, and Shelby townships.

2 12. The twelfth representative district shall consist of:

3 a. Crawford county.

4 b. Ida county.

5 c. In Shelby county:

6 (1) The city of Harlan.

7 (2) Cass, Greeley, Grove, Jefferson, Lincoln, Union,

8 Washington, and Westphalia townships.

9 13. The thirteenth representative district shall consist
10 of:

11 a. Monona county.

12 b. In Cherokee county, Amherst, Grand Meadow, Marcus, Rock,
13 Sheridan, Tilden, and Willow townships.

14 c. In Plymouth county:

15 (1) The cities of Remsen and Sioux City.

16 (2) Elkhorn, Garfield, Hancock, Henry, Hungerford, Liberty,
17 Lincoln, Marion, Perry, Plymouth, Remsen, Stanton, and Union
18 townships.

19 d. In Woodbury county, Arlington, Grange, Grant, Kedron,
20 Lakeport, Liston, Little Sioux, Miller, Morgan, Merville, Oto,
21 Rock, Rutland, Sloan, Union, West Fork, Willow, and Wolf Creek
22 townships, and that portion of Floyd township lying outside the
23 corporate limits of the city of Lawton.

24 14. The fourteenth representative district in Woodbury
25 county shall consist of:

26 a. Liberty township and that portion of Woodbury township
27 lying outside the corporate limits of the city of Sioux City.

28 b. That portion of the city of Sioux City bounded by a
29 line commencing at the point the southern corporate limits of
30 the city of Sioux City intersects with the boundary of the
31 state of Iowa, and proceeding east, then in a counterclockwise
32 manner along the corporate limits of the city of Sioux City to
33 Stone avenue, and proceeding westerly along Stone avenue to
34 Morningside avenue, and proceeding southerly along Morningside
35 avenue to Peters avenue, and proceeding westerly along Peters

1 avenue to South Paxton street, and proceeding northerly along
2 South Paxton street to Stone avenue, and proceeding westerly
3 along Stone avenue to South Cecelia street, and proceeding
4 northerly along South Cecelia street to Jay avenue, and
5 proceeding easterly along Jay avenue to South Cecelia street,
6 and proceeding northerly along South Cecelia street to Leech
7 avenue, and proceeding westerly along Leech avenue to Alice
8 street South, and proceeding northerly along Alice street
9 South to Correctionville road, and proceeding westerly along

29 in the nineteenth and twentieth representative districts.

18 Spaulding, and Union townships.

19 18. The eighteenth representative district shall consist
20 of:

34 easterly along Interstate 480 to U.S. highway 6, and proceeding
35 easterly along U.S. highway 6 to West Broadway, and proceeding

1 easterly along West Broadway to South Twenty-fourth street,
2 and proceeding southerly along South Twenty-fourth street
3 to Ninth avenue, and proceeding easterly along Ninth avenue
4 to South Seventeenth street, and proceeding southerly
5 along South Seventeenth street to Sixteenth avenue, and
6 proceeding easterly along Sixteenth avenue to Indian creek,
7 and proceeding southerly along Indian creek to Twenty-third
8 avenue, and proceeding easterly along Twenty-third avenue
9 to South Thirteenth street, and proceeding northerly along
10 South Thirteenth street to Twenty-first avenue, and proceeding

23 point of beginning.

28 a line commencing at the point the corporate limits of the

30 intersects Interstate 480, and proceeding northerly, then in
31 a clockwise manner along the corporate limits of the city
32 of Council Bluffs until it intersects North Broadway, and
33 proceeding southerly along North Broadway to Hunter avenue,
34 and proceeding westerly along Hunter avenue to Creek Frontage
35 street, and proceeding northerly along Creek Frontage street

1 to Norton avenue, and proceeding westerly along Norton avenue
2 to East Washington avenue, and proceeding southerly along East
3 Washington avenue to West Oak street, and proceeding easterly
4 along West Oak street to North Broadway, and proceeding
5 southerly along North Broadway to Ridge street, and proceeding
6 southerly along Ridge street to East Broadway, and proceeding
7 southerly along East Broadway to Frank street, and proceeding
8 easterly along Frank street to East Pierce street, and
9 proceeding southerly along East Pierce street to Union street,
10 and proceeding northerly along Union street to East Broadway,

23 23. The twenty-third representative district shall consist
24 of:

11 to West Fifty-eighth street, and proceeding easterly along
12 West Fifty-eighth street to Appomattox road, and proceeding
13 southerly along Appomattox road to West Fifty-third street,
14 and proceeding easterly along West Fifty-third street to
15 East Fifty-third street, and proceeding easterly along East
16 Fifty-third street to Eastern avenue, and proceeding southerly
17 along Eastern avenue to East Kimberly road, and proceeding
18 easterly along East Kimberly road to Spring street, and
19 proceeding southerly along Spring street and its extension
20 to Duck creek, and proceeding easterly along Duck creek to
21 the corporate limits of the city of Davenport, and proceeding
22 southerly along the corporate limits of the city of Davenport
23 to the boundary of the state of Iowa, and proceeding westerly
24 along the boundary of the state of Iowa to the point of origin.

25 98. The ninety-eighth representative district in Scott
26 county shall consist of:

27 a. That portion of Buffalo township lying outside the
28 corporate limits of the city of Blue Grass.

29 b. That portion of Blue Grass township and the city
30 of Davenport bounded by a line commencing at the point of
31 intersection of the boundary of the state of Iowa and the west
32 corporate limits of the city of Davenport, and proceeding
33 northerly along the corporate limits of the city of Davenport
34 to One Hundred Sixtieth street, and proceeding easterly
35 along One Hundred Sixtieth street to West Locust street, and

1 proceeding easterly along West Locust street to Waverly road,
2 and proceeding southerly along Waverly road to North Clark
3 street, and proceeding northerly along North Clark street to
4 West Lombard street, and proceeding westerly along West Lombard
5 street to North Michigan avenue, and proceeding northerly
6 along North Michigan avenue to West Central Park avenue, and
7 proceeding easterly along West Central Park avenue to North
8 Division street, and proceeding northerly along North Division
9 street to West Garfield street, and proceeding easterly along
10 West Garfield street to North Marquette street, and proceeding
11 southerly along North Marquette street to West Central Park
12 avenue, and proceeding easterly along West Central Park avenue
13 to North Harrison street, and proceeding southerly along
14 North Harrison street to West Rusholme street, and proceeding
15 westerly along West Rusholme street to Warren street, and
16 proceeding southerly along Warren street to West Fifteenth
17 street, and proceeding westerly along West Fifteenth street to
18 North Marquette street, and proceeding southerly along North
19 Marquette street to West Fifteenth street, and proceeding
20 westerly along West Fifteenth street to Washington street, and
21 proceeding southerly along Washington street to West Twelfth
22 street, and proceeding easterly along West Twelfth street to
23 Vine street, and proceeding southerly along Vine street to
24 West Tenth street, and proceeding easterly along West Tenth
25 street to Warren street, and proceeding northerly along Warren
26 street to West Eleventh street, and proceeding easterly along
27 West Eleventh street to North Gaines street, and proceeding
28 southerly along North Gaines street to West Sixth street, and
29 proceeding easterly along West Sixth street to East Sixth
30 street, and proceeding easterly along East Sixth street to Iowa
31 street, and proceeding southerly along Iowa street to Leclaire
32 street, and proceeding southerly along Leclaire street to the
33 Arsenal bridge, and proceeding southerly along the Arsenal
34 bridge to the boundary of the state of Iowa, and proceeding
35 westerly along the boundary of the state of Iowa to the point

1 of origin.

2 99. The ninety-ninth representative district shall consist
3 of:

4 a. In Des Moines county:

5 (1) The cities of Burlington, Danville, and West
6 Burlington.

7 (2) Concordia, Danville, and Union townships.

8 b. In Lee county, Denmark, Green Bay, and Pleasant Ridge
9 townships.

10 100. The one-hundredth representative district in Lee
11 county shall consist of that portion of Lee county not
12 contained in the ninety-ninth representative district.

13 Sec. 3. MEMBERSHIP.

14 1. CONGRESSIONAL DISTRICTS. Each congressional district
15 established by section 1 of this Act shall elect one
16 representative for a term of two years in 2022 and every
17 subsequent even-numbered year.

18 2. STATE SENATE AND HOUSE DISTRICTS. The membership of the
19 senate and house of representatives in the Ninetieth General
20 Assembly and subsequent general assemblies shall be determined
21 as follows:

22 a. Each representative district established by section 2 of
23 this Act shall elect one representative for a term of two years
24 in 2022 and every subsequent even-numbered year.

25 b. Each odd-numbered senatorial district established by
26 section 41.2 which the general assembly adopts by reference,
27 and section 2 of this Act, shall elect a senator in 2022 for
28 a four-year term commencing in January 2023. If an incumbent
29 senator who was elected to a four-year term which commenced in
30 January 2021, or was subsequently elected to fill a vacancy in
31 such a term, is residing in an odd-numbered senatorial district
32 on February 2, 2022, that senator's term of office shall be
33 terminated on January 1, 2023.

34 c. Each even-numbered senatorial district established by
35 section 41.2 which the general assembly adopts by reference,

1 and section 2 of this Act, shall elect a senator in 2024 for a
2 four-year term commencing in January 2025.

3 (1) If one and only one incumbent state senator is residing
4 in an even-numbered senatorial district on February 2, 2022,
5 and that senator meets all of the following requirements, the
6 senator shall represent the district in the senate for the
7 Ninetieth General Assembly:

8 (a) The senator was elected to a four-year term which
9 commenced in January 2021 or was subsequently elected to fill a
10 vacancy in such a term.

11 (b) The senatorial district in the plan which includes
12 the place of residence of the state senator on the date of
13 the senator's last election to the senate is the same as the
14 even-numbered senatorial district in which the senator resides
15 on February 2, 2022, or is contiguous to such even-numbered
16 senatorial district and the senator's declared residence as
17 of February 2, 2022, was within the district from which the
18 senator was last elected. Areas which meet only at the points
19 of adjoining corners are not contiguous.

20 (2) Each even-numbered senatorial district to which
21 subparagraph (1) of this paragraph "c" is not applicable
22 shall elect a senator in 2022 for a two-year term commencing
23 in January 2023. However, if more than one incumbent state
24 senator is residing in an even-numbered senatorial district on
25 February 2, 2022, and, on or before February 16, 2022, all but
26 one of the incumbent senators resigns from office effective no
27 later than January 1, 2023, the remaining incumbent senator
28 shall represent the district in the senate for the Ninetieth
29 General Assembly if that senator meets the requirements of
30 subparagraph (1), subparagraph divisions (a) and (b) of this
31 paragraph "c". A copy of the resignation must be filed in the
32 office of the secretary of state no later than 5:00 p.m. on
33 February 16, 2022.

34 d. To fulfill the purposes of this subsection, the secretary
35 of state shall prescribe a form to be completed by all senators

1 to declare their residences as of February 2, 2022. The form
2 shall be filed with the secretary of state no later than 5:00
3 p.m. on February 2, 2022.

4 Sec. 4. VACANCIES.

5 1. MEMBER OF CONGRESS. If a special election to fill a
6 vacancy for a representative in Congress occurs or exists
7 after the effective date of this Act, at a time which makes
8 it necessary to fill the vacancy at a special election held
9 pursuant to section 69.14, the vacancy shall be filled from the
10 same district provided in chapter 40, Code 2021, which elected
11 the representative whose seat is vacant. This subsection does
12 not apply if a special election is not required under section
13 69.14.

14 2. MEMBER OF GENERAL ASSEMBLY. If a vacancy in the
15 Eighty-ninth General Assembly occurs or exists after the
16 effective date of this Act, at a time which makes it necessary
17 to fill the vacancy at a special election held pursuant to
18 section 69.14, the vacancy shall be filled from the same
19 district provided in chapter 41, Code 2021, which elected
20 the senator or representative whose seat is vacant. This
21 subsection does not apply if a special election is not required
22 under section 69.14.

23 3. REPEAL. This section is repealed January 1, 2023.

24 Sec. 5. GEOGRAPHY. For purposes of this Act, each reference
25 to a specific city, township, street, or other boundary means
26 such city, township, street, or other boundary as they are
27 delineated and described in the 2020 topologically integrated
28 geographic encoding and referencing system (TIGER) data file
29 created by the United States census bureau that corresponds to
30 the population data provided to the state under Pub. L. No.
31 94-171 based upon the 2020 United States decennial census.

32 Sec. 6. EFFECTIVE DATE. This Act, being deemed of immediate
33 importance, takes effect upon enactment.

34 EXPLANATION

35 The inclusion of this explanation does not constitute agreement with

1 the explanation's substance by the members of the general assembly.

2 This bill establishes congressional and legislative
3 districts for the state effective during the 2022 and
4 subsequent general elections. Current Code section 41.2
5 provides that state senate districts are composed of two
6 state representative districts and specifies which numbered
7 representative districts make up each numbered senate district.
8 The bill takes effect upon enactment.
