- 1 An Act relating to deer hunting licenses available to
- 2 nonresident hunters.
- 3 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

      Section 1. Section 483A.8, subsection 3, paragraphs c and e,
 2 Code 2022, are amended to read as follows:
          The commission shall annually limit to six seven
 4 thousand five hundred the number of nonresidents allowed to
 5 have antlered or any sex deer hunting licenses. Of the six
 6 seven thousand five hundred nonresident antlered or any sex
 7 deer hunting licenses issued, not more than thirty-five percent
 8 of the licenses shall be bow season licenses. After the six
 9 seven thousand five hundred antlered or any sex nonresident
10 deer hunting licenses have been issued, all additional licenses
11 shall be issued for antlerless deer only. The commission shall
12 annually determine the number of nonresident antlerless deer
13 only deer hunting licenses that will be available for issuance.

         The commission shall assign one preference point to a
15 nonresident whose application for a nonresident antlered or any
16 sex deer hunting license is denied due to limitations on the
17 number of nonresident antlered or any sex deer hunting licenses
18 available for issuance that year. An additional preference
19 point shall be assigned to that person each subsequent year
20 the person's license application is denied for that reason.
21 nonresident may purchase additional preference points pursuant
22 to rules adopted pursuant to section 483A.1. The first
23 department shall use a random draw process that is weighted
24 to favor applicants with the most preference points to assign
25 nonresident antlered or any sex deer hunting license drawing
26 each year shall be made from the pool of applicants with the
27 most preference points and continue to pools of applicants
28 with successively fewer preference points licenses until
29 all available nonresident antlered or any sex deer hunting
30 licenses have been issued. If a nonresident applicant receives
31 an antlered or any sex deer hunting license, all of the
32 applicant's assigned preference points at that time shall be
33 removed.

- 1 NEW PARAGRAPH. f. If a nonresident hunting deer while using
- 2 the antlerless deer only deer hunting license and tag required
- 3 to be purchased pursuant to paragraph "b" takes an antlerless
- 4 deer in a zone that is above the population goal determined
- 5 by the commission by rule, the commission shall assign one
- 6 preference point to the nonresident, which shall be in addition
- 7 to any preference points acquired pursuant to paragraph "e".
- 8 The department shall determine a method for verifying a harvest
- 9 pursuant to this paragraph.
- 10 EXPLANATION
- 11 The inclusion of this explanation does not constitute agreement with 12 the explanation's substance by the members of the general assembly.
- 13 This bill relates to deer hunting licenses available to
- 14 nonresident hunters.
- 15 Currently, the natural resource commission (NRC) issues
- 16 up to 6,000 antlered or any sex deer hunting licenses to
- 17 nonresidents. The bill increases that amount to 7,500. The
- 18 bill requires NRC to use a random draw process that is weighted
- 19 to favor applicants with the most preference points to assign
- 20 nonresident antlered or any sex deer hunting licenses until all
- 21 available nonresident antlered or any sex deer hunting licenses
- 22 have been issued.
- 23 The bill provides that when a nonresident uses the
- 24 antlerless deer only deer hunting license and tag that the
- 25 nonresident is required to purchase with an antlered or any sex
- 26 deer hunting license to take an antlerless deer in a zone that
- 27 is above the population goal determined by NRC, then NRC will
- 28 assign one preference point to the nonresident, which shall
- 29 be in addition to any preference points purchased or acquired
- 30 after failing to obtain an antlered or any sex deer hunting
- 31 license from a drawing. The department of natural resources
- 32 shall determine a method for verifying a harvest in a zone that
- 33 is above the population goal.
