A BILL FOR

- 1 An Act relating to education, including eligibility for grants
- 2 under the teach Iowa scholar program, licenses issued by the
- 3 board of educational examiners, and the use of revenues from
- 4 the district management levy, and including applicability
- 5 provisions.
- 6 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

- 1 Section 1. Section 256.16, subsection 1, Code 2022, is
- 2 amended by adding the following new paragraph:
- 3 NEW PARAGRAPH. n. If a higher education institution
- 4 providing practitioner preparation offers a program that is
- 5 designed to assist students in attaining a teacher intern
- 6 license from the board of educational examiners, the program
- 7 shall require participants to satisfy all of the following
- 8 requirements before completing the program:
- 9 (1) A participant in the program must have graduated from an
- 10 accredited or state-approved college or university.
- 11 (2) A participant in the program must have at least three
- 12 years of post-baccalaureate work experience.
- 13 (3) A participant in the program must submit with the
- 14 application to the program a copy of an offer of employment
- 15 from a school.
- 16 (4) A participant in the program must have completed the
- 17 required pedagogy training.
- 18 (5) A participant in the program must work under the
- 19 supervision of a teacher leader assigned by the school district
- 20 or accredited nonpublic school, including during co-teaching
- 21 and planning time.
- 22 (6) A participant in the program must complete at least
- 23 fifteen additional hours of coursework.
- Sec. 2. Section 261.110, subsection 3, Code 2022, is amended
- 25 by adding the following new paragraph:
- 26 NEW PARAGRAPH. d. The total value of grants awarded under
- 27 this section each year to applicants who are preparing to
- 28 teach in a school district, charter school, or an accredited
- 29 nonpublic school shall be as follows:
- 30 (1) Fifty percent shall be awarded to applicants preparing
- 31 to teach in a school district with less than or equal to one
- 32 thousand two hundred students, a charter school with less than
- 33 or equal to one thousand two hundred students, or an accredited
- 34 nonpublic school with less than or equal to one thousand
- 35 two hundred students. However, if the amount requested by

- 1 applicants pursuant to subparagraph (2) is less than the amount
- 2 reserved for applicants under subparagraph (2), the commission
- 3 may award the difference to applicants under this subparagraph.
- 4 (2) Fifty percent shall be awarded to applicants preparing
- 5 to teach in a school district with greater than one thousand
- 6 two hundred students, a charter school with greater than one
- 7 thousand two hundred students, or an accredited nonpublic
- 8 school with greater than one thousand two hundred students.
- 9 However, if the amount requested by applicants pursuant
- 10 to subparagraph (1) is less than the amount reserved for
- 11 applicants under subparagraph (1), the commission may award the
- 12 difference to applicants under this subparagraph.
- 13 Sec. 3. Section 272.2, subsection 1, Code 2022, is amended
- 14 by adding the following new paragraph:
- 15 NEW PARAGRAPH. d. Rules adopted pursuant to this subsection
- 16 establishing criteria for applicants for licenses who have
- 17 completed an accredited or state-approved teacher preparation
- 18 program and who are applying for the applicant's first Iowa
- 19 teaching license shall not require the applicant to be an Iowa
- 20 resident if the applicant provides the board with a copy of an
- 21 offer of employment as a teacher from a school located in this
- 22 state.
- 23 Sec. 4. Section 272.2, subsection 13, Code 2022, is amended
- 24 to read as follows:
- 25 13. Adopt rules to provide for nontraditional preparation
- 26 options for licensing persons who hold a bachelor's degree
- 27 or higher from an accredited or state-approved college or
- 28 university, who do not meet other requirements for licensure.
- 29 The rules shall, at a minimum, require the board to do all of
- 30 the following:
- 31 a. Issue a teacher intern license for instruction in grades
- 32 six through twelve to an applicant who has completed a program
- 33 established pursuant to section 256.16, subsection 1, paragraph
- 34 "n".
- 35 b. Allow a licensee who has attained a teacher intern

- 1 license pursuant to paragraph "a" to apply for an initial
- 2 teaching license if the school that employed the licensee
- 3 during the licensee's completion of the program established
- 4 pursuant to section 256.16, subsection 1, paragraph n'', and
- 5 the higher education institution that operated the program,
- 6 recommend that the licensee be allowed to apply for an initial
- 7 teaching license.
- 8 Sec. 5. Section 272.2, Code 2022, is amended by adding the
- 9 following new subsection:
- 10 NEW SUBSECTION. 27. Adopt rules pursuant to chapter
- 11 17A that allow an individual seeking a career and technical
- 12 secondary authorization to apply, and if eligible, be issued
- 13 the secondary authorization prior to accepting an offer of
- 14 employment with a school.
- 15 Sec. 6. Section 279.46, Code 2022, is amended to read as
- 16 follows:
- 17 279.46 Retirement incentives and teacher recruitment
- 18 incentives tax.
- 19 1. The board of directors of a school district may adopt
- 20 a program for payment of a monetary bonus, continuation of
- 21 health or medical insurance coverage, or other incentives
- 22 for encouraging its employees to retire before the normal
- 23 retirement date as defined in chapter 97B. The program is
- 24 available only to employees who notify the board of directors
- 25 prior to April 1 of the fiscal year that they intend to retire
- 26 not later than the start of the next following school calendar.
- 27 The age at which employees shall be designated eligible for the
- 28 program shall be at the discretion of the board. An employee
- 29 retiring under this section this subsection may apply for a
- 30 retirement allowance under chapter 97B or chapter 294. The
- 31 board may include in the district management levy an amount to
- 32 pay the total estimated accumulated cost to the school district
- 33 of the health or medical insurance coverage, bonus, or other
- 34 incentives for employees fifty-five years of age or older who
- 35 retire under this section subsection.

- 1 2. a. The board of directors of a school district may
- 2 adopt a program for teacher recruitment incentives to recruit
- 3 new teachers. If the board does adopt a program for teacher
- 4 recruitment incentives, the board shall adopt a policy to
- 5 implement the program.
- 6 b. The board may include in the district management levy
- 7 an amount to pay the total estimated accumulated cost to the
- 8 school district of the teacher recruitment incentives adopted
- 9 under this subsection.
- 10 c. The board shall not adopt either the program for early
- 11 retirement benefits provided in subsection 1 or the program
- 12 for teacher recruitment incentives provided in this subsection
- 13 within two years after adopting the other program.
- 3. The board of directors of a school district shall
- 15 discuss the adoption of the program for early retirement
- 16 benefits provided in subsection 1 or the program for teacher
- 17 recruitment incentives provided in subsection 2, as applicable,
- 18 at a regular or special meeting prior to adopting the program.
- 19 The board of directors of the school district shall provide
- 20 sufficient time to receive public comment on the program. The
- 21 board shall allow each interested member of the public to speak
- 22 at the meeting regarding the program, but may impose a time
- 23 limit on the amount of time a member of the public is allowed
- 24 to speak if the time limit is the same for each speaker and
- 25 necessary due to the amount of people wishing to speak. The
- 26 board of directors of a school district shall not adopt the
- 27 program for early retirement benefits provided in subsection
- 28 1 concurrently with the program for teacher recruitment
- 29 incentives provided in subsection 2.
- 30 Sec. 7. Section 298.4, subsection 1, paragraph e, Code 2022,
- 31 is amended to read as follows:
- e. To pay the cost of early retirement benefits to employees
- 33 under section 279.46, subsection 1, or teacher recruitment
- 34 incentives under section 279.46, subsection 2. A board of
- 35 directors of a school district shall not expend the district

- 1 management levy on the costs of both programs in the same
- 2 fiscal year.
- 3 Sec. 8. APPLICABILITY. The following applies to grants
- 4 awarded by the college student aid commission on or after July
- 5 1, 2022, to initial applicants under the teach Iowa scholar
- 6 program established pursuant to section 261.110:
- 7 The section of this Act amending section 261.110.
- 8 EXPLANATION
- 9 The inclusion of this explanation does not constitute agreement with the explanation's substance by the members of the general assembly.
- 11 This bill relates to education, including eligibility for
- 12 grants under the teach Iowa scholar program, licenses issued
- 13 by the board of educational examiners (BOEE), and the use of
- 14 revenues from the district management levy.
- 15 The bill provides that if a higher education institution
- 16 providing practitioner preparation offers a program that is
- 17 designed to assist students in attaining a teacher intern
- 18 license from the BOEE, the program shall require participants
- 19 to satisfy certain specified requirements.
- 20 The teach Iowa scholar program, administered by the
- 21 college student aid commission, provides grants to certain
- 22 high-caliber, full-time teachers in Iowa in amounts not to
- 23 exceed \$4,000 annually or \$20,000 over five years. The bill
- 24 provides that the total value of grants awarded under the
- 25 program to applicants who are preparing to teach in a school
- 26 district, charter school, or an accredited nonpublic school
- 27 shall be equally divided between applicants preparing to
- 28 teach in a school district, charter school, or an accredited
- 29 nonpublic school with less than or equal to 1,200 students and
- 30 applicants preparing to teach in a school district, charter
- 31 school, or accredited nonpublic school with greater than
- 32 1,200 students. The bill authorizes the commission to award
- 33 different amounts to each group of applicants if the amount
- 34 requested by applicants of either group is less than the amount
- 35 reserved for that group. The bill establishes that this

1 provision applies to grants awarded by the commission on or 2 after July 1, 2022, to initial applicants under the program. Current law authorizes the BOEE to issue a regional exchange 4 teaching license to an applicant who has completed a teacher 5 preparation program outside of the state and who is applying 6 for the applicant's first Iowa teaching license if, among 7 other requirements, the applicant is a resident of the state. 8 The bill removes the requirement that such an applicant be a 9 resident of this state if the applicant provides the BOEE with 10 a copy of an offer of employment as a teacher from a school ll located in this state. Current law requires the BOEE to adopt rules to provide 12 13 for nontraditional preparation options for licensing persons 14 who hold a bachelor's degree from an accredited college 15 or university and who do not meet other requirements for 16 licensure. The bill provides that the rules shall require 17 the BOEE to issue a teacher intern license to an applicant 18 who has completed a program offered by a higher education 19 institution providing practitioner preparation that is designed 20 to assist students in attaining a teacher intern license. 21 bill requires the BOEE to allow a licensee who has attained 22 a teacher intern license under such a program to apply for 23 an initial teaching license if the school that employed 24 the licensee during the program and the higher education 25 institution recommend that the licensee be allowed to apply. 26 The bill requires the BOEE to adopt rules that allow 27 an individual seeking a career and technical secondary 28 authorization to apply, and if eligible, be issued the 29 secondary authorization prior to accepting an offer of 30 employment with a school. Currently, Code section 279.46 authorizes the board of 31 32 directors of a school district to adopt a program for early 33 retirement benefits to encourage its employees to retire before 34 the normal retirement date. The bill modifies Code section 35 279.46 to also authorize the board of directors to adopt a

- 1 program for teacher recruitment incentives to recruit new
- 2 teachers. The bill requires the board of directors to discuss
- 3 the adoption of the program for early retirement benefits or
- 4 the program for teacher recruitment incentives, as applicable,
- 5 at a regular or special meeting prior to adopting the program
- 6 and allow for public comment. The bill prohibits the board
- 7 of directors from adopting the program for early retirement
- 8 benefits concurrently with the program for teacher recruitment
- 9 incentives. The bill also prohibits the board of directors
- 10 from adopting either the program for early retirement benefits
- ll or the program for teacher recruitment incentives within two
- 12 years after adopting the other program.
- 13 The bill authorizes the board of directors to expend the
- 14 district management levy to pay the costs of either the program
- 15 for early retirement benefits or the program for teacher
- 16 recruitment incentives. The bill prohibits the board of
- 17 directors from expending the district management levy on the
- 18 costs of both programs in the same fiscal year.
