A BILL FOR

1 An Act making appropriations to the department of cultural
2 affairs, the economic development authority, the Iowa
3 finance authority, the public employment relations board,
4 the department of workforce development, and the state board
5 of regents and certain regents institutions, and providing
6 for properly related matters.
7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

1 DIVISION I
2 FY 2021-2022
3 APPROPRIATIONS

4 Section 1. DEPARTMENT OF CULTURAL AFFAIRS.

5 1. There is appropriated from the general fund of the state
6 to the department of cultural affairs for the fiscal year
7 beginning July 1, 2021, and ending June 30, 2022, the following
8 amounts, or so much thereof as is necessary, to be used for the
9 purposes designated:

10 a. ADMINISTRATION

11 For salaries, support, maintenance, and miscellaneous
12 purposes, and for not more than the following full-time
13 equivalent positions for the department:

14	\$	168,637
15	FTEs	55.49

16 The department of cultural affairs shall coordinate
17 activities with the tourism office of the economic development
18 authority to promote attendance at the state historical
19 building and at the state's historic sites.

20 Full-time equivalent positions authorized under this
21 paragraph are funded, in full or in part, using moneys
22 appropriated under this paragraph and paragraphs "c" through
23 "g".

24 b. COMMUNITY CULTURAL GRANTS

25 For planning and programming for the community cultural
26 grants program established under [section 303.3](#):

29 For the support of the historical division:

2 Of the moneys appropriated in this paragraph, the department
3 shall allocate \$300,000 for purposes of the film office.

4 f. IOWA GREAT PLACES

5 For the Iowa great places program established under section
6 303.3C:

7 \$ 150,000

8 g. CULTURAL TRUST GRANTS

9 For grant programs administered by the Iowa arts
10 council including those programs supporting the long-term
11 financial stability and sustainability of nonprofit cultural
12 organizations:

13 \$ 150,000

14 2. Notwithstanding section 8.33, moneys appropriated in
15 this section that remain unencumbered or unobligated at the
16 close of the fiscal year shall not revert but shall remain
17 available for expenditure for the purposes designated until the
18 close of the succeeding fiscal year.

19 Sec. 2. GOALS AND ACCOUNTABILITY — ECONOMIC DEVELOPMENT.

20 1. For the fiscal year beginning July 1, 2021, the goals
21 for the economic development authority shall be to expand and
22 stimulate the state economy, increase the wealth of Iowans, and
23 increase the population of the state.

24 2. To achieve the goals in subsection 1, the economic
25 development authority shall do all of the following for the
26 fiscal year beginning July 1, 2021:

27 a. Concentrate its efforts on programs and activities that
28 result in commercially viable products and services.

29 b. Adopt practices and services consistent with free
30 market, private sector philosophies.

31 c. Ensure economic growth and development throughout the
32 state.

33 d. Work with businesses and communities to continually
34 improve the economic development climate along with the
35 economic well-being and quality of life for Iowans.

1 e. Coordinate with other state agencies to ensure that they
2 are attentive to the needs of an entrepreneurial culture.

3 f. Establish a strong and aggressive marketing image to
4 showcase Iowa's workforce, existing industry, and potential.
5 A priority shall be placed on recruiting new businesses,
6 business expansion, and retaining existing Iowa businesses.
7 Emphasis shall be placed on entrepreneurial development through
8 helping entrepreneurs secure capital, and developing networks
9 and a business climate conducive to entrepreneurs and small
10 businesses.

11 g. Encourage the development of communities and quality of
12 life to foster economic growth.

13 h. Prepare communities for future growth and development
14 through development, expansion, and modernization of
15 infrastructure.

16 i. Develop public-private partnerships with Iowa businesses
17 in the tourism industry, Iowa tour groups, Iowa tourism
18 organizations, and political subdivisions in this state to
19 assist in the development of advertising efforts.

20 j. Develop, to the fullest extent possible, cooperative
21 efforts for advertising with contributions from other sources.

22 Sec. 3. ECONOMIC DEVELOPMENT AUTHORITY.

23 1. APPROPRIATION

24 a. There is appropriated from the general fund of the state
25 to the economic development authority for the fiscal year
26 beginning July 1, 2021, and ending June 30, 2022, the following
27 amount, or so much thereof as is necessary, to be used for the
28 purposes designated in this subsection, and for not more than
29 the following full-time equivalent positions:

30	\$ 13,318,553
31	FTEs 106.95

32 b. (1) For salaries, support, miscellaneous purposes,
33 programs, marketing, and the maintenance of an administration
34 division, a business development division, a community
35 development division, a small business development division,

1 and other divisions the authority may organize.

2 (2) The full-time equivalent positions authorized under
3 this section are funded, in whole or in part, by the moneys
4 appropriated under this subsection or by other moneys received
5 by the authority, including certain federal moneys.

6 (3) For business development operations and programs,
7 international trade, export assistance, workforce recruitment,
8 and the partner state program.

9 (4) For transfer to a fund created pursuant to section
10 15.313 for purposes of financing strategic infrastructure
11 projects.

12 (5) For community economic development programs, tourism
13 operations, community assistance, plans for Iowa green corps
14 and summer youth programs, the main street and rural main
15 street programs, the school-to-career program, the community
16 development block grant, and housing and shelter-related
17 programs.

18 (6) For achieving the goals and accountability, and
19 fulfilling the requirements and duties required under this Act.

20 c. Notwithstanding section 8.33, moneys appropriated in
21 this subsection that remain unencumbered or unobligated at the
22 close of the fiscal year shall not revert but shall remain
23 available for expenditure for the purposes designated in this
24 subsection until the close of the succeeding fiscal year.

25 2. FINANCIAL ASSISTANCE RESTRICTIONS

26 a. A business creating jobs through moneys appropriated in
27 subsection 1 shall be subject to contract provisions requiring
28 new and retained jobs to be filled by individuals who are
29 citizens of the United States who reside within the United
30 States, or any person authorized to work in the United States
31 pursuant to federal law, including legal resident aliens
32 residing in the United States.

33 b. Any vendor who receives moneys appropriated in
34 subsection 1 shall adhere to such contract provisions and
35 provide periodic assurances as the state shall require that the

1 jobs are filled solely by citizens of the United States who
2 reside within the United States, or any person authorized to
3 work in the United States, pursuant to federal law, including
4 legal resident aliens residing in the United States.

5 c. A business that receives financial assistance from
6 the authority from moneys appropriated in subsection 1 shall
7 only employ individuals legally authorized to work in this
8 state. In addition to all other applicable penalties provided
9 by current law, all or a portion of the assistance received
10 by a business which is found to knowingly employ individuals
11 not legally authorized to work in this state is subject to
12 recapture by the authority.

13 3. USES OF APPROPRIATIONS

14 a. From the moneys appropriated in subsection 1, the
15 authority may provide financial assistance in the form of a
16 grant to a community economic development entity for conducting
17 a local workforce recruitment effort designed to recruit former
18 citizens of the state and former students at colleges and
19 universities in the state to meet the needs of local employers.

20 b. From the moneys appropriated in subsection 1, the
21 authority may provide financial assistance to early stage
22 industry companies being established by women entrepreneurs.

23 c. From the moneys appropriated in subsection 1, the
24 authority may provide financial assistance in the form of
25 grants, loans, or forgivable loans for advanced research and
26 commercialization projects involving value-added agriculture,
27 advanced technology, or biotechnology.

28 d. The authority shall not use any moneys appropriated in
29 subsection 1 for purposes of providing financial assistance for
30 the Iowa green streets pilot project or for any other program
31 or project that involves the installation of geothermal systems
32 for melting snow and ice from streets or sidewalks.

33 4. WORLD FOOD PRIZE

34 In lieu of the standing appropriation in [section 15.368](#),
35 there is appropriated from the general fund of the state to the

1 economic development authority for the fiscal year beginning
2 July 1, 2021, and ending June 30, 2022, the following amount
3 for the world food prize:

4 \$ 375,000

5 5. IOWA COMMISSION ON VOLUNTEER SERVICE

6 a. There is appropriated from the general fund of the state
7 to the economic development authority for the fiscal year
8 beginning July 1, 2021, and ending June 30, 2022, the following
9 amount for allocation to the Iowa commission on volunteer
10 service for purposes of the Iowa state commission grant
11 program, the Iowa's promise and Iowa mentoring partnership
12 programs, and for not more than the following full-time
13 equivalent positions:

14 \$ 168,201

15 FTEs 12.00

16 Of the moneys appropriated in this subsection, the
17 authority shall allocate \$75,000 for purposes of the Iowa state
18 commission grant program and \$93,201 for purposes of the Iowa's
19 promise and Iowa mentoring partnership programs.

20 b. Notwithstanding [section 8.33](#), moneys appropriated in
21 this subsection that remain unencumbered or unobligated at the
22 close of the fiscal year shall not revert but shall remain
23 available for expenditure for the purposes designated until the
24 close of the succeeding fiscal year.

25 6. COUNCILS OF GOVERNMENTS — ASSISTANCE

26 There is appropriated from the general fund of the state
27 to the economic development authority for the fiscal year
28 beginning July 1, 2021, and ending June 30, 2022, the following
29 amount to be used for the purposes of providing financial
30 assistance to Iowa's councils of governments:

31 \$ 275,000

32 7. FUTURE READY IOWA REGISTERED APPRENTICESHIP DEVELOPMENT
33 PROGRAM

34 a. There is appropriated from the general fund of the state
35 to the economic development authority for the fiscal year

1 beginning July 1, 2021, and ending June 30, 2022, the following
2 amount to be used for the funding of the future ready Iowa
3 registered apprenticeship development program under chapter
4 15C, to encourage small to midsize businesses to start or grow
5 registered apprenticeships:

6 \$ 1,000,000

7 b. Notwithstanding section 8.33, moneys appropriated in
8 this section that remain unencumbered or unobligated at the
9 close of the fiscal year shall not revert but shall remain
10 available for expenditure for the purposes designated until the
11 close of the succeeding fiscal year.

12 8. SCIENCE, TECHNOLOGY, ENGINEERING, AND MATHEMATICS
13 INTERNSHIPS

14 a. There is appropriated from the Iowa skilled worker and
15 job creation fund created in section 8.75 to the Iowa economic
16 development authority for the fiscal year beginning July 1,
17 2021, and ending June 30, 2022, the following amount, or so
18 much thereof as is necessary, to be used for the purposes
19 designated:

20 For the funding of internships for students studying in the
21 fields of science, technology, engineering, and mathematics
22 with eligible Iowa employers as provided in section 15.411,
23 subsection 3, paragraph "c":

24 \$ 1,000,000

25 b. No more than 3 percent of the moneys appropriated in this
26 subsection may be used by the authority for costs associated
27 with administration of the internship program.

28 c. Notwithstanding section 8.33, moneys appropriated in
29 this subsection which remain unencumbered or unobligated at
30 the end of the fiscal year shall not revert but shall remain
31 available for expenditure for the purposes designated in
32 subsequent fiscal years.

33 9. FUTURE READY IOWA — VOLUNTEER MENTORING PROGRAM

34 a. There is appropriated from the Iowa skilled worker and
35 job creation fund created in section 8.75 to the economic

1 development authority for the fiscal year beginning July 1,
2 2021, and ending June 30, 2022, the following amount, or so
3 much thereof as is necessary, to be used for the purpose
4 designated:

5 For allocation to the Iowa commission on volunteer services
6 to be used for establishing a volunteer mentor program to
7 support implementation of the future ready Iowa skilled
8 workforce last-dollar scholarship program in section 261.131
9 and the future ready Iowa skilled workforce grant program
10 created in section 261.132, and for not more than the following
11 full-time equivalent positions:

12 \$ 400,000
13 FTEs 1.00

14 b. Notwithstanding section 8.33, moneys appropriated in
15 this subsection which remain unencumbered or unobligated at
16 the end of the fiscal year shall not revert but shall remain
17 available for expenditure for the purposes designated until the
18 close of the succeeding fiscal year.

19 10. STEM BEST AND EMPOWER RURAL IOWA

20 a. There is appropriated from the Iowa skilled worker and
21 job creation fund created in section 8.75 to the economic
22 development authority for the fiscal year beginning July 1,
23 2021, and ending June 30, 2022, the following amounts, or so
24 much thereof as is necessary, for the purposes designated:

25 STEM Best:

26 \$ 700,000

27 Empower Rural Iowa Program:

28 \$ 700,000

29 b. Notwithstanding section 8.33, moneys appropriated in
30 this subsection which remain unencumbered or unobligated at
31 the end of the fiscal year shall not revert but shall remain
32 available for expenditure for the purposes designated until the
33 close of the succeeding fiscal year.

34 c. The authority shall adopt rules pursuant to chapter
35 17A to establish criteria for the distribution of the moneys

1 appropriated in this subsection.

2 Sec. 4. LIMITATIONS OF STANDING APPROPRIATIONS — FY
3 2021-2022. Notwithstanding the standing appropriations
4 in the following designated sections for the fiscal year
5 beginning July 1, 2021, and ending June 30, 2022, the amounts
6 appropriated from the general fund of the state pursuant to
7 these sections for the following purposes shall not exceed the
8 following amounts:

9 1. For operational support grants and community cultural
10 grants under section 99F.11, subsection 3, paragraph "d",
11 subparagraph (1):

12 \$ 448,403

13 2. For the purposes of regional tourism marketing under
14 section 99F.11, subsection 3, paragraph "d", subparagraph (2):

15 \$ 900,000

16 Sec. 5. FINANCIAL ASSISTANCE REPORTING — ECONOMIC
17 DEVELOPMENT AUTHORITY. The economic development authority and
18 the department of revenue shall submit a joint annual report
19 to the general assembly no later than November 1, 2021, that
20 details the amount of every direct loan, forgivable loan,
21 tax credit, tax exemption, tax refund, grant, or any other
22 financial assistance awarded to a person during the prior
23 fiscal year by the authority under an economic development
24 program administered by the authority. The report shall
25 identify the county where the project associated with each such
26 award is located.

27 Sec. 6. INSURANCE ECONOMIC DEVELOPMENT. From the
28 moneys collected by the insurance division in excess of the
29 anticipated gross revenues under section 505.7, subsection
30 3, during the fiscal year beginning July 1, 2021, \$100,000
31 shall be transferred to the economic development authority for
32 insurance economic development and international insurance
33 economic development.

34 Sec. 7. IOWA FINANCE AUTHORITY.

35 1. There is appropriated from the general fund of the state

1 to the Iowa finance authority for the fiscal year beginning
2 July 1, 2021, and ending June 30, 2022, the following amount,
3 or so much thereof as is necessary, to be used to provide
4 reimbursement for rent expenses to eligible persons under
5 the home and community-based services rent subsidy program
6 established in section 16.55:

7 \$ 658,000

8 2. Of the moneys appropriated in this section, not more than
9 \$35,000 may be used for administrative costs.

10 3. Notwithstanding section 8.33, moneys appropriated in
11 this section that remain unencumbered or unobligated at the
12 close of the fiscal year shall not revert but shall remain
13 available for expenditure for the purposes designated until the
14 close of the succeeding fiscal year.

15 Sec. 8. IOWA FINANCE AUTHORITY AUDIT. The auditor of state
16 is requested to review the audit of the Iowa finance authority
17 performed by the auditor hired by the authority.

18 Sec. 9. PUBLIC EMPLOYMENT RELATIONS BOARD.

19 1. There is appropriated from the general fund of the state
20 to the public employment relations board for the fiscal year
21 beginning July 1, 2021, and ending June 30, 2022, the following
22 amount, or so much thereof as is necessary, to be used for the
23 purposes designated:

24 For salaries, support, maintenance, and miscellaneous
25 purposes, and for not more than the following full-time
26 equivalent positions:

27 \$ 1,492,452

28 FTEs 11.00

29 2. Of the moneys appropriated in this section, the board
30 shall allocate \$15,000 for maintaining an internet site that
31 allows access to a searchable database of collective bargaining
32 information.

33 Sec. 10. DEPARTMENT OF WORKFORCE DEVELOPMENT. There
34 is appropriated from the general fund of the state to the
35 department of workforce development for the fiscal year

1 beginning July 1, 2021, and ending June 30, 2022, the following
2 amounts, or so much thereof as is necessary, to be used for the
3 purposes designated:

4 1. DIVISION OF LABOR SERVICES

5 a. For the division of labor services, including salaries,
6 support, maintenance, and miscellaneous purposes, and for not
7 more than the following full-time equivalent positions:

8 \$ 3,491,252
9 FTEs 58.00

10 b. From the contractor registration fees, the division of
11 labor services shall reimburse the department of inspections
12 and appeals for all costs associated with hearings under
13 chapter 91C, relating to contractor registration.

14 2. DIVISION OF WORKERS' COMPENSATION

15 a. For the division of workers' compensation, including
16 salaries, support, maintenance, and miscellaneous purposes, and
17 for not more than the following full-time equivalent positions:

18 \$ 3,321,044
19 FTEs 26.10

20 b. The division of workers' compensation shall charge a
21 \$100 filing fee for workers' compensation cases. The filing
22 fee shall be paid by the petitioner of a claim. However, the
23 fee can be taxed as a cost and paid by the losing party, except
24 in cases where it would impose an undue hardship or be unjust
25 under the circumstances. The moneys generated by the filing
26 fee allowed under this subsection are appropriated to the
27 department of workforce development to be used for purposes of
28 administering the division of workers' compensation.

29 3. WORKFORCE DEVELOPMENT OPERATIONS

30 a. For the operation of field offices, the workforce
31 development board, and for not more than the following
32 full-time equivalent positions:

33 \$ 6,675,650
34 FTEs 189.18

35 b. Of the moneys appropriated in paragraph "a", the

1 department shall allocate \$150,000 to the state library for the
2 purpose of licensing an online resource which prepares persons
3 to succeed in the workplace through programs which improve job
4 skills and vocational test-taking abilities.

5 4. OFFENDER REENTRY PROGRAM

6 a. For the development and administration of an offender
7 reentry program to provide offenders with employment skills,
8 and for not more than the following full-time equivalent
9 positions:

10	\$	387,158
11	FTEs	5.00

12 b. The department of workforce development shall partner
13 with the department of corrections to provide staff within the
14 correctional facilities to improve offenders' abilities to find
15 and retain productive employment.

16 5. INTEGRATED INFORMATION FOR IOWA SYSTEM

17 For the payment of services provided by the department of
18 administrative services related to the integrated information
19 for Iowa system:

20	\$	228,822

21 6. SUMMER YOUTH INTERN PILOT PROGRAM

22 For the funding of a summer youth intern pilot program that
23 will help young people at risk of not graduating from high
24 school to explore and prepare for high-demand careers through

32 Notwithstanding section 8.33, moneys appropriated in this
33 section that remain unencumbered or unobligated at the close of
34 the fiscal year shall not revert but shall remain available for
35 expenditure for the purposes designated until the close of the

1 succeeding fiscal year.

2 Sec. 11. GENERAL FUND — EMPLOYEE MISCLASSIFICATION
3 PROGRAM. There is appropriated from the general fund of the
4 state to the department of workforce development for the fiscal
5 year beginning July 1, 2021, and ending June 30, 2022, the
6 following amount, or so much thereof as is necessary, to be
7 used for the purposes designated:

8 For enhancing efforts to investigate employers that
9 misclassify workers and for not more than the following
10 full-time equivalent positions:

11	\$	379,631
12	FTEs	5.15

13 Sec. 12. SPECIAL EMPLOYMENT SECURITY CONTINGENCY FUND.

14 1. There is appropriated from the special employment
15 security contingency fund to the department of workforce
16 development for the fiscal year beginning July 1, 2021, and
17 ending June 30, 2022, the following amount, or so much thereof
18 as is necessary, to be used for field offices:

20 2. Any remaining additional penalty and interest revenue
21 collected by the department of workforce development is
22 appropriated to the department for the fiscal year beginning
23 July 1, 2021, and ending June 30, 2022, to accomplish the
24 mission of the department.

25 Sec. 13. FUTURE READY IOWA — IOWA EMPLOYER INNOVATION FUND.

26 1. There is appropriated from the general fund of the state
27 to the department of workforce development for the fiscal year
28 beginning July 1, 2021, and ending June 30, 2022, the following
29 amount, or so much thereof as is necessary, to be used for the
30 purposes designated:

31 In consultation with the workforce development board, for
32 funding of the Iowa employer innovation program which shall
33 match eligible employer moneys to expand opportunities for
34 education and training leading to high-demand jobs and to
35 encourage Iowa employers, community leaders, and others to

1 provide leadership and support for regional workforce talent
2 pools throughout the state, and for future ready Iowa education
3 and outreach:

4 \$ 4,200,000

5 Of the moneys appropriated in this subsection, an amount
6 to be determined by the department of workforce development
7 in consultation with the workforce development board shall be
8 transferred to the Iowa child care challenge fund.

9 2. Notwithstanding section 8.33, moneys appropriated in
10 this section which remain unencumbered or unobligated at the
11 end of the fiscal year shall not revert but shall remain
12 available for expenditure for the purposes designated until the
13 close of the succeeding fiscal year.

14 Sec. 14. UNEMPLOYMENT COMPENSATION RESERVE FUND —
15 FIELD OFFICES. Notwithstanding section 96.9, subsection 8,
16 paragraph "e", there is appropriated from interest earned on
17 the unemployment compensation reserve fund to the department
18 of workforce development for the fiscal year beginning July
19 1, 2021, and ending June 30, 2022, the following amount, or
20 so much thereof as is necessary, to be used for the purposes
21 designated:

22 For the operation of field offices:
23 \$ 2,200,000

24 Sec. 15. VIRTUAL ACCESS WORKFORCE DEVELOPMENT OFFICES. The
25 department of workforce development shall require a unique
26 identification login for all users of workforce development
27 centers operated through electronic means.

28 Sec. 16. UNEMPLOYMENT COMPENSATION PROGRAM. Notwithstanding
29 section 96.9, subsection 4, paragraph "a", moneys credited to
30 the state by the secretary of the treasury of the United
31 States pursuant to section 903 of the Social Security
32 Act are appropriated to the department of workforce
33 development and shall be used by the department for the
34 administration of the unemployment compensation program only.
35 This appropriation shall not apply to any fiscal year

1 beginning after December 31, 2021.

2 Sec. 17. IOWA SKILLED WORKER AND JOB CREATION FUND.

3 1. There is appropriated from the Iowa skilled worker and
4 job creation fund created in section 8.75 to the following
5 departments, agencies, and institutions for the fiscal year
6 beginning July 1, 2021, and ending June 30, 2022, the following
7 amounts, or so much thereof as is necessary, to be used for the
8 purposes designated:

9 a. ECONOMIC DEVELOPMENT AUTHORITY

10 (1) For the purposes of providing assistance as described in
11 section 15.335B for the high quality jobs program:

12 \$ 11,700,000

13 From the moneys appropriated in this subparagraph, the
14 economic development authority may use not more than \$1,000,000
15 for purposes of providing infrastructure grants to main street
16 communities under the main street Iowa program and may allocate
17 not more than \$300,000 for the purposes of supporting statewide
18 worker education and quality preapprenticeship programs.

19 (2) As a condition of receiving moneys appropriated in
20 this lettered paragraph "a", an entity shall testify upon the
21 request of the joint appropriations subcommittee on economic
22 development regarding the expenditure of such moneys.

23 b. STATE BOARD OF REGENTS AND REGENTS INSTITUTIONS

24 (1) STATE BOARD OF REGENTS. For capacity building
25 infrastructure in areas related to technology
26 commercialization, marketing and business development
27 efforts in areas related to technology commercialization,
28 entrepreneurship, and business growth, and infrastructure
29 projects and programs needed to assist in implementation of
30 activities under chapter 262B:

31 \$ 3,000,000

32 (a) Of the moneys appropriated pursuant to this
33 subparagraph (1), 35 percent shall be allocated for Iowa state
34 university of science and technology, 35 percent shall be
35 allocated for the state university of Iowa, and 30 percent

1 shall be allocated for the university of northern Iowa.

5 DIVISION I — FY 2021-2022 APPROPRIATIONS. This bill
6 appropriates moneys for the fiscal year 2021-2022 from the
7 general fund of the state to the department of cultural
8 affairs, the economic development authority, the Iowa
9 finance authority, the public employment relations board, the
10 department of workforce development, Iowa state university of
11 science and technology, the state university of Iowa, and the
12 university of northern Iowa.

13 The bill appropriates moneys for the fiscal year 2021-2022
14 from the Iowa skilled worker and job creation fund created in
15 Code section 8.75 to the economic development authority, the
16 department of workforce development, and the state board of
17 regents and institutions under the control of the board.

18 For the fiscal year 2021-2022, the bill limits standing
19 appropriations established in the Code for the world food
20 prize, certain operational support grants, community cultural
21 grants, and regional tourism marketing.

22 The bill transfers \$100,000 of the moneys collected by the
23 insurance division in excess of the anticipated gross revenues
24 under Code section 505.7 to the economic development authority.

25 The bill appropriates moneys for the fiscal year 2021-2022
26 from the special employment security contingency fund to the
27 department of workforce development.

28 The bill appropriates interest earned on the unemployment
29 compensation reserve fund for the fiscal year 2021-2022 to the
30 department of workforce development.

31 Moneys credited to the state by the secretary of treasury
32 of the United States pursuant to section 903 of the Social
33 Security Act are appropriated to the department of workforce
34 development.

35 The auditor of state is requested to review the audit of the

1 Iowa finance authority performed by the auditor hired by the
2 authority.

3 The bill requires the economic development authority and the
4 department of revenue to submit a joint annual report to the
5 general assembly by November 1, 2021, detailing all financial
6 assistance awarded in the prior fiscal year.

7 DIVISION II — BEER AND LIQUOR CONTROL FUND — TOURISM. The
8 bill requires the department of commerce to transfer to the
9 economic development authority from the beer and liquor control
10 fund \$1 million annually for a statewide tourism marketing
11 campaign. The transfer occurs after certain specified
12 transfers from the fund and before other specified transfers.

13 As part of the tourism marketing campaign, the authority
14 must issue a single request for proposals to select an entity
15 located in this state for a statewide effort to leverage public
16 and private partnerships to market and promote the state as a
17 travel destination.
