A BILL FOR

1 An Act relating to controlled substances and precursor
2 substances, including amending the controlled substance and
3 precursor substances schedules and including effective date
4 provisions.

7 The inclusion of this explanation does not constitute agreement with
8 the explanation's substance by the members of the general assembly.

9 This bill relates to controlled substances and precursor
10 substances, including amending the controlled substance and
11 precursor substances schedules and including effective date
12 provisions.

13 The bill makes changes in Iowa's uniform controlled
14 substances Act (Code chapter 124) and precursor substances
15 (Code chapter 124B) to conform to the specific chemical
16 designations of the substances contained in Title 21 of
17 the Code of Federal Regulations (C.F.R.), parts 1300, 1308,
18 and 1310. The changes include changing some parentheses to
19 brackets, adding or removing hyphens, and adding or removing
20 spaces. Additionally, some substances have been moved from the
21 current location in the Code to a location which corresponds
22 to those under federal law. Fourteen new substances were
23 added to the schedule I opiates category, including acetyl
24 fentanyl which was moved from the "other substances" category.
25 Marijuana extract, synthetic cathinone, and 21 other substances
26 were added to the schedule I, hallucinogenic substances
27 category.

28 The bill takes effect upon enactment.
