1 An Act relating to appropriations to the justice system and
2 including effective date provisions.

Section 1. DEPARTMENT OF JUSTICE.

1. There is appropriated from the general fund of the state to the department of justice for the fiscal year beginning July 1, 2021, and ending June 30, 2022, the following amounts, or so much thereof as is necessary, to be used for the purposes designated:

a. For the general office of attorney general for salaries, support, maintenance, and miscellaneous purposes, including the prosecuting attorneys training program, matching funds for federal violence against women grant programs, victim assistance grants, the office of drug control policy prosecuting attorney program, and odometer fraud enforcement:
..... \$ 6,006,268

As a condition of receiving the appropriation provided in this lettered paragraph, the department of justice shall maintain a record of the estimated time incurred representing each agency or department.

The general office of attorney general may temporarily exceed and draw more than the amount appropriated in this lettered paragraph and incur a negative cash balance as long as there are receivables equal to or greater than the negative balances and the amount appropriated in this lettered paragraph is not exceeded at the close of the fiscal year.

b. For victim assistance grants:
..... \$ 5,016,708

The moneys appropriated in this lettered paragraph shall be used to provide grants to care providers providing services to crime victims of domestic abuse or to crime victims of rape and sexual assault.

The balance of the victim compensation fund established in section 915.94 may be used to provide salary and support of not more than 24.00 full-time equivalent positions and to provide maintenance for the victim compensation functions

1 of the department of justice. In addition to the full-time
2 equivalent positions authorized pursuant to this paragraph,
3 5.00 full-time equivalent positions are authorized and shall
4 be used by the department of justice to employ one accountant
5 and four program planners. The department of justice may
6 employ the additional 5.00 full-time equivalent positions
7 authorized pursuant to this paragraph that are in excess of the
8 number of full-time equivalent positions authorized only if
9 the department of justice receives sufficient federal moneys
10 to maintain employment for the additional full-time equivalent
11 positions during the current fiscal year. The department
12 of justice shall only employ the additional 5.00 full-time
13 equivalent positions in succeeding fiscal years if sufficient
14 federal moneys are received during each succeeding fiscal year.

15 The department of justice shall transfer at least \$150,000
16 from the victim compensation fund established in section 915.94
17 to the victim assistance grant program established in section
18 13.31.

19 Notwithstanding section 8.33, moneys appropriated in this
20 lettered paragraph that remain unencumbered or unobligated at
21 the close of the fiscal year shall not revert but shall remain
22 available for expenditure for the purposes designated until the
23 close of the succeeding fiscal year.

24 c. For legal services for persons in poverty grants as
25 provided in section 13.34:

26 \$ 2,634,601

27 2. a. The department of justice, in submitting budget
28 estimates for the fiscal year beginning July 1, 2022, pursuant
29 to section 8.23, shall include a report of funding from sources
30 other than amounts appropriated directly from the general fund
31 of the state to the department of justice or to the office of
32 consumer advocate. These funding sources shall include but
33 are not limited to reimbursements from other state agencies,
34 commissions, boards, or similar entities, and reimbursements
35 from special funds or internal accounts within the department

1 of justice. The department of justice shall also report actual
2 reimbursements for the fiscal year beginning July 1, 2020,
3 and actual and expected reimbursements for the fiscal year
4 beginning July 1, 2021.

5 b. The department of justice shall include the report
6 required under paragraph "a", as well as information regarding
7 any revisions occurring as a result of reimbursements actually
8 received or expected at a later date, in a report to the
9 co-chairpersons and ranking members of the joint appropriations
10 subcommittee on the justice system and the legislative services
11 agency. The department of justice shall submit the report on
12 or before January 15, 2022.

13 3. a. The department of justice shall fully reimburse
14 the costs and necessary related expenses incurred by the Iowa
15 law enforcement academy to continue to employ one additional
16 instructor position who shall provide training for human
17 trafficking-related issues throughout the state.

18 b. The department of justice shall obtain the moneys
19 necessary to reimburse the Iowa law enforcement academy to
20 employ such an instructor from unrestricted moneys from either
21 the victim compensation fund established in section 915.94, the
22 human trafficking victim fund established in section 915.95, or
23 the human trafficking enforcement fund established in 2015 Iowa
24 Acts, chapter 138, section 141.

25 4. REPORT OF MONEY AWARDS. The attorney general shall
26 submit a report to the general assembly and the department of
27 management all money settlement awards and court money awards
28 which were awarded to the state of Iowa. The attorney general
29 shall report which funds are designated to receive the moneys
30 and under what legal authority the designation is being made.
31 Reports must be submitted within 30 days following a money
32 settlement award or a court money award.

33 Sec. 2. OFFICE OF CONSUMER ADVOCATE. There is appropriated
34 from the department of commerce revolving fund created in
35 section 546.12 to the office of consumer advocate of the

1 department of justice for the fiscal year beginning July 1,
2 2021, and ending June 30, 2022, the following amount, or so
3 much thereof as is necessary, to be used for the purposes
4 designated:

5 For salaries, support, maintenance, and miscellaneous
6 purposes:

7 \$ 3,137,588

8 Sec. 3. DEPARTMENT OF CORRECTIONS — FACILITIES.

9 1. There is appropriated from the general fund of the state
10 to the department of corrections for the fiscal year beginning
11 July 1, 2021, and ending June 30, 2022, the following amounts,
12 or so much thereof as is necessary, to be used for the purposes
13 designated:

14 a. For the operation of the Fort Madison correctional
15 facility, including salaries, support, maintenance, and
16 miscellaneous purposes:

17 \$ 41,647,701

18 b. For the operation of the Anamosa correctional facility,
19 including salaries, support, maintenance, and miscellaneous
20 purposes:

21 \$ 32,868,225

22 c. For the operation of the Oakdale correctional facility,
23 including salaries, support, maintenance, and miscellaneous
24 purposes:

25 \$ 62,610,335

26 d. For the operation of the Newton correctional facility,
27 including salaries, support, maintenance, and miscellaneous
28 purposes:

29 \$ 28,818,686

30 e. For the operation of the Mount Pleasant correctional
31 facility, including salaries, support, maintenance, and
32 miscellaneous purposes:

33 \$ 26,177,884

34 f. For the operation of the Rockwell City correctional
35 facility, including salaries, support, maintenance, and

1 miscellaneous purposes:

2 \$ 10,623,767

3 g. For the operation of the Clarinda correctional facility,
4 including salaries, support, maintenance, and miscellaneous
5 purposes:

6 \$ 25,132,431

7 Moneys received by the department of corrections as
8 reimbursement for services provided to the Clarinda youth
9 corporation are appropriated to the department and shall be
10 used for the purpose of operating the Clarinda correctional
11 facility.

12 h. For the operation of the Mitchellville correctional
13 facility, including salaries, support, maintenance, and
14 miscellaneous purposes:

15 \$ 23,483,038

16 i. For the operation of the Fort Dodge correctional
17 facility, including salaries, support, maintenance, and
18 miscellaneous purposes:

19 \$ 30,324,956

20 j. For reimbursement of counties for temporary confinement
21 of prisoners, as provided in sections 901.7, 904.908, and
22 906.17, and for offenders confined pursuant to section 904.513:

24 k. For federal prison reimbursement, reimbursements for
25 out-of-state placements, and miscellaneous contracts:

27 2. The department of corrections shall use moneys
28 appropriated in subsection 1 to continue to contract for the
29 services of a Muslim imam and a Native American spiritual
30 leader.

31 Sec. 4. DEPARTMENT OF CORRECTIONS — ADMINISTRATION.

32 There is appropriated from the general fund of the state to the
33 department of corrections for the fiscal year beginning July
34 1, 2021, and ending June 30, 2022, the following amounts, or
35 so much thereof as is necessary, to be used for the purposes

1 designated:

2 1. For general administration, including salaries and the
3 adjustment of salaries throughout the department, support,
4 maintenance, employment of an education director to administer
5 a centralized education program for the correctional system,
6 and miscellaneous purposes:

7 \$ 5,473,325

8 a. It is the intent of the general assembly that each
9 lease negotiated by the department of corrections with a
10 private corporation for the purpose of providing private
11 industry employment of inmates in a correctional institution
12 shall prohibit the private corporation from utilizing inmate
13 labor for partisan political purposes for any person seeking
14 election to public office in this state and that a violation
15 of this requirement shall result in a termination of the lease
16 agreement.

17 b. It is the intent of the general assembly that as a
18 condition of receiving the appropriation provided in this
19 subsection the department of corrections shall not enter into
20 a lease or contractual agreement pursuant to section 904.809
21 with a private corporation for the use of building space for
22 the purpose of providing inmate employment without providing
23 that the terms of the lease or contract establish safeguards to
24 restrict, to the greatest extent feasible, access by inmates
25 working for the private corporation to personal identifying
26 information of citizens.

27 2. For educational programs for inmates at state penal
28 institutions:

29 \$ 2,608,109

30 a. To maximize the funding for educational programs,
31 the department shall establish guidelines and procedures to
32 prioritize the availability of educational and vocational
33 training for inmates based upon the goal of facilitating an
34 inmate's successful release from the correctional institution.

35 b. The director of the department of corrections may

1 transfer moneys from Iowa prison industries and the canteen
2 operating funds established pursuant to section 904.310, for
3 use in educational programs for inmates.

4 c. Notwithstanding section 8.33, moneys appropriated in
5 this subsection that remain unencumbered or unobligated at the
6 close of the fiscal year shall not revert but shall remain
7 available to be used only for the purposes designated in this
8 subsection until the close of the succeeding fiscal year.

9 3. For the development and operation of the Iowa corrections
10 offender network (ICON) data system:

11 \$ 2,000,000

12 4. For offender mental health and substance abuse
13 treatment:

14 \$ 28,065

15 5. For department-wide duties, including operations, costs,
16 and miscellaneous purposes:

17 \$ 5,000,000

18 Sec. 5. JUDICIAL DISTRICT DEPARTMENTS OF CORRECTIONAL
19 SERVICES.

20 1. There is appropriated from the general fund of the state
21 to the department of corrections for the fiscal year beginning
22 July 1, 2021, and ending June 30, 2022, for salaries, support,
23 maintenance, and miscellaneous purposes, the following amounts,
24 or so much thereof as is necessary, to be used for the purposes
25 designated:

26 a. For the first judicial district department of
27 correctional services:

28 \$ 15,219,261

29 It is the intent of the general assembly that the first
30 judicial district department of correctional services maintains
31 the drug courts operated by the district department.

32 b. For the second judicial district department of
33 correctional services:

34 \$ 11,758,160

35 It is the intent of the general assembly that the second

1 judicial district department of correctional services maintains
2 two drug courts to be operated by the district department.

3 c. For the third judicial district department of
4 correctional services:
5 \$ 7,324,425

6 d. For the fourth judicial district department of
7 correctional services:
8 \$ 5,815,391

9 e. For the fifth judicial district department of
10 correctional services, including funding for electronic
11 monitoring devices for use on a statewide basis:
12 \$ 22,008,023

13 It is the intent of the general assembly that the fifth
14 judicial district department of correctional services maintains
15 the drug court operated by the district department.

16 f. For the sixth judicial district department of
17 correctional services:
18 \$ 15,069,674

19 It is the intent of the general assembly that the sixth
20 judicial district department of correctional services maintains
21 the drug court operated by the district department.

22 g. For the seventh judicial district department of
23 correctional services:
24 \$ 8,013,609

25 It is the intent of the general assembly that the seventh
26 judicial district department of correctional services maintains
27 the drug court operated by the district department.

28 h. For the eighth judicial district department of
29 correctional services:
30 \$ 8,547,829

31 2. There is appropriated from the general fund of the state
32 to the department of corrections for the fiscal year beginning
33 July 1, 2021, and ending June 30, 2022, the following amount,
34 or so much thereof as is necessary, to be used for the purposes
35 designated:

1 For statewide judicial assistance, support, and pilot
2 projects for judicial district departments of correctional
3 services:

4 \$ 663,219

5 3. Each judicial district department of correctional
6 services, within the moneys available, shall continue programs
7 and plans established within that district to provide for
8 intensive supervision, sex offender treatment, diversion of
9 low-risk offenders to the least restrictive sanction available,
10 job development, and expanded use of intermediate criminal
11 sanctions.

12 4. Each judicial district department of correctional
13 services shall provide alternatives to prison consistent with
14 chapter 901B. The alternatives to prison shall ensure public
15 safety while providing maximum rehabilitation to the offender.
16 A judicial district department of correctional services may
17 also establish a day program.

18 5. The governor's office of drug control policy shall
19 consider federal grants made to the department of corrections
20 for the benefit of each of the eight judicial district
21 departments of correctional services as local government
22 grants, as defined pursuant to federal regulations.

23 6. The department of corrections shall continue to contract
24 with a judicial district department of correctional services to
25 provide for the rental of electronic monitoring equipment which
26 shall be available statewide.

27 7. The public safety assessment shall not be utilized
28 in pretrial hearings when determining whether to detain or
29 release a defendant before trial, and the use of the public
30 safety assessment pilot program shall be terminated as of the
31 effective date of this subsection, until such time the use of
32 the public safety assessment has been specifically authorized
33 by the general assembly.

34 Sec. 6. DEPARTMENT OF CORRECTIONS — REALLOCATION OF
35 APPROPRIATIONS. Notwithstanding section 8.39, within the

1 moneys appropriated in this division of this Act to the
2 department of corrections, the department may reallocate the
3 moneys appropriated and allocated as necessary to best fulfill
4 the needs of the correctional institutions, administration
5 of the department, and the judicial district departments of
6 correctional services. However, in addition to complying with
7 the requirements of sections 904.116 and 905.8 and providing
8 notice to the legislative services agency, the department
9 of corrections shall also provide notice to the department
10 of management, prior to the effective date of the revision
11 or reallocation of an appropriation made pursuant to this
12 section. The department of corrections shall not reallocate an
13 appropriation or allocation for the purpose of eliminating any
14 program.

15 Sec. 7. INTENT — REPORTS.

16 1. The department of corrections, in cooperation with
17 townships, the Iowa cemetery associations, and other nonprofit
18 or governmental entities, may use inmate labor during the
19 fiscal year beginning July 1, 2021, to restore or preserve
20 rural cemeteries and historical landmarks. The department, in
21 cooperation with the counties, may also use inmate labor to
22 clean up roads, major water sources, and other water sources
23 around the state.

24 2. On a quarterly basis, the department shall provide
25 a status report regarding private-sector employment to the
26 legislative services agency beginning on July 1, 2021. The
27 report shall include the number of offenders employed in the
28 private sector, the combined number of hours worked by the
29 offenders, the total amount of allowances, and the distribution
30 of allowances pursuant to section 904.702, including any moneys
31 deposited in the general fund of the state.

32 Sec. 8. ELECTRONIC MONITORING REPORT. The department of
33 corrections shall submit a report on electronic monitoring to
34 the general assembly, to the co-chairpersons and the ranking
35 members of the joint appropriations subcommittee on the justice

1 system, and to the legislative services agency by January
2 15, 2022. The report shall specifically address the number
3 of persons being electronically monitored and break down the
4 number of persons being electronically monitored by offense
5 committed. The report shall also include a comparison of any
6 data from the prior fiscal year with the current fiscal year.

7 Sec. 9. STATE AGENCY PURCHASES FROM PRISON INDUSTRIES.

8 1. As used in this section, unless the context otherwise
9 requires, "state agency" means the government of the state
10 of Iowa, including but not limited to all executive branch
11 departments, agencies, boards, bureaus, and commissions, the
12 judicial branch, the general assembly and all legislative
13 agencies, institutions within the purview of the state board of
14 regents, and any corporation whose primary function is to act
15 as an instrumentality of the state.

16 2. State agencies are encouraged to purchase products from
17 Iowa state industries, as defined in section 904.802, when
18 purchases are required and the products are available from
19 Iowa state industries. State agencies shall obtain bids from
20 Iowa state industries for purchases of office furniture during
21 the fiscal year beginning July 1, 2021, exceeding \$5,000 or
22 in accordance with applicable administrative rules related to
23 purchases for the agency.

24 Sec. 10. IOWA LAW ENFORCEMENT ACADEMY.

25 1. There is appropriated from the general fund of the
26 state to the Iowa law enforcement academy for the fiscal year
27 beginning July 1, 2021, and ending June 30, 2022, the following
28 amount, or so much thereof as is necessary, to be used for the
29 purposes designated:

30 a. For salaries, support, maintenance, and miscellaneous
31 purposes, including jailer training and technical assistance:
32 \$ 1,193,868

33 b. The Iowa law enforcement academy may temporarily exceed
34 and draw more than the amount appropriated in this subsection
35 and incur a negative cash balance as long as there are

1 receivables equal to or greater than the negative balance and
2 the amount appropriated in this subsection is not exceeded at
3 the close of the fiscal year.

4 2. The Iowa law enforcement academy may select at least
5 five automobiles of the department of public safety, division
6 of state patrol, prior to turning over the automobiles to
7 the department of administrative services to be disposed
8 of by public auction, and the Iowa law enforcement academy
9 may exchange any automobile owned by the academy for each
10 automobile selected if the selected automobile is used in
11 training law enforcement officers at the academy. However, any
12 automobile exchanged by the academy shall be substituted for
13 the selected vehicle of the department of public safety and
14 sold by public auction with the receipts being deposited in the
15 depreciation fund maintained pursuant to section 8A.365 to the
16 credit of the department of public safety, division of state
17 patrol.

18 3. The Iowa law enforcement academy shall provide training
19 for domestic abuse and human trafficking-related issues
20 throughout the state. The training shall be offered at no
21 cost to the attendees and the training shall not replace any
22 existing domestic abuse or human trafficking training offered
23 by the academy.

24 Sec. 11. STATE PUBLIC DEFENDER. There is appropriated from
25 the general fund of the state to the office of the state public
26 defender of the department of inspections and appeals for the
27 fiscal year beginning July 1, 2021, and ending June 30, 2022,
28 the following amounts, or so much thereof as is necessary, to
29 be used for the purposes designated:

30 1. For salaries, support, maintenance, and miscellaneous
31 purposes:
32 \$ 27,144,382

33 2. For payments on behalf of eligible adults and juveniles
34 from the indigent defense fund, in accordance with section
35 815.11:

1 \$ 40,760,448

2 Sec. 12. BOARD OF PAROLE. There is appropriated from the
3 general fund of the state to the board of parole for the fiscal
4 year beginning July 1, 2021, and ending June 30, 2022, the
5 following amount, or so much thereof as is necessary, to be
6 used for the purposes designated:

7 For salaries, support, maintenance, and miscellaneous
8 purposes:

9 \$ 1,240,265

10 Sec. 13. DEPARTMENT OF PUBLIC DEFENSE.

11 1. There is appropriated from the general fund of the
12 state to the department of public defense, for the fiscal year
13 beginning July 1, 2021, and ending June 30, 2022, the following
14 amount, or so much thereof as is necessary, to be used for the
15 purposes designated:

16 For salaries, support, maintenance, and miscellaneous
17 purposes:

18 \$ 6,678,140

19 2. The department of public defense may temporarily exceed
20 and draw more than the amount appropriated in this section and
21 incur a negative cash balance as long as there are receivables
22 of federal funds equal to or greater than the negative balance
23 and the amount appropriated in this section is not exceeded at
24 the close of the fiscal year.

25 Sec. 14. DEPARTMENT OF HOMELAND SECURITY AND EMERGENCY
26 MANAGEMENT.

27 1. There is appropriated from the general fund of the state
28 to the department of homeland security and emergency management
29 for the fiscal year beginning July 1, 2021, and ending June 30,
30 2022, the following amount, or so much thereof as is necessary,
31 to be used for the purposes designated:

32 For salaries, support, maintenance, and miscellaneous
33 purposes:

34 \$ 2,139,390

35 2. The department of homeland security and emergency

1 management may temporarily exceed and draw more than the amount
2 appropriated in this section and incur a negative cash balance
3 as long as there are receivables of federal funds equal to or
4 greater than the negative balance and the amount appropriated
5 in this section is not exceeded at the close of the fiscal
6 year.

7 Sec. 15. DEPARTMENT OF PUBLIC SAFETY. There is appropriated
8 from the general fund of the state to the department of public
9 safety for the fiscal year beginning July 1, 2021, and ending
10 June 30, 2022, the following amounts, or so much thereof as is
11 necessary, to be used for the purposes designated:

12 1. For administrative functions, including salaries and
13 the adjustment of salaries throughout the department, and the
14 criminal justice information system:

15 \$ 5,591,361

16 2. For the division of criminal investigation, including
17 the state's contribution to the peace officers' retirement,
18 accident, and disability system provided in chapter 97A in the
19 amount of the state's normal contribution rate, as defined
20 in section 97A.8, multiplied by the salaries for which the
21 moneys are appropriated, and to meet federal fund matching
22 requirements:

23 \$ 17,576,601

24 3. For the criminalistics laboratory fund created in
25 section 691.9:

26 \$ 650,000

27 Notwithstanding section 8.33, moneys appropriated in this
28 subsection that remain unencumbered or unobligated at the close
29 of the fiscal year shall not revert but shall remain available
30 for expenditure for the purposes designated until the close of
31 the succeeding fiscal year.

32 4. a. For the division of narcotics enforcement, including
33 the state's contribution to the peace officers' retirement,
34 accident, and disability system provided in chapter 97A in the
35 amount of the state's normal contribution rate, as defined

1 in section 97A.8, multiplied by the salaries for which the
2 moneys are appropriated, and to meet federal fund matching
3 requirements:

4 \$ 8,124,117

5 b. For the division of narcotics enforcement for undercover
6 purchases:

7 \$ 209,042

8 5. For the division of state fire marshal, for fire
9 protection services as provided through the state fire service
10 and emergency response council as created in the department,
11 and for the state's contribution to the peace officers'
12 retirement, accident, and disability system provided in chapter
13 97A in the amount of the state's normal contribution rate, as
14 defined in section 97A.8, multiplied by the salaries for which
15 the moneys are appropriated:

16 \$ 5,231,360

17 6. For the division of state patrol, for salaries, support,
18 maintenance, workers' compensation costs, and miscellaneous
19 purposes, including the state's contribution to the peace
20 officers' retirement, accident, and disability system provided
21 in chapter 97A in the amount of the state's normal contribution
22 rate, as defined in section 97A.8, multiplied by the salaries
23 for which the moneys are appropriated:

24 \$ 66,037,699

25 It is the intent of the general assembly that members of the
26 state patrol be assigned to patrol the highways and roads in
27 lieu of assignments for inspecting school buses for the school
28 districts.

29 7. For deposit in the sick leave benefits fund established
30 in section 80.42 for all departmental employees eligible to
31 receive benefits for accrued sick leave under the collective
32 bargaining agreement:

34 8. For costs associated with the training and equipment
35 needs of volunteer fire fighters:

2 Notwithstanding section 8.33, moneys appropriated in this
3 subsection that remain unencumbered or unobligated at the
4 close of the fiscal year shall not revert but shall remain
5 available for expenditure only for the purpose designated in
6 this subsection until the close of the succeeding fiscal year.

7 9. For the public safety interoperable and broadband
8 communications fund established in section 80.44:

9 \$ 115,661

10 10. For the office to combat human trafficking established
11 pursuant to section 80.45, including salaries, support,
12 maintenance, and miscellaneous purposes:

13 \$ 340,000

14 11. For department-wide duties, including operations,
15 costs, and miscellaneous purposes:

17 12. For costs associated with the training and equipment
18 needs of volunteer fire fighters:

19 \$ 50,000

20 Notwithstanding section 8.39, the department of public
21 safety may reallocate moneys appropriated in this section
22 as necessary to best fulfill the needs provided for in the
23 appropriation. However, the department shall not reallocate
24 moneys appropriated to the department in this section unless
25 notice of the reallocation is given to the legislative services
26 agency and the department of management prior to the effective
27 date of the reallocation. The notice shall include information
28 regarding the rationale for reallocating the moneys. The
29 department shall not reallocate moneys appropriated in this
30 section for the purpose of eliminating any program.

31 Sec. 16. GAMING ENFORCEMENT.

32 1. There is appropriated from the gaming enforcement
33 revolving fund created in section 80.43 to the department of
34 public safety for the fiscal year beginning July 1, 2021, and
