A BILL FOR

- 1 An Act authorizing certain motor vehicles to display one
- 2 registration plate.
- 3 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

- 1 Section 1. Section 321.37, subsection 2, Code 2022, is
- 2 amended to read as follows:
- 3 2. a. Registration plates issued for a motor vehicle
- 4 which is model year 1948 or older, and reconstructed or
- 5 specially constructed vehicles built to resemble a model year
- 6 1948 vehicle or older, Notwithstanding subsection 1, any of
- 7 the following motor vehicles, other than a truck registered
- 8 for more than five tons, autocycle, motorcycle, or truck
- 9 tractor, may display one registration plate on the rear of the
- 10 vehicle if the other registration plate issued to the vehicle
- ll is carried in the vehicle at all times when the vehicle is
- 12 operated on a public highway.:
- 13 (1) A vintage motor vehicle.
- 14 (2) A reconstructed or specially constructed vehicle built
- 15 to resemble a vintage motor vehicle.
- 16 (3) A limited-production motor vehicle.
- 17 b. As used in this subsection:
- 18 (1) "Limited-production motor vehicle" means a motor vehicle
- 19 with a specific make, model, and trim level, if the trim level
- 20 has a different engine than the base model, of which ten
- 21 thousand or fewer vehicles of that make, model, and trim level
- 22 were manufactured in the year the motor vehicle was produced,
- 23 as determined by the department.
- 24 (2) "Vintage motor vehicle" means a motor vehicle which is
- 25 model year 1979 or older.
- 26 EXPLANATION
- The inclusion of this explanation does not constitute agreement with the explanation's substance by the members of the general assembly.
- 29 Under current law, registration plates issued for a motor
- 30 vehicle other than an autocycle, motorcycle, motorized bicycle,
- 31 or truck tractor must be attached to the motor vehicle, one
- 32 in the front and the other in the rear. However, a motor
- 33 vehicle which is model year 1948 or older, or a reconstructed
- 34 or specially constructed vehicle built to resemble a model
- 35 year 1948 or older vehicle, other than a truck registered for

- 1 more than five tons, autocycle, motorcycle, or truck tractor
- 2 (autocycles, motorcycles, and truck tractors are all issued
- 3 only one registration plate), may display one registration
- 4 plate on the rear of the vehicle if the other registration
- 5 plate is carried in the vehicle when the vehicle is operated on
- 6 a public highway.
- 7 This bill authorizes a vintage motor vehicle, a
- 8 reconstructed or specially constructed vehicle built to
- 9 resemble a vintage motor vehicle, and a limited-production
- 10 motor vehicle to display one registration plate on the rear of
- 11 the vehicle if the other registration plate is carried in the
- 12 vehicle when the vehicle is operated on a public highway.
- 13 The bill defines "vintage motor vehicle" as a motor vehicle
- 14 which is model year 1979 or older and "limited-production motor
- 15 vehicle" as a motor vehicle with a specific make, model, and
- 16 trim level, if the trim level has a different engine than
- 17 the base model, of which 10,000 or fewer vehicles of that
- 18 make, model, and trim level were manufactured in the year the
- 19 motor vehicle was produced, as determined by the department of
- 20 transportation. The bill makes organizational changes to Code
- 21 section 321.37(2).
