- 1 Section 1. Section 445.5, subsection 1, Code 2024, is
- 2 amended by adding the following new paragraphs:
- 3 NEW PARAGRAPH. j. (1) A statement of how much less funding
- 4 the titleholder's school district received in the current
- 5 school year from the previous school year as a result of
- 6 students receiving education savings account payments pursuant
- 7 to section 257.11B if such a reduction of funding exists.
- 8 (2) The department of management shall make all
- 9 calculations necessary to determine the information required
- 10 to be disclosed pursuant to subparagraph (1) and transmit such
- 11 information to the treasurer in a timely manner.
- 12 NEW PARAGRAPH. k. (1) A statement of how much of the
- 13 titleholder's state income taxes have been used to fund the
- 14 education savings account program established in section
- 15 257.11B.
- 16 (2) The department of management and the department of
- 17 revenue shall collaborate to make all calculations necessary
- 18 to determine the information required to be disclosed pursuant
- 19 to subparagraph (1) and the department of management shall
- 20 transmit such information to the treasurer in a timely manner.
- 21 NEW PARAGRAPH. 1. (1) The following or substantially
- 22 similar statement:
- 23 The gross reduction in state funding to your school district
- 24 in (the current school year) as a result of students receiving
- 25 education savings account payments is (amount).
- 26 (2) The department of management shall make all
- 27 calculations necessary to determine the information required
- 28 to be disclosed pursuant to subparagraph (1) and transmit such
- 29 information to the treasurer in a timely manner.
- 30 EXPLANATION
- 31 The inclusion of this explanation does not constitute agreement with
- 32 the explanation's substance by the members of the general assembly.

      The bill requires each statement of tax due and payable
 2 by a titleholder to include information concerning how much
 3 less funding the titleholder's school district received in the
 4 current school year from the previous school year as a result
 5 of students receiving payments through the education savings
 6 account (ESA) program if such a reduction of funding exists; a
 7 statement of how much of the titleholder's state income taxes
 8 have been used to fund the ESA program; and the following or
 9 substantially similar language: "The gross reduction in state
10 funding to your school district in (the current school year)
11 as a result of students receiving education savings account
12 payments is (amount)."

      The bill requires the department of management (DOM) to
14 make all calculations necessary to determine the information
15 required to be disclosed to a titleholder concerning reductions
16 to the titleholder's school district due to students receiving
17 payments through the ESA program, requires DOM and the
18 department of revenue to collaborate to make calculations
19 necessary to determine information required to be disclosed to
20 a titleholder concerning the titleholder's total payments of
21 income taxes used to fund the ESA program, and requires DOM to
22 transmit such information to the treasurer in a timely manner.
