      Section 1. Section 708.7, subsection 1, paragraph a,
 2 subparagraph (5), Code 2024, is amended to read as follows:
      (5) Disseminates, publishes, distributes, posts, or

 4 causes to be disseminated, published, distributed, or posted a
 5 photograph or film visual depiction as defined in section 728.1
 6 showing another person in a state of full or partial nudity or
 7 engaged in a sex act, knowing that the other person has not
 8 consented to the dissemination, publication, distribution,
 9 or posting. For purposes of this section, "another person"
10 includes an individual, recognizable by the person's face,
11 likeness, or other distinguishing features, whose image is used
12 to create, adapt, or modify a visual depiction to depict that

      This bill relates to harassment by the dissemination,

      Current law provides that a person commits harassment when,
23 with intent to intimidate, annoy, or alarm another person,
24 the person disseminates, publishes, distributes, posts, or
25 causes to be disseminated, published, distributed, or posted a
26 photograph or film showing another person in a state of full or
27 partial nudity or engaged in a sex act, knowing that the other
28 person has not consented to the dissemination, publication,
29 distribution, or posting.

      The bill provides that "another person" includes an
31 individual, recognizable by the person's face, likeness, or
32 other distinguishing features, whose image is used to create,
33 adapt, or modify a visual depiction to depict that other person
34 as being in a state of full or partial nudity or engaged in a

- "Visual depiction" is defined in Code chapter 728
- 2 (obscenity) to include any picture, slide, photograph,
- 3 digital or electronic image, negative image, undeveloped film,
- 4 motion picture, videotape, digital or electronic recording,
- 5 live transmission, or other pictorial or three-dimensional
- 6 representation.
- 7 A violation of Code section 708.7(1)(a)(5) is harassment
- 8 in the first degree and is an aggravated misdemeanor. An
- 9 aggravated misdemeanor is punishable by confinement for no more
- 10 than two years and a fine of at least \$855 but not more than
- 11 \$8,540.
