## A BILL FOR

- 1 An Act relating to the therapeutic classroom incentive program
- 2 by authorizing the expenditure of moneys for certain
- 3 nutritional items and making appropriations.
- 4 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

1 Section 1. Section 256.25, subsection 7, Code 2024, is 2 amended to read as follows: 7. For purposes of this section, "therapeutic classroom" 3 4 means a classroom designed for the purpose of providing support 5 for any student whose emotional, social, or behavioral needs 6 interfere with the student's ability to be successful in the 7 current educational environment, with or without supports, 8 until the student is able to successfully return to the 9 student's current education environment, with or without 10 supports, including but not limited to the general education 11 classroom. The support provided by a therapeutic classroom 12 shall also include all of the following: 13 a. Supporting student access to micronutrients, vitamin 14 supplementation, and mineral supplementation, including vitamin 15 "D" and vitamin "K2". 16 b. Assessing the macro-nutritional needs of students. c. Providing minimally processed whole foods, including 17 18 fresh fruits, fresh vegetables, and healthy animal-derived fats 19 and proteins, including eggs, full-fat dairy products, beef, 20 and bacon. 21 Restricting the use and availability of artificial or d. 22 synthetic food additives that may have an adverse effect on 23 activity and attention in students. 24 e. Remediating the negative impacts of excessive use of 25 digital screens and devices on human biology. 26 f. Increasing student exposure to natural light or the light 27 emitted by full spectrum lighting fixtures. g. Carrying out any other scientifically supported 28 29 initiative that a school district reasonably believes will 30 improve emotional, social, and behavioral health outcomes among 31 students. 32 Sec. 2. DEPARTMENT OF EDUCATION — THERAPEUTIC CLASSROOM 33 INCENTIVE GRANT PROGRAM. There is appropriated from the 34 general fund of the state to the department of education for 35 the fiscal year beginning July 1, 2024, and ending June 30,

9 This bill relates to the therapeutic classroom incentive 10 program by authorizing the expenditure of moneys for certain 11 nutritional items. The therapeutic classroom incentive 12 program, administered by the department of education, provides 13 competitive grants to school districts to establish classrooms 14 that are designed for the purpose of providing support for any 15 student whose emotional, social, or behavioral needs interfere 16 with the student's ability to be successful in the current 17 educational environment, with or without supports, until the 18 student is able to successfully return to the student's current 19 education environment, with or without supports, including 20 the general education classroom. The bill provides that 21 the support provided by a therapeutic classroom is required 22 to include supporting student access to micronutrients and 23 vitamins, assessing the macro-nutritional needs of students, 24 providing minimally processed whole foods, restricting the 25 use and availability of certain artificial or synthetic food 26 additives, remediating the negative impacts of excessive use 27 of digital screens, increasing student exposure to natural 28 light or the light emitted by full spectrum lighting fixtures, 29 and carrying out any other scientifically supported initiative 30 that a school district reasonably believes will improve student 31 health. The bill appropriates \$75 million from the general 32 fund of the state to the therapeutic classroom incentive fund 33 for FY 2024-2025.
