A BILL FOR

- 1 An Act relating to child sexual abuse and child sexual assault
- 2 awareness and prevention.
- 3 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

      Section 1. Section 256.9, subsection 46, paragraph a, Code
 2 2024, is amended to read as follows:
         Develop and make available to school districts, examples
 4 of age-appropriate and research-based materials and lists
 5 of resources which parents may use to teach their children
 6 to recognize unwanted physical and verbal sexual advances,
 7 to not make unwanted physical and verbal sexual advances,
 8 to effectively reject unwanted sexual advances, that it is
 9 wrong to take advantage of or exploit another person, about
10 the dangers of sexual exploitation by means of the internet
11 including specific strategies to help students protect
12 themselves and their personally identifiable information
13 from such exploitation, and about counseling, medical, and
14 legal resources available to survivors of sexual abuse and
15 sexual assault, including resources for escaping violent
16 relationships. The materials and resources shall cover verbal,
17 physical, and visual sexual harassment, including nonconsensual
18 sexual advances, and nonconsensual physical sexual contact,
19 and child sexual abuse and child sexual assault awareness and
20 prevention. In developing the materials and resource list, the
21 director shall consult with entities that shall include but
22 not be limited to the departments of health and human services
23 and public safety, education stakeholders, and parent-teacher
24 organizations. School districts shall provide age-appropriate
25 and research-based materials and a list of available community
26 and internet-based resources to parents at registration and
27 shall also include the age-appropriate and research-based
28 materials and resource list in the student handbook.
29 districts are encouraged to work with their communities to
30 provide voluntary parent education sessions to provide parents
31 with the skills and appropriate strategies to teach their
32 children as described in this subsection.

- 2 Sec. 2. Section 256.146, Code 2024, is amended by adding the
- 3 following new subsection:
- 4 NEW SUBSECTION. 25. Adopt rules pursuant to chapter 17A
- 5 establishing continuing education requirements for renewal
- 6 of a license, certificate, authorization, or statement of
- 7 recognition. Continuing education activities may include
- 8 participating in or presenting at in-service training programs
- 9 related to child sexual abuse and child sexual assault
- 10 awareness and prevention.
- 11 Sec. 3. Section 279.50, subsections 1, 2, and 3, Code 2024,
- 12 are amended to read as follows:
- 13 1. Subject to section 279.80, each school board shall
- 14 provide instruction in kindergarten, and in prekindergarten
- 15 if the school board offers a prekindergarten program, which
- 16 gives attention to experiences relating to life skills and
- 17 human growth and development as required in section 256.11.
- 18 The human growth and development instruction shall include
- 19 instruction related to child sexual abuse and child sexual
- 20 assault awareness and prevention. School districts shall use
- 21 research provided in section 256.9, subsection 46, paragraph
- 22 "b", to evaluate and upgrade their instructional materials and
- 23 teaching strategies for human growth and development.
- 24 2. Subject to section 279.80, each school board shall
- 25 provide age-appropriate and research-based instruction in
- 26 human growth and development including instruction regarding
- 27 self-esteem, stress management, interpersonal relationships,
- 28 and domestic abuse in grades one through six. The human growth
- 29 and development instruction shall include instruction related
- 30 to child sexual abuse and child sexual assault awareness and
- 31 prevention.
- 32 3. Each school board shall provide age-appropriate and
- 33 research-based instruction in human growth and development
- 34 including instruction regarding human sexuality, self-esteem,
- 35 stress management, interpersonal relationships, domestic

- 1 abuse, and the prevention and control of disease, including
- 2 sexually transmitted diseases as required in section 256.11, in
- 3 grades seven through twelve. The human growth and development
- 4 instruction shall include instruction related to child sexual
- 5 abuse and child sexual assault awareness and prevention.
- 6 Sec. 4. STATE MANDATE FUNDING SPECIFIED. In accordance
- 7 with section 25B.2, subsection 3, the state cost of requiring
- 8 compliance with any state mandate included in this Act shall
- 9 be paid by a school district from state school foundation aid
- 10 received by the school district under section 257.16. This
- 11 specification of the payment of the state cost shall be deemed
- 12 to meet all of the state funding-related requirements of
- 13 section 25B.2, subsection 3, and no additional state funding
- 14 shall be necessary for the full implementation of this Act
- 15 by and enforcement of this Act against all affected school
- 16 districts.

17 EXPLANATION

- The inclusion of this explanation does not constitute agreement with the explanation's substance by the members of the general assembly.
- 20 This bill relates to child sexual abuse and child sexual
- 21 assault awareness and prevention.
- 22 Current law requires the director of the department of
- 23 education to develop and make available to school districts
- 24 examples of age-appropriate and research-based materials. The
- 25 bill provides that the age-appropriate and research-based
- 26 materials shall also cover child sexual abuse and child sexual
- 27 assault awareness and prevention.
- 28 The bill requires the board of educational examiners to
- 29 adopt rules that establish continuing education requirements
- 30 for renewal of a license, certificate, authorization, or
- 31 statement of recognition. The bill establishes that continuing
- 32 education activities may include participating in or presenting
- 33 at in-service training programs related to child sexual abuse
- 34 and child sexual assault awareness and prevention.
- 35 The bill requires school districts to provide

- 1 age-appropriate and research-based instruction related to child
- 2 sexual abuse and child sexual assault awareness and prevention
- 3 as part of its human growth and development instruction in
- 4 kindergarten through grade 12, and in prekindergarten if the
- 5 school district offers a prekindergarten program.
- 6 The bill may include a state mandate as defined in Code
- 7 section 25B.3. The bill requires that the state cost of
- 8 any state mandate included in the bill be paid by a school
- 9 district from state school foundation aid received by the
- 10 school district under Code section 257.16. The specification
- 11 is deemed to constitute state compliance with any state mandate
- 12 funding-related requirements of Code section 25B.2. The
- 13 inclusion of this specification is intended to reinstate the
- 14 requirement of political subdivisions to comply with any state
- 15 mandates included in the bill.
