A BILL FOR

- 1 An Act establishing a nursing education grant program and fund
- 2 to be administered by the college student aid commission and
- 3 making appropriations.
- 4 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

- 1 Section 1. <u>NEW SECTION</u>. **256.231 Nursing education grant** 2 program fund.
- 3 1. A nursing education grant program is established for the
- 4 purpose of providing grants to accredited private nonprofit
- 5 colleges and universities in this state to fund clinical
- 6 education for students in nursing education programs. Subject
- 7 to an appropriation of moneys for purposes of this section, the
- 8 college student aid commission shall administer the program.
- 9 2. The commission shall distribute moneys contained in the
- 10 nursing education grant fund created in subsection 3 as grants
- 11 to accredited private nonprofit colleges and universities in
- 12 this state for the establishment, expansion, or enhancement of
- 13 clinical education for students in nursing education programs.
- 14 Permitted uses of grant funds received through the program
- 15 shall include but are not limited to funding the cost of
- 16 personnel and equipment necessary to establish, expand, or
- 17 enhance such clinical education. The commission shall develop
- 18 a grant application; selection, evaluation, and award amount
- 19 criteria; and applicable procedures and timelines for the
- 20 program.
- 21 3. A nursing education grant fund is established in the
- 22 state treasury under the control of the commission. Moneys
- 23 credited to the fund are appropriated to the commission for
- 24 purposes of distributing grants under this section. The
- 25 commission may accept gifts, grants, bequests, and other
- 26 private contributions, as well as state or federal moneys, for
- 27 deposit in the fund. Moneys available in the fund for a fiscal
- 28 year shall be distributed as grants pursuant to this section.
- 29 Notwithstanding section 8.33, moneys in the fund at the close
- 30 of the fiscal year shall not revert but shall remain available
- 31 for expenditure for the purposes designated for subsequent
- 32 fiscal years.
- 33 4. The commission shall adopt rules pursuant to chapter 17A
- 34 to administer this section.

The inclusion of this explanation does not constitute agreement with the explanation's substance by the members of the general assembly. 2 3 This bill establishes a nursing education grant program for 4 the purpose of providing grants to accredited private nonprofit 5 colleges and universities in Iowa to fund clinical education 6 for students in nursing education programs. Subject to an 7 appropriation of moneys for this purpose, the college student 8 aid commission shall administer the program. The bill establishes a nursing education grant fund in the 10 state treasury under the control of the commission. 11 credited to the fund are appropriated to the commission for 12 purposes of distributing grants as provided in the bill. 13 The bill directs the commission to distribute moneys 14 contained in the fund as grants to accredited private nonprofit 15 colleges and universities in Iowa for the establishment, 16 expansion, or enhancement of clinical education for students 17 in nursing education programs. Permitted uses of grant funds 18 received through the program shall include but are not limited 19 to funding the cost of personnel and equipment necessary to 20 establish, expand, or enhance such clinical education. 21 bill directs the commission to develop a grant application; 22 selection, evaluation, and award amount criteria; and 23 applicable procedures and timelines for the program.
