A BILL FOR

- 1 An Act relating to national wild turkey federation special
- 2 registration plates, and making appropriations.
- 3 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

TLSB 5075YH (5) 90 th/ns 1 Section 1. Section 321.34, Code 2024, is amended by adding
2 the following new subsection:

3 <u>NEW SUBSECTION</u>. 11E. National wild turkey federation plates. 4 a. Upon application and payment of the proper fees, the 5 director may issue national wild turkey federation plates to 6 the owner of a motor vehicle subject to registration under 7 section 321.109, subsection 1, autocycle, motor truck, motor 8 home, multipurpose vehicle, motorcycle, trailer, or travel 9 trailer.

10 b. National wild turkey federation plates shall be designed 11 by the department in cooperation with the Iowa chapter of the 12 national wild turkey federation.

The special national wild turkey federation fee for 13 C. 14 letter-number designated national wild turkey federation plates 15 is twenty-five dollars. An applicant may obtain personalized 16 national wild turkey federation plates upon payment of the fee 17 for personalized plates as provided in subsection 5, which is 18 in addition to the special national wild turkey federation fee. đ. The fees collected by the director under this subsection 19 20 shall be paid monthly to the treasurer of state and deposited 21 in the road use tax fund. The treasurer of state shall 22 transfer monthly from the statutory allocations fund created 23 under section 321.145, subsection 2, to the general fund of the 24 state the amount of the special fees collected in the previous 25 month for national wild turkey federation plates. Such 26 moneys are appropriated to the department of natural resources 27 to distribute in the form of grants to support wild turkey 28 habitat conservation and hunting in Iowa. In the awarding of 29 grants, the department of natural resources shall give first 30 consideration to any state chapter of a nonprofit organization 31 supporting wild turkey habitat conservation and improvement, 32 and efforts to increase the number of hunters in this state, 33 and similar nonprofit organizations. Notwithstanding section 34 8.33, moneys appropriated under this subsection shall not 35 revert to the general fund of the state.

1 Upon receipt of the special registration plates, the е. 2 applicant shall surrender the current registration plates to 3 the county treasurer. The county treasurer shall validate 4 the special registration plates in the same manner as regular 5 registration plates are validated under this section. The 6 annual special national wild turkey federation fee for 7 letter-number designated plates is ten dollars which shall be 8 paid in addition to the regular annual registration fee. The 9 annual fee for personalized national wild turkey federation 10 plates is ten dollars which shall be paid in addition to the 11 annual special national wild turkey federation fee and the 12 regular annual registration fee. The annual special national 13 wild turkey federation fee shall be credited as provided under 14 paragraph d''.

15 f. The department shall not condition the issuance of 16 national wild turkey federation plates on the receipt of any 17 number of orders for national wild turkey federation plates. 18 EXPLANATION

19The inclusion of this explanation does not constitute agreement with20the explanation's substance by the members of the general assembly.

21 This bill authorizes the department of transportation (DOT) 22 to design and issue national wild turkey federation (NWTF) 23 special registration plates. The NWTF is a national nonprofit 24 organization dedicated to the conservation of the wild turkey 25 and the preservation of wild turkey hunters' hunting heritage. 26 The bill provides that the special NWTF fee for 27 letter-number designated NWTF plates is \$25. An applicant may 28 obtain personalized NWTF plates by paying an additional \$25 29 fee for personalized registration plates as provided in Code 30 section 321.34(5), which is in addition to the special NWTF 31 fee. The annual special NWTF fee for letter-number designated 32 plates is \$10, which is in addition to the regular annual 33 registration fee. Similarly, the annual fee for personalized 34 NWTF plates is \$10, which is in addition to both the annual 35 special NWTF fee and the regular annual registration fee.

1 The fees collected by the DOT must be paid monthly to the 2 treasurer of state and deposited in the road use tax fund. The 3 treasurer of state must transfer monthly from the statutory 4 allocations fund to the general fund of the state the amount 5 of the special fees collected in the previous month for the 6 NWTF plates. Such moneys are appropriated to the department of 7 natural resources (DNR) to distribute in the form of grants to 8 support wild turkey habitat conservation and hunting in Iowa. 9 In awarding the grants, DNR must give first consideration to 10 any state chapter of a nonprofit organization supporting wild 11 turkey habitat conservation and improvement, and efforts to 12 increase the number of hunters in Iowa, and similar nonprofit 13 organizations.

14 The bill prohibits the DOT from conditioning the issuance 15 of NWTF plates on the receipt of any number of orders for NWTF 16 plates.

Under current law, nonprofit organizations are authorized to apply to the DOT for approval to issue a decal of the organization's own design to be displayed on special registration plates with space reserved for an organizational decal. The nonprofit organization may charge a fee and retain any payment received for the organizational decal. Code section 321.34(13) sets forth the application process and certain limitations for nonprofit organizations and decal besigns.
