### A BILL FOR

- 1 An Act relating to ensuring the provision of accessible
- 2 prescription-related measures for persons who are
- 3 blind, have a visual impairment, or otherwise have print
- 4 disabilities.
- 5 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

- 1 Section 1. NEW SECTION. 155A.49 Accessible
- 2 prescription-related measures for persons who are blind,
- 3 visually impaired, or otherwise have print disabilities rules.
- 4 1. The board shall adopt rules pursuant to chapter 17A
- 5 to ensure that no later than October 31, 2024, a person who
- 6 is blind, has a visual impairment, or otherwise has a print
- 7 disability has appropriate access to prescription drug labels,
- 8 bag tags, and medical guides. The accessibility measures shall
- 9 meet all of the following requirements:
- 10 a. Be provided at no additional cost to such persons.
- 11 b. Provide information in a format that is fully accessible
- 12 to a person who is blind, has a visual impairment, or otherwise
- 13 has a print disability.
- 14 c. Provide information to a person who is blind, has a
- 15 visual impairment, or otherwise has a print disability within
- 16 a time frame comparable to the time frame within which the
- 17 information is provided to a person who is not blind, does not
- 18 have a visual impairment, or does not otherwise have a print
- 19 disability.
- 20 2. In adopting rules under this section, the board shall
- 21 solicit input from persons who are blind, have a visual
- 22 impairment, or otherwise have a print disability.
- 23 3. The rules adopted under this section shall meet all of
- 24 the following requirements:
- 25 a. Comply with the guidelines and recommendations in the
- 26 United States government accountability office report published
- 27 in December 2016, entitled "Prescription Drug Labels: Actions
- 28 Needed to Increase Awareness of Best Practices for Accessible
- 29 Labels for Individuals Who are Blind or Visually Impaired".
- 30 b. Include a method for providing notice to the public
- 31 that accessible prescription drug labels, bag tags, and
- 32 medical guides are available, including notice regarding the
- 33 availability of the prescription drug labels, bag tags, and
- 34 medical guides in audio format.
- 35 4. The board shall submit a report to the governor and the

1 general assembly by January 1, 2025, which includes information
2 regarding progress in the implementation of the rules,
3 recommendations regarding additional measures for improving
4 accessibility, and projected costs of implementing enhanced
5 dispensing fees to defray the costs of providing accessible
6 prescription drug labels, bag tags, and medical guides to
7 persons who are blind, have a visual impairment, or otherwise
8 have a print disability.

9 EXPLANATION

10 The inclusion of this explanation does not constitute agreement with
11 the explanation's substance by the members of the general assembly.

12 This bill requires the board of pharmacy to adopt

12 13 administrative rules no later than October 31, 2024, to 14 ensure that a person who is blind, has a visual impairment, 15 or otherwise has a print disability has appropriate access to 16 prescription drug labels, bag tags, and medical guides. 17 accessibility measures shall be provided at no additional cost 18 to such person, provide information in a format that is fully 19 accessible to a person who is blind, has a visual impairment, 20 or otherwise has a print disability, and provide information to 21 a person who is blind, has a visual impairment, or otherwise 22 has a print disability within a time frame comparable to the 23 time frame within which the information is provided to a 24 person who is not blind, does not have a visual impairment, or 25 otherwise does not have a print disability. 26 The board is required to solicit input in developing the

rules from persons who are blind, have a visual impairment,
or otherwise have a print disability. The rules shall comply
with the guidelines and recommendations in the United States
government accountability office report published in December
2016, entitled "Prescription Drug Labels: Actions Needed to
Increase Awareness of Best Practices for Accessible Labels for
Individuals Who are Blind or Visually Impaired", and shall
include a method for providing notice to the public that
accessible prescription drug labels, bag tags, and medical
