A BILL FOR

- 1 An Act creating a program and fund for court reporter
- 2 equipment, and making appropriations.
- 3 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

H.F. 2644

- 1 Section 1. <u>NEW SECTION</u>. **15.485** Court reporter equipment 2 incentive program.
- The authority shall establish and administer a court
- 4 reporter equipment incentive program. The court reporter
- 5 equipment incentive program shall consist of a student grant
- 6 program and a graduate forgivable loan program. Financial
- 7 assistance under the programs shall be provided from the court
- 8 reporter equipment incentive fund created in section 15.486.
- 9 2. A person enrolled in a court reporter course at a school
- 10 in Iowa that demonstrates financial need, as determined by the
- 11 authority by rule, is eligible to apply for a grant under the
- 12 student grant program to be used for the purchase of court
- 13 reporter equipment and software for the court reporter training
- 14 at the school.
- 15 3. a. A person is eligible to apply for a loan under the
- 16 graduate forgivable loan program if the person meets all of the
- 17 following requirements:
- 18 (1) The person is a newly licensed court reporter within one
- 19 year of graduation from a court reporter training program.
- 20 (2) The person is a resident of Iowa.
- 21 (3) The person agrees to work as a court reporter for five
- 22 years after the date of the loan.
- 23 b. After five years from the date of the loan, if eligible
- 24 under paragraph "a", the loan is forgiven. If the loan is
- 25 not forgiven, the authority shall establish a loan repayment
- 26 schedule for repayment of the loan within five years. A
- 27 loan not forgiven and defaulted on shall be referred to the
- 28 department of revenue for collections.
- c. A loan granted under this subsection shall be used to
- 30 purchase court reporter equipment and software.
- 31 4. Applicants to the court reporter equipment incentive
- 32 program who are doing court-related work shall receive priority
- 33 over applicants who are not.
- 34 5. Available moneys shall be divided equally among all
- 35 applicants during a fiscal year.

- 6. The authority shall adopt rules to administer this
 2 section.
- 3 Sec. 2. <u>NEW SECTION</u>. **15.486** Court reporter equipment 4 incentive fund.
- 5 l. A court reporter equipment incentive fund is created
- 6 in the state treasury under the control of the authority and
- 7 shall consist of moneys appropriated to the fund by the general
- 8 assembly and any other moneys available to and obtained or
- 9 accepted by the authority for placement in the fund.
- 10 2. The following accounts are created within the court
- 11 reporter equipment incentive fund:
- 12 a. A student grant account, which is appropriated to the
- 13 authority to support the student grant program created in
- 14 section 15.485.
- 15 b. A graduate forgivable loan account, which is appropriated
- 16 to the authority to support the graduate forgivable loan
- 17 program created in section 15.485.
- 18 3. Notwithstanding section 12C.7, subsection 2, interest or
- 19 earnings on moneys in the fund shall be credited to the fund.
- 20 Notwithstanding section 8.33, moneys in the fund that remain
- 21 unencumbered or unobligated at the close of a fiscal year shall
- 22 not revert but shall remain available for expenditure for the
- 23 purposes designated. For moneys deposited in the fund but not
- 24 to a particular account, the authority shall split available
- 25 moneys among the accounts based on need and to maximize the
- 26 impact of available moneys, as determined by the authority.
- 27 Sec. 3. APPROPRIATION COURT REPORTER EQUIPMENT
- 28 PROGRAM. There is appropriated from the general fund of the
- 29 state to the economic development authority for the fiscal year
- 30 beginning July 1, 2024, and ending June 30, 2025, the following
- 31 amount, or so much thereof as is necessary, to be used for the
- 32 purposes designated:
- For deposit in the court reporter equipment incentive fund
- 34 created in section 15.486, as enacted by this Act:
- 35 \$ 80,000

1	EXPLANATION
2	The inclusion of this explanation does not constitute agreement with
3	the explanation's substance by the members of the general assembly.
4	This bill creates a court reporter equipment incentive
5	program and associated fund under the control of the Iowa
6	economic development authority. The bill provides that the
7	court reporter equipment incentive program is comprised of two
8	programs, the student grant program and the graduate forgivable
9	loan program. A person is eligible to apply for a grant from
10	the student grant program to purchase court reporter equipment
11	and software if the person is enrolled in a court reporter
12	course at a school in Iowa and demonstrates financial need.
13	A person is eligible to apply for a loan under the graduate
14	forgivable loan program to purchase court reporter equipment
15	and software if the person is newly licensed within one year
16	of graduation from a court reporter program, is a resident of
17	Iowa, and agrees to work as a court reporter for five years
18	after the date of the loan. The bill provides repayment
19	requirements for the graduate forgivable loan program. The
20	bill provides that applicants to the court reporter equipment
21	incentive program who are doing court-related work shall
22	receive priority over applicants who are not.
23	The bill appropriates \$80,000 from the general fund for
24	FY 2024-2025 to the court reporter equipment incentive fund.
