A BILL FOR

- 1 An Act relating to requiring landowner approval for a
- 2 pipeline company submitting a request for the right to
- 3 exercise eminent domain and including effective date and
- 4 applicability provisions.
- 5 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

- 1 Section 1. Section 479B.16, subsection 1, Code 2023, is
- 2 amended to read as follows:
- A pipeline company granted a pipeline permit shall,
- 4 subject to subsection 4, be vested with the right of eminent
- 5 domain, to the extent necessary and as prescribed and approved
- 6 by the board, not exceeding seventy-five feet in width for
- 7 right-of-way and not exceeding one acre in any one location in
- 8 addition to right-of-way for the location of pumps, pressure
- 9 apparatus, or other stations or equipment necessary to
- 10 the proper operation of its pipeline. The board may grant
- 11 additional eminent domain rights where the pipeline company
- 12 has presented sufficient evidence to adequately demonstrate
- 13 that a greater area is required for the proper construction,
- 14 operation, and maintenance of the pipeline or for the location
- 15 of pumps, pressure apparatus, or other stations or equipment
- 16 necessary to the proper operation of its pipeline.
- 17 Sec. 2. Section 479B.16, Code 2023, is amended by adding the
- 18 following new subsection:
- 19 NEW SUBSECTION. 4. A pipeline company granted a pipeline
- 20 permit and seeking the right of eminent domain under this
- 21 chapter shall acquire consent from landowners owning ninety
- 22 percent or more of the real estate parcels which shall be
- 23 necessary for the project. The pipeline company shall submit
- 24 evidence of landowner approval to the board.
- 25 Sec. 3. EFFECTIVE DATE. This Act, being deemed of immediate
- 26 importance, takes effect upon enactment.
- 27 Sec. 4. APPLICABILITY. This Act applies to a pipeline
- 28 company that has yet to be granted a permit from the utilities
- 29 board on or after the effective date of the Act.
- 30 EXPLANATION
- 31 The inclusion of this explanation does not constitute agreement with
- 32 the explanation's substance by the members of the general assembly.
- 33 This bill relates to a pipeline company seeking eminent
- 34 domain rights for a pipeline construction project.
- 35 The bill requires a pipeline company seeking to use eminent

- 1 domain to acquire approval from landowners owning 90 percent
- 2 of the land which shall be necessary for the project. The
- 3 pipeline company shall submit evidence of landowner approval
- 4 to the utilities board within the utilities division of the
- 5 department of commerce.
- 6 The bill takes effect upon enactment. The bill applies to
- 7 pipeline companies without a permit from the board on or after
- 8 the effective date of the bill.
