A BILL FOR

- 1 An Act relating to the physical education and physical
- 2 activities requirements that apply to students enrolled in
- 3 school districts, accredited nonpublic schools, and charter
- 4 schools.
- 5 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

- 1 Section 1. Section 256.11, subsection 5, paragraph g, 2 subparagraphs (1) and (2), Code 2023, are amended to read as 3 follows:
- 4 (1) All students physically able shall be required to
 5 participate in physical education activities during each
 6 semester they are enrolled in school except as otherwise
 7 provided in this paragraph. A minimum of one-eighth unit each
 8 semester is required. A twelfth grade student who meets the
 9 requirements of this paragraph may shall be excused from the
 10 physical education requirement by the principal of the school
 11 in which the student is enrolled if the parent or guardian of
 12 the student requests in writing that the student be excused
 13 from the physical education requirement. A student who wishes
 14 to be excused from the physical education requirement must be
 15 seeking to be excused in order to enroll in academic courses
 16 not otherwise available to the student, or be enrolled or
- 18 (a) A work-based learning program or other educational 19 program authorized by the school which requires the student to 20 leave the school premises for specified periods of time during 21 the school day.

17 participating in one of the following:

- 22 (b) An organized and supervised athletic program which 23 requires at least as much participation per week as one-eighth 24 unit of physical education.
- 25 (c) Show choir, marching band, or color guard, if the
 26 student's participation per week in show choir, marching
 27 band, or color guard is at least equivalent to the per-week
 28 participation required for one-eighth unit of physical
 29 education.
- 30 (2) Students in grades nine through eleven may be excused
 31 from the physical education requirement in order to enroll in
 32 academic courses not otherwise available to the student if the
 33 board of directors of the school district in which the school
 34 is located, or the authorities in charge of the school, if the
 35 school is a nonpublic school, determine that students from

1 the school may be permitted to be excused from the physical
 2 education requirement. A student may shall be excused from
 3 the physical education requirement by the principal of the
 4 school in which the student is enrolled, in consultation with
 5 the student's counselor, for up to one semester, trimester,
 6 or the equivalent of a semester or trimester, per year if the
 7 parent or quardian of the student requests in writing that the
 8 student be excused from the physical education requirement.
 9 The student seeking to be excused from the physical education
10 requirement must, at some time during the period for which the
ll excuse is sought, be a participant in show choir, marching
12 band, color guard, or an organized and supervised athletic
13 program which requires at least as much time of participation
14 per week as one-eighth unit of physical education.
      Sec. 2. Section 256.11, subsection 6, paragraph b,
15
16 subparagraph (2), Code 2023, is amended to read as follows:
      (2) All physically able students in grades six through
17
18 twelve shall be required to engage in a physical activity
19 for a minimum of one hundred twenty minutes per week. A
20 student participating in an organized and supervised athletic
21 program, show choir, marching band, or color guard, or
22 non-school-sponsored extracurricular activity which requires
23 the student to participate in physical activity for a minimum
24 of one hundred twenty minutes per week is exempt from the
25 requirements of this subparagraph.

1 minimum of one-eighth unit of physical education activities
 2 during each semester they are enrolled in school. Current law
 3 provides that a student enrolled in grade 12 may be excused
 4 from this requirement by the school principal if the student's
 5 parent or guardian requests that the student be excused from
 6 the requirement to take part in certain specified activities.
 7 The bill modifies this provision to provide that a student
 8 enrolled in grade 12 shall be excused from this requirement
 9 by the school principal if the student's parent or guardian
10 requests that the student be excused from the requirement
11 to take part in the activities, and the bill adds to the
12 list of activities for which a student may be excused show
13 choir, marching band, and color quard. The bill requires
14 that the student's participation per week in show choir,
15 marching band, or color guard be at least equivalent to the
16 per-week participation required for one-eighth unit of physical
17 education.
      Current law provides that a student enrolled in grades 9
18
19 through 11 may be excused from the requirement related to
20 physical education activities by the principal of the school
21 in which the student is enrolled, in consultation with the
22 student's counselor, for up to one semester, trimester, or
23 the equivalent, per year if the board of directors or the
24 authorities in charge of the school determine that students
25 from the school may be permitted to be excused from the
26 physical education requirement and if the student's parent or
27 quardian requests in writing that the student be excused from
28 the physical education requirement. Current law requires that
29 the student seeking to be excused from the physical education
30 requirement must, at some time during the period for which
31 the excuse is sought, be a participant in an organized and
32 supervised athletic program which requires at least as much
33 time of participation per week as one-eighth unit of physical
34 education. The bill modifies this provision to provide that a
35 student enrolled in grades 9 through 11 shall be excused from

- 1 the requirement related to physical education activities by
- 2 the principal of the school in which the student is enrolled
- 3 for up to one semester, trimester, or the equivalent, per year
- 4 if the student's parent or guardian requests that the student
- 5 be excused from the physical education requirement, and the
- 6 bill adds to the list of activities for which a student may
- 7 be excused show choir, marching band, and color guard. The
- 8 bill requires that the student's participation per week in show
- 9 choir, marching band, or color guard be at least equivalent
- 10 to the per-week participation required for one-eighth unit of
- 11 physical education.
- 12 The bill exempts from the physical activity requirements
- 13 that apply to students enrolled in school districts, accredited
- 14 nonpublic schools, and charter schools in grades 6 through 12
- 15 students who are participating in show choir, marching band,
- 16 or color quard.
